Under Section 402 of the Not-For-Profit Corporation Law

THE UNDERSIGNED, being eighteen (18) years of age or over, for the purpose of forming a corporation pursuant to Section 402 of the Not-For-Profit Corporation Law of New York, does hereby certify:

FIRST: The name of the corporation is: Multi-Craft Apprenticeship Preparation Program, Inc.

**SECOND:** The corporation is a corporation as defined in subparagraph (a)(5) of Section 102 of the Not-For-Profit Corporation Law.

**THIRD:** The corporation is organized, and at all times shall be operated, exclusively to provide meaningful opportunities and resources to disadvantaged individuals, whether by virtue of race, ethnicity, religion, gender, economics, disability, or otherwise, to promote and enhance the employability of such individuals in construction-related and other fields, and to receive and administer funds to facilitate and financially support the aforementioned endeavors.

**FOURTH**: The corporation shall be a charitable corporation under Section 201 of the Not-For-Profit Corporation Law.

**FIFTH:** The following provisions are inserted for the regulation and conduct of the affairs of the corporation:

The corporation shall have and exercise any and all powers, rights and privileges which a corporation organized under the Not-For-Profit Corporation Law of the State of New York may now or hereafter have or exercise by law; provided, however, that:

- (A) No part of the net earnings of the corporation shall inure to the benefit of any non-charitable member, trustee, director or officer of the corporation, or any private individual (except that reasonable compensation may be paid for services rendered to or for the corporation), and no non-charitable member, trustee, director or officer of the corporation or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the corporation.
- (B) No part of the activities of the corporation shall consist of carrying on propaganda or otherwise attempting to influence

legislation; nor shall it in any manner participate or intervene (including the publication or distribution of statements) in any political campaign on behalf of any candidate for public office; nor shall it engage in any transaction defined as "prohibited" under Section 503 of the Code.

- (C) In the event of the termination, dissolution, or winding up of the corporation, its remaining assets, if any, shall be distributed only to one or more organizations described in Section 501(c)(3) of the Code. None of the income, property or assets of the corporation shall ever be distributed to or divided among any non-charitable member, officer, director, trustee, creator, organizer of or contributor to the corporation, nor ever be used for or inure to the benefit of any private individual within the meaning of Section 501(c)(3) of the Code.
- (D) Notwithstanding any other provision of this Certificate of Incorporation, if at any time the corporation is a private foundation within the meaning of Section 509 of the Code, then, during such time or times:
  - (1) The corporation shall distribute its income for each taxable year at such time and in such manner as not to subject the corporation tax under Section 4942 of the Code;
  - (2) The corporation shall not engage in any act of self-dealing, as defined in Section 4941(d) of the Code;
  - (3) The corporation shall not retain any excess business holdings, as defined in Section 4943(c) of the Code;
  - (4) The corporation shall not make any investments in such a manner as to subject the corporation to tax under Section 4944 of the Code; and
  - (5) The corporation shall not make any taxable expenditure as defined in Section 4945(d) of the Code.

**SIXTH:** The management of the affairs of the corporation shall be vested in the board of board of directors, except as otherwise provided in this Certificate of Incorporation or in the by-laws of the corporation.

**SEVENTH:** The office of the corporation is to be located in Monroe County, New York.
