I recommend that Your Honorable Body authorize a settlement in the amount of \$90,000 in an action brought against the County of Monroe, the Monroe County Sheriff's Department, Monroe County Sheriff Patrick O'Flynn, Monroe County Deputy Sheriff Jason Surowy and Monroe County Deputy Sheriff J. Cave by Yuri Shyshko, Nataliya Shyshko, Taras Shyshko, Vladimir Shyshko and Andrew Sundberg.

The Shyshko-Sundberg lawsuit arises out of the use of force against and/or arrest of plaintiffs following an incident on December 10, 2005.

#### The specific legislative actions required are:

- 1. Authorize the settlement of the Shyshko-Sundberg lawsuit for \$90,000.
- 2. Authorize the County Executive, or her designee, to execute and deliver any and all documents necessary to effectuate such settlement.

Funding for the payment of the settlement is available in the Risk Management Fund. No additional net County support is required in the current Monroe County budget.
