Subject: Authorize a Contract with the University of Rochester Medical Center to Provide Interim Commissioner of Public Health Services

Honorable Legislators:

I recommend that Your Honorable Body authorize a contract with the University of Rochester Medical Center, in a total amount not to exceed \$92,000, to provide Interim Commissioner of Public Health services, for the period of April 18, 2016 through December 31, 2016.

Monroe County is a county health district which requires the head of our Department of Public Health be a commissioner. The University of Rochester will provide the services of Dr. Michael Mendoza to serve as the County's Interim Commissioner of Public Health. Dr. Mendoza is a multi-state, board-certified physician in family medicine and the current medical director at Highland Family Medicine. Dr. Mendoza has over a decade of service in family medicine and a master's degree in public health.

The specific legislative action required is to authorize the County Executive, or her designee, to execute a contract, and any amendments thereto, with the University of Rochester Medical Center, to provide Interim Commissioner of Public Health services, in a total amount not to exceed \$92,000, for the period of April 18, 2016 through December 31, 2016.

Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.

Funding for this contract is included in the 2016 operating budget of the Department of Public Health, fund 9001, funds center 5801010000, Public Health Commissioner. No additional net County support is required in the current Monroe County budget.

**AUTHORIZING CONTRACT WITH UNIVERSITY OF ROCHESTER MEDICAL CENTER
