the Monroe County Public Safety Communications Sites Project

Honorable Legislators:

I recommend that Your Honorable Body authorize a contract with CHA Consulting, Inc., in the amount of \$224,870, for professional design services, for the Monroe County Public Safety Communications Sites Project.

The design services are required prior to construction of the four (4) public safety communications system site additions, which are being added to increase coverage for Monroe County's 700/800 MHz trunked radio system.

Several consultants were considered to provide professional design services, with CHA Consulting, Inc. rated the most qualified for the project. CHA Consulting, Inc. proposes to provide basic design and special services in the amount of \$224,870. These initial services are for the planning phase of the project. A cost breakdown of these services is as follows:

Basic Design Services	\$174,350
Special Services	\$ 50,520
Total	\$224,870

The specific legislative action required is to authorize the County Executive, or her designee, to execute a contract with CHA Consulting, Inc., 16 West Main Street, Suite 830, Rochester, New York 14614, for professional design services, for the Monroe County Public Safety Communications Sites Project, in the amount of \$224,870, and any amendments necessary to complete the project within the total capital fund(s) appropriation.

Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.

Funding for this contract, consistent with authorized uses, is included in capital fund 1892 and in any other capital fund(s) created for the same intended purpose. No additional net County support is required in the current Monroe County budget.

The records in the Office of the Monroe County Treasury have indicated that neither CHA Consulting, Inc., nor any of its principal officers, owes any delinquent Monroe County Property taxes. The principal officers of the firm are:
