Re: Memorializing State and Federal Leaders to Continue the Prioritization of Opioid Abuse Prevention in 2018

Honorable Legislators:

The battle against opioid abuse is becoming increasingly more critical as this epidemic continues to grow in our community and around the nation. Local, state and national leaders have already made it clear that combatting this problem is of the utmost importance. Monroe County has taken a firm position on trying to alleviate widespread addiction and the impact that it has. While efforts have already been made, it is important that our New York State leaders and Federal leaders continue to prioritize the prevention of opioid abuse.

Opioid abuse is a problem that does not discriminate and impacts many families and households in our communities. According to the United States Department of Health and Human Services, health care professionals dispense more than 650,000 prescriptions and 3,900 people initiate nonmedical use of prescription opioids for the first time per year. It is important that healthcare practitioners are counseling patients who are receiving these drugs on the possible side effects and potency of the opioids they are being prescribed, as addiction can begin as a dependence on painkillers such as Oxycodone, OxyContin and Percocet.

The effects of opioid abuse are seen in many parts of county government. Public safety, probation, public health and mental health are all impacted by the opioid crisis that is being experienced. Government leaders should continue to lend support and seek ways to continue to combat the abuse of opioids in our communities in order to make eliminating this epidemic a priority.

Therefore we urge you to join us in calling on State and Federal leaders to continue to prioritize opioid abuse prevention with regards to public safety, public health and mental health. Monroe County Executive Cheryl Dinolfo and Dr. Michael Mendoza have been leaders in Monroe County taking on the opioid epidemic. In early January, County Executive Dinolfo joined the nationwide lawsuit against pharmaceutical companies that make, market, and distribute opioid prescription drugs. Monroe County will continue to support efforts that strive towards ending the opioid epidemic.



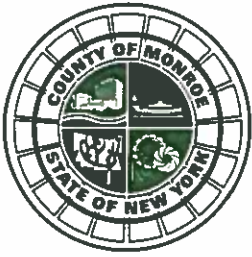

Re: Memorializing the New York State Assembly and Senate To Pass, And Governor Andrew Cuomo To Sign, An Act to Establish a For the Inspiration and Recognition of Science and Technology (FIRST) Grant Program

Honorable Legislators:

When students show interest in the fields of science and technology, it is the responsibility of parents, teachers, and community leaders to provide them with a variety of hands-on opportunities to explore that interest. Continued success in the fields of science, technology, engineering, and math depends on the ability of schools to help students discover what career opportunities exist within these fields. For the Inspiration and Recognition of Science and Technology (FIRST) is an organization that encourages students to be leaders in the fields of science, technology, and engineering. By providing mentor-based programs that build skills in science and technology, FIRST helps students develop self-confidence, communication skills, and leadership.

FIRST holds a variety of robotics competitions throughout the country, and several robotics teams from Monroe County have had outstanding success in these competitions. Ranger Robotics of Spencerport Central School District has almost 200 participants throughout the district and has had wide success at various competitions, championships, and regional championships. In six weeks, teams must build and program robots that can play difficult field games against competitors. Professional mentors volunteer their time and talents by guiding these students through competitions. However, it can cost as much as \$30,000 dollars for an individual school to develop and offer a FIRST program to their students due to registration, travel, material, and other costs. Schools without available funds have missed out on this opportunity to involve their students in a program that teaches invaluable skills in science, technology, and leadership.

New York State Assembly Bill A5736 and Senate Bill S3875 create a grant program for public and private schools in New York State who wish to create a team to participate in FIRST Robotics Competitions. Schools may be awarded \$5,000 to help with costs associated with registering, attending, and participating in robotics competitions. The program also gives preference to schools that have not previously participated in FIRST Robotics Competitions or

schools that would be receiving a grant through this program for the first time. This legislation will make a total of \$250,000 available for schools. The Churchville Chili Senior High School robotics team, known as Team 340, has been supporting this bill for six years. Although this team is operated out of Churchville Chili Senior High School, students from around Monroe County participate in FIRST Robotics Competitions with Team 340. This bill would give financial support to teams like Team 340 who seek to expand their involvement in FIRST Robotics Competitions. In addition, it would help schools in Monroe County and around New York State, who are currently unable to offer this program due to budget constraints, to begin a FIRST Robotics program.

Therefore, we urge you to join us in calling on the New York State Legislature to pass, and Governor Andrew Cuomo to sign, Senate Bill S3875 and Assembly Bill A5736, which create a For the Inspiration and Recognition of Science and Technology Grant Program.

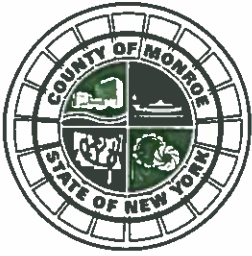

**Re: Memorializing Governor Andrew Cuomo to Increase State Library
Funding in Proportion with Overall Education Funding**

Honorable Legislators:

Public libraries have provided opportunities for enrichment and creativity, where all people are guaranteed access to the lifelong education they need to fully participate in our information economy. Libraries must continue to meet the needs of our population who may not have access to the most up-to-date technologies that will help them be productive members of our community.

Governor Andrew Cuomo's 2018-2019 New York State Budget proposes a 4% cut in library aid, while aid to education is increasing 3%. If New York State is unable to provide funding to support library systems, the services they offer will stagnate and communities that need additional support will experience a gap in the technology they can provide. The Monroe County Library System offers services that members of our community heavily rely on, including homework help, curriculum guides for teachers, children's libraries, book discussion groups, health and wellness programs for seniors, career exploration assistance, test preparation, and more that contribute to the education of all citizens.

New York State Libraries are a model of shared services. According to the State Education Department, each dollar spent for New York State library systems returns \$7 for local library systems. Continued cuts threaten the system of collaboration that is currently in place. These cuts do not just affect the services our libraries offer. State funding also helps support basic improvements needed to keep the building accessible, safe, and open. Many libraries also require expansions for additional meeting spaces and accommodations for new technologies.

Governor Cuomo is making our library systems vulnerable to stagnation in a country where access to information has become increasingly important. A 2017 Siena Research Institute poll found that 92% of New Yorkers say the public library is an important part of their local education system and more than 60% of respondents have used their local public library in the last six months. Libraries are an integral part of ensuring fair access

to education. Funding for libraries should increase in proportion with education funding to encourage lifelong learning.

Therefore, we urge you to join us in calling on Governor Andrew Cuomo to fund libraries in proportion to education funding in the 2018-2019 New York State Budget.

Re: Memorializing New York State Government to Establish and Invest \$50 Million in a Market-Ready Site Program to Encourage Business Activity in New York State

Honorable Legislators:

New York State and Monroe County must remain competitive in an environment where developers are seeking sites for large-scale, job creating projects. To encourage businesses to locate here in New York and Monroe County, we must make locations attractive to companies who are seeking to minimize the time between beginning construction and opening their doors.

In the past, New York has developed a “Shovel-Ready” Program. If an empty site is certified as “shovel-ready,” it indicates that all planning, zoning, surveys, title work, environmental studies, and public infrastructure engineering have been completed before the site was put on the market for sale. This greatly reduces the amount of time it takes a company to begin construction, provide jobs to the community, and begin production.

“Market-Ready” programs are becoming more popular around the country, and have higher standards for certification than shovel-ready sites. In order to become certified as a “market-ready” site in the State of Georgia, the site must complete requirements including site acreage, secured property, zoning, railroad accessibility, road accessibility, utilities, wetlands and stream delineation, topographic survey, geotechnical investigations, environmental phase I assessment, and cultural resources and endangered species investigations. When reports and engineering work are completed in advance, the “time to market” for a company is greatly reduced. The time to market begins when property is acquired and ends when the store is open for customers. By offering the owners of construction sites the opportunity to get their sites certified as market-ready, communities can increase the odds of a retail company setting up a location in their area.

Georgia’s Market-Ready Program, called the Georgia Ready for Accelerated Development Sites Program (GRAD), has certified over 60 different sites around the State, and 18 companies have chosen to build new locations on these sites. New York must continue to stay competitive in a fast-paced business environment where companies are looking to minimize their costs, and members of our community can find employment in the shortest time possible.

Therefore, I urge you to join me in calling on New York State to invest \$50 million in a Market-Ready Site Program, to encourage businesses to locate in New York State.

Re: Memorializing the New York State Legislature and Governor Andrew M. Cuomo to Increase State Investment in Locally Owned Roads, Bridges and Culverts through CHIPS

Honorable Legislators:

State funding through the Consolidated Local Streets and Highway Improvement Program (CHIPS), as well as BRIDGE NY, PAVE NY and Extreme Winter Recovery, is vital in order to meet the enduring demands of our local roads, bridges, and culverts. While this supplementary funding is being put to good use, it still does not cover the majority of the total cost.

In New York State, a substantial amount of infrastructure is under local jurisdiction. Locally owned bridges and roads account for 50% of the State's 18,000 bridges and 87% of the State's 110,000 miles of roadways. Locally-owned transportation systems are essential for the mobility of our residents and the State relies on local municipalities to keep these roads, bridges, and culverts functional and safe.

As reported by NYS Comptroller Thomas P. DiNapoli, 20.7% of bridges in NYS are functionally obsolete and 12.8% are structurally deficient. Despite the many efforts by localities to focus on preventive maintenance of their roads and bridges, the need for rehabilitation and reconstruction is inevitable as these infrastructure systems age over time and their conditions naturally worsen. It is approximated to cost a total of \$27.4 billion to repair all of these bridges with the majority of those reported as structurally deficient being locally-owned. This places a massive burden on local municipalities who are expected to shoulder a sizable amount of the cost. Albeit the many pleas by local officials to increase state funding, Governor Cuomo continues to underfund essential local infrastructure projects.

Investment in our locally-owned infrastructure is necessary to maintain the quality of life that our residents have come to expect in Monroe County. Therefore, I urge you to join me in calling on the members of the New York State Legislature and Governor Andrew M. Cuomo to increase infrastructure investments to counties and local municipalities.

Re: Memorializing New York State to Invest in Provider Capacity to Ensure Appropriate and Meaningful Services and Diversion Programs are Available and to Develop a Comprehensive Transition and Waiver Process as Counties Begin Implementing Raise the Age

Honorable Legislators:

In 2017, New York State enacted legislation to raise the age of criminal responsibility in New York, effective October 1, 2018 for 16 year old offenders. In order to ensure that this program is successful, New York State must invest in programs and services that will be beneficial to rehabilitation. The structural changes involved in raising the age of criminal responsibility will require a significant investment in services based on a children and families social services model. There also must be a recalibration of the treatment of impacted young people and their families in court, juvenile justice and education systems.

New York State must also be able to have the facilities to house young offenders as the transition implementing Raise the Age begins. Counties are diligently working with New York State on construction plans, but the draft regulations do not provide for streamlining of state procurement laws. These draft regulations include provisions that will likely increase the length of time necessary to build facilities and make them fully operational by requiring state certification and approval of requests for proposals. Counties will not have a proper amount of time to budget for implementation of Raise the Age, therefore they are concerned about having the ability to satisfy all state law procurement requirements while meeting the implementation deadlines of the new law.

Counties are required to have secured or build new specialized secure detention facility beds by the October 1, 2018 effective date. Given the fast approaching deadlines for Raise the Age, New York State should consider implementing a waiver process during the early years of transition. This would be especially important in regard to finding the most appropriate

placement options for youth and families in need of services, as well as for cases where placement in new detention facilities are required, but may yet be fully operational. These waivers should be guaranteed for counties until reliable historical data is available to help counties develop accurate budget projections.

Therefore, I urge you to join me in calling on New York State to invest in provider capacity to ensure appropriate and meaningful services are available to children and their families and to develop a comprehensive transition and waiver process as counties being implementing Raise the Age. Ensuring that adequate services and facilities are available for children and families will help this transition be successful. New York State must take responsibility in making sure that deadlines of the new goal are able to be met and that they have adequate capacity to provide the type and quantity of services to affected youth and their families in their local communities.

Subject: Approve a Public Employees Blanket Bond for the Genesee/Finger Lakes Regional Planning Council

Honorable Legislators:

I recommend that Your Honorable Body approve the Public Employees Blanket Bond as the official undertaking of the Genesee/Finger Lakes Regional Planning Council (G/FLRPC).

Monroe County has appropriated the sum of \$29,989 as its share of the 2018 operating funds of the G/FLRPC. In a concurrently submitted referral I am requesting authorization to make the annual contribution. Pursuant to Section 119-00 of the General Municipal Law of the State of New York, Monroe County is authorized to provide for the payment of such appropriations to an officer of the agency designated by the agency to receive such monies provided that such officer shall have executed an official undertaking approved by the County Legislature. The G/FLRPC has designated David S. Zorn, Executive Director of the Council, as the officer to receive payments of such monies. G/FLRPC has secured a Public Employees Blanket Bond, issued by National Grange Mutual Insurance Company, providing faithful performance blanket bond coverage for officers and employees of the G/FLRPC in the amount of \$500,000 (copy attached). Monroe County must approve such blanket bond as the official undertaking of G/FLRPC.

The specific legislative action required is to approve the Public Employees Blanket Bond for the Genesee/Finger Lakes Regional Planning Council required pursuant to Section 119-00 of the General Municipal Law of the State of New York.

Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.

This Public Employees Blanket Bond will have no impact on the revenues or expenditures of the current Monroe County budget.

I recommend that this matter be referred to the appropriate committee(s) for favorable action by Your Honorable Body.

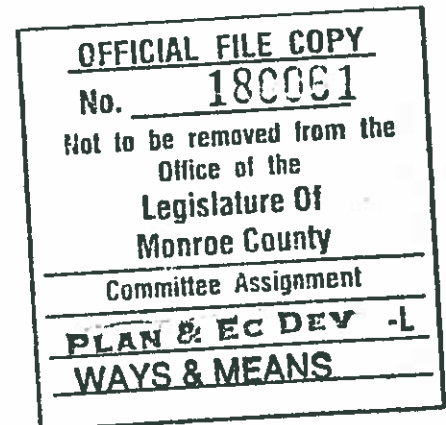

Honorable Legislators:

I recommend that Your Honorable Body authorize Monroe County's 2018 annual contribution to the Genesee/Finger Lakes Regional Planning Council (G/FLRPC) in the amount of \$29,989. This annual contribution is Monroe County's share of the G/FLRPC's operating budget and is based on a formula in the Operating Agreement, which specifies the contribution of each of the nine member counties according to population.

The member counties of the G/FLRPC agree each year on an operating budget for the G/FLRPC. The budget is funded from the county contributions and supplemented with grants for such activities as water resources planning, demographic analysis, economic development coordination, and other special projects. This is the forty-seventh year the County has contributed to G/FLRPC. This year's contribution is the same amount as last year.



Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.

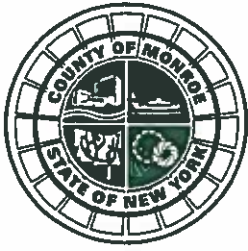

Subject: Acceptance of a Grant from the Genesee Transportation Council for a Land Use Project

Honorable Legislators:

I recommend that Your Honorable Body accept a grant from the Genesee Transportation Council, in the amount of \$15,000, for a Land Use Project, for the period of April 1, 2018 through March 31, 2019.

The purpose of this grant is to enable the County to prepare a report on changes in land use in Monroe County and projections of future land use. The information will be used by the Genesee Transportation Council to prepare updated estimates and projections of highway traffic using a computer model. This information will also be of use to the Department of Planning and Development in assessing changes and trends in land use during the year and reviewing County activities relating to land use and economic development. This is the twenty-sixth consecutive year the County has received this grant. This year's funding represents the same amount as last year.

The specific legislative actions required are:

1. Authorize the County Executive, or her designee, to accept a \$15,000 grant from, and to execute a contract and any amendments thereto with, the Genesee Transportation Council, for a Land Use Project, for the period of April 1, 2018 through March 31, 2019.
2. Authorize the County Executive to appropriate any subsequent years of the grant award in accordance with the grant terms, to reappropriate any unencumbered balances during the grant period according to the grantor requirements, and to make any necessary funding modifications within the grant guidelines to meet contractual commitments.

3. Should funding for this program be modified or terminated for any reason, the County Executive is hereby authorized to terminate or modify the program and where applicable, to terminate or abolish some or all positions funded under such program. Any termination or abolishment of positions shall be in accordance with New York State Civil Service Law, and when applicable, the terms of any labor agreement affecting such positions.


Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.

Funding for this grant is included in the 2018 operating budget of the Department of Planning and Development, general fund 9001, funds center 1401010000, Planning Services.

This project is 90% funded by the Genesee Transportation Council with an in-kind match of 10% support from staff of the Department of Planning and Development. No additional net County support is required in the current Monroe County budget.

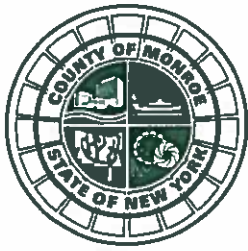

Subject: Acceptance of a Grant from the United States Department of Justice, Office of Justice Programs, for the FY2017 Forensic DNA Laboratory Efficiency Improvement and Capacity Enhancement Program

Honorable Legislators:

I recommend that Your Honorable Body accept a grant from the United States Department of Justice, Office of Justice Programs, in the amount of \$396,930, for the FY2017 Forensic DNA Laboratory Efficiency Improvement and Capacity Enhancement Program, for the period of January 1, 2018 through December 31, 2019.

The purpose of the FY2017 Forensic DNA Laboratory Efficiency Improvement and Capacity Enhancement Program is to increase the capabilities of the Monroe County Crime Laboratory DNA analysis section by providing supplies for casework, contracts for continuing education in human identification science and related travel, the purchase of two (2) new instruments, and funds to cover registration fees, on-line training, text books and software. This Program allows the Laboratory to provide more timely services to the region's law enforcement community and judicial system. This is the first year that the County has received this grant.

The specific legislative actions required are:

1. Authorize the County Executive, or her designee, to accept a \$396,930 grant from, and to execute a contract and any amendments thereto with, the United States Department of Justice, Office of Justice Programs, for the FY2017 Forensic DNA Laboratory Efficiency Improvement and Capacity Enhancement Program, for the period of January 1, 2018 through December 31, 2019.
2. Amend the 2018 operating budget of the Department of Public Safety by appropriating the sum of \$396,930 into general fund 9300, funds center 2408040100, Monroe County Crime Laboratory.


3. Authorize the County Executive to appropriate any subsequent years of the grant award in accordance with the grant terms, to reappropriate any unencumbered balances during the grant period according to the grantor requirements, and to make any necessary funding modifications within grant guidelines to meet contractual commitments.
4. Honorable Legislators:

I recommend that Your Honorable Body accept a grant from the Dormitory Authority State of New York for the State and Municipal Facilities Program, in the amount of \$250,000, for reimbursement of the renovation of three (3) existing restrooms at Ontario Beach Park.

This funding was made possible through the efforts of Senator Joseph E. Robach. This project will include the renovation of three (3) existing restrooms at Ontario Beach Park. Completion of the project will improve the existing park restroom facilities substantially and increase the number of drinking fountains available in the park. The restrooms chosen to be renovated were based on the most need as follows:

- The 50 Beach Avenue restrooms (closest to the playground area) require the most substantial upgrades and will include but is not limited to new: exhaust, heating, plumbing fixtures, flooring, tile walls, paint, baby changing stations, toilets, urinals, sinks and hand dryers and the addition of a drinking fountain. The ADA partitions in both restrooms will also be replaced.
- The River/Pier restrooms will include the following upgrades: sinks, toilets, urinals, baby changing stations, drinking fountain and new exterior doors.
- The Swimmers restrooms (end of Robach Center) upgrades will include new sinks, baby changing stations, toilets and urinals.

Honorable Legislators:

I recommend that Your Honorable Body accept a grant from the Dormitory Authority State of New York for the State and Municipal Facilities Program, in the amount of \$55,000, for the renovation of the Colby-Pulver House at Northampton Park.

This funding was made possible through the efforts of Senator Robert G. Ort. The Colby-Pulver House is located in Northampton Park and is used as a historical museum under an agreement with the Ogden Historical Society. The renovation upgrades that will be completed are: the installation of nine (9) new windows, rewiring the electric in the basement, saw cutting the basement floor for drainage, clapboard replacement in the front of the home on the lower portion of the house, replacement of the front wood decking entry, replacement of the existing toilet with a handicap toilet, installation of a new counter top, faucet and existing sink, installation of a holding tank, preparation of an engineering survey for the barn. The improvements will be completed through Term Services Contracts with Parks Department staff managing the project.

I recommend that Your Honorable Body, in accordance with Section 18 of the Monroe County Tax Act, authorize the County Treasurer to publish in The Daily Record the list of lands with unpaid taxes and to charge a fee of up to \$7.00 per parcel to cover the cost of the publications, which will be added to the unpaid amounts due for such parcel. In addition, I will direct the Department of Communications to post the list of lands with unpaid taxes on the County's website (www.monroecounty.gov), and notice thereof will be provided to the local media.

To comply with the provisions of Section 18, a list of lands charged with unpaid taxes must be published and printed annually. Such publication should take place on August 15, 2018, together with a notice that each tax sale certificate will be sold on August 20, 2018 in the County Treasury. In addition to the publication of the list of lands, a notice of said publication calling the attention of the public and all persons interested that a list of lands charged with unpaid taxes will be available and the notice shall be published in The Rochester Business Journal for four (4) consecutive weeks and in The Daily Record for thirty (30) days prior to August 1.

The specific legislative action required is to direct the County Treasurer to publish in The Daily Record the list of lands charged with unpaid taxes, and the notice of publication of the list in both The Daily Record and The Rochester Business Journal, and to authorize the charge of up to \$7.00 per parcel for such publications.

Honorable Legislators:

I recommend that Your Honorable Body authorize a contract with the New York State Department of Transportation (NYSDOT) for access to the Monroe County 700/800 MHz trunked radio system ("System") for the Highway Emergency Local Patrol (HELP) Program, for the period April 1, 2018 through March 31, 2019, with the option to renew for four (4) additional one-year terms.

The NYSDOT will purchase up to ten (10) radios to be used on the System by operators of the HELP program. The County will initially program the radios for activation and charge a service fee of \$9.25 per device, per month, with the option to re-evaluate rates in the renewal agreements. Radio repair and maintenance will be the responsibility of the NYSDOT.

Participating in the System will allow for a more rapid response to crash scenes or disabled vehicle incidents by providing local law enforcement with direct access to request assistance from a HELP driver; thus, increasing the safety of first responders, drivers, passengers and other motorists.


The specific legislative action required is to authorize the County Executive, or her designee, to execute a contract, and any amendments thereto, with the New York State Department of Transportation for access to Monroe County's 700/800 MHz trunked radio system for the Highway Emergency Local Patrol Program, for the period of April 1, 2018 through March 31, 2019, with the option to renew for four (4) additional one-year terms.
