Re: Memorializing the New York State Legislature and Governor Andrew M. Cuomo to Increase the First-Responder State Income Tax Credit (Section 606 of NYS Tax Law)

Honorable Legislators:

Throughout the State of New York, volunteers are the lifeblood of our first-response to crisis. Of the State's 1,795 municipal fire departments, 89% are volunteer. These volunteers provide the backbone to municipal emergency medical services and fire-stations. According to reports, it is estimated that volunteer fire departments save the state approximately \$9.3 billion.

In 2007, the State Legislature and the Governor enacted a volunteer firefighters' and ambulance workers' credit (Section 606 of the NYS Tax Law). This action gave active volunteer firefighters and ambulance workers to a credit against their state income tax equal to \$200. While implementing this tax credit has been helpful, this amount has remained unchanged since the enactment of the legislation in 2007.

Over the last decade, New York State has experienced several volunteer ambulance departments closing, transferring their certificates of operation to a for-profit provider or merge with other volunteer ambulance departments. Monroe County's first-response operations rely heavily upon volunteerism and such closings would be detrimental to taxpayers. Recruitment and retention of volunteer first-responders is crucial to avoiding continued closings and transfer to for-profit providers.

Instead of earning wages or serving their community elsewhere, volunteer emergency personal choose to serve their communities with dedication and vigor despite the dangers they face each and every day. Oftentimes, these critical emergency personnel often pay for their own travel costs to and from a firehouse and ambulance stations, as well as to emergency scenes. The volunteer firefighters' and ambulance workers' credit must be increased to \$500 annually in order to effectively recruit and retain our local volunteer first-responders.

Volunteer firefighters and ambulance workers give selflessly every day for the safety of their communities while saving taxpayers billions of dollars. The volunteer firefighters' and ambulance workers' income tax credit both honors these local heroes and encourages them to stay involved in their volunteer departments. The recruitment and retention of men and women willing to act in these positons as volunteers is essential to ensuring public safety in a fiscally responsible manner. Therefore, I urge to join me in calling upon the New York State Legislature and Governor Andrew M. Cuomo to increase the volunteer firefighters' and ambulance workers' income tax credit (Section 606 of NYS Tax Law) to at least \$500 annually.

Amend Resolution 410 of 2017 to Amend and Increase the Contract with the Legal Aid Society of Rochester, New York for the Improving Criminal Justice Responses Grant Program also known as the Arrest Program

Honorable Legislators:

I recommend that Your Honorable Body amend Resolution 410 of 2017 to amend and increase the contract with the Legal Aid Society of Rochester, New York, from an amount not to exceed \$270,865 to an amount not to exceed \$274,465, for legal representation of domestic violence victims for the Improving Criminal Justice Responses Grant Program, for the period of October 1, 2017 through September 30, 2020.

This contract is part of a collaboration of partnerships between criminal justice agencies, victim service providers, and community organizations which respond to domestic violence, sexual assault, dating violence and stalking in Monroe County. The increase is due to grant requirements for new individuals working on the program to attend an annual conference.

The contract with the Legal Aid Society funds: 1) a part-time Domestic Violence Consortium Assistant to provide administrative support; and 2) a civil attorney to provide legal representation to victims seeking orders of protection, and for immigrant and limited English proficient victims seeking services.

A request for qualifications was issued with the Legal Aid Society of Rochester, New York rated the most qualified to provide these services.

The specific legislative action required is to amend Resolution 410 of 2017 to amend and increase the contract with the Legal Aid Society of Rochester, New York, One West Main Street, Suite 800, Rochester, New York 14614, for legal representation of domestic violence victims for the Improving Criminal Justice Responses Grant Program, from an amount not to exceed \$270,865 to an amount not to exceed \$274,465, for the period of October 1, 2017 through September 30, 2020.

Authorize an Intermunicipal Agreement with the Rochester City School District and a Contract with the Center for Youth Services Inc. for Services Related to the Raise the Age Legislation

Honorable Legislators:

I recommend that Your Honorable Body authorize an intermunicipal agreement with the Rochester City School District, in an amount not to exceed \$64,084, for an Administrative Specialist/Educational Liaison for Raise the Age youth, and a contract with the Center for Youth Services Inc., in the amount of \$150,000, to administer the Rochester Teen Court diversion program, for the period of January 1, 2019 through March 31, 2020.

Per Resolution 263 of 2019, Your Honorable Body accepted a grant from the New York State Division of Criminal Justice Services for the Raise the Age Legislation. The Rochester City School District will provide an Administrative Specialist/Educational Liaison who will work on behalf of detained/sentenced Raise the Age youth who may be/are released to facilitate re-entry into school or other educational programming. The Center for Youth Services Inc. will administer the Rochester Teen Court diversion program for nonviolent offenders.

It has been determined that both the Rochester City School District and the Center for Youth Services Inc. are sole source providers for these services.

The specific legislative actions required are:

- 1. Authorize the County Executive, or his designee, to execute an intermunicpal agreement, and any amendments thereto, with the Rochester City School District, 131 West Broad Street, Rochester, New York 14614, for an Administrative Specialist/Educational Liaison for Raise the Age youth, in the amount of \$64,084, for the period of January 1, 2019 through March 31, 2020.
- 2. Authorize the County Executive, or his designee, to execute a contract, and any amendments thereto, with the Center for Youth Services Inc., 905 Monroe Avenue, Rochester, New York 14620, to administer the Rochester Teen Court diversion program, in the amount of \$150,000 for the period of January 1, 2019 through March 31, 2020.

Honorable Legislators:

This matter is being referred to Your Honorable Body at the request of District Attorney Sandra Doorley and Sheriff Todd Baxter.

I recommend that Your Honorable Body authorize Federal Equitable Sharing Agreements with the United States Department of Justice and the United States Department of the Treasury, for participation by the Monroe County District Attorney's Office and the Monroe County Sheriff's Office in the federal equitable sharing programs for federally forfeited cash, property and proceeds obtained in the course of joint law enforcement investigations and prosecutions, for the period of January 1, 2020 through December 31, 2020.

In an effort to further encourage cooperation among federal, state and local law enforcement agencies and to punish and deter criminal activity by depriving criminals of property used or acquired through illegal activities, the United States Congress provided the Secretary of the Treasury and the United States Attorney General with the authority to share federally forfeited cash, property and proceeds with participating federal, state and local law enforcement agencies. The shared funds, property and proceeds must be used for law enforcement purposes. This will be the 29th year the County has participated in this program.

The specific legislative action required is to authorize the Coun y Executive, or his designee, to execute Federal Equitable Sharing Agreements with the United States Department of Justice and the United States Department of the Treasury, for participation in federal equitable sharing programs for federally forfeited cash, property and proceeds obtained in the course of joint law enforcement investigations and prosecutions, for the period of January 1, 2020 through December 31, 2020.

This is a Type II Action pursuant to 6 NYCRR 617.5(c) and is not subject to review under the State Environmental Quality Review Act.

These agreements are revenue generating and no net County support is required in the current Monroe County budget.

Acceptance of a Grant from the Transportation Security Administration for the Continuation of a Partnership with the Monroe County Sheriff's Office and the National Explosive Detection Canine Team Program

Honorable Legislators:

This matter is being referred to Your Honorable Body at the request of Sheriff Todd K. Baxter.

I recommend that Your Honorable Body accept a grant from the Transportation Security Administration (TSA) in the amount of \$150,500, for the continuation of a partnership with the Monroe County Sheriff's Office and the National Explosive Detection Canine Team Program (NEDCTP), for the period of January 1, 2020 through December 31, 2020.

The TSA NEDCTP provides partial funding for the deployment of three (3) certified TSA Nitrate Canine Road Patrol Deputies to the Greater Rochester International Airport. The Sheriff's Office will also be responsible for promptly responding to threats at support facilities, rail stations, airports, passenger terminal, seaports and surface carriers. Funds will be used to help support the handlers' salaries, fringe, overtime, uniforms, canine expenses, kenneling, equipment, gas and training for the three K-9 Deputies and their assigned canine partners. This is the twelfth year of the program, contract and grant. This years' funding represents a decrease of \$1,000 from last year.

The specific legislative actions required are:

1. Authorize the County Executive, or his designee, to accept a \$150,500 grant from and to execute a contract and any amendments thereto, with the Transportation Security Administration for the continuation of a partnership with the Monroe County Sheriff's Office and The National Explosive Detection Canine Team Program, for the period of January, 1, 2020 through December 31, 2020.

- 2. Amend the 2020 operating budget of the Office of the Sheriff by appropriating the sum of \$150,500 into general fund 9300, funds center 3803140000, Police Bureau Airport Security.
- 3. Authorize the County Executive to appropriate any subsequent years of the grant award in accordance with the grant terms, to reappropriate any unencumbered balances during the grant period according to the grantor requirements, and to make any necessary funding modifications within the grant guidelines to meet contractual commitments.
- 4. Should funding of this program be modified or terminated for any reason, the County Executive is hereby authorized to terminate or modify the program and, where applicable, to terminate or abolish some or all positions funded under such program. Any termination or abolishment of positions shall be in accordance with New York State Civil Service Law and, when applicable, the terms of any labor agreement affecting such positions.

This action is a Type II Action pursuant to 6 NYCRR § 617.5(c) and is not subject to review under the State Environmental Quality Review Act.

This grant will help offset costs for the TSA Canine Road Patrol Deputies and their assigned canine partners. No additional net County support is required in the current Monroe County budget.

Honorable Legislators:

I recommend that Your Honorable Body accept a grant from the Dormitory Authority of the State of New York, in the total amount of \$233,000, amend the 2020-2025 Capital Improvement Program and the 2020 Capital Budget to add a project entitled "Lake Ontario Resiliency & Economic Development Initiative (REDI) – Sutter's Marina Project" in the amount of \$233,000; and authorize financing for the project in the amount of \$233,000.

This project involves modifications to the county-owned, privately-operated Sutter's Marina including elevation of the permanent structure close to the waters' edge and installation of shoreline stabilization measures at the waters' edge. This resiliency project is intended to protect the infrastructure as the marina is susceptible to flooding with lake level rising. Work will include design and construction of modifications with the work to be overseen by the New York State Department of State.

Major funding for the grant to Monroe County will be provided by the Dormitory Authority of the State of New York in the amount of 95%, and the remaining 5% is a required local match by Monroe County. The total cost of this project is estimated at \$233,000.

This project is scheduled to be considered by the Monroe County Planning Board on March 26, 2020.

The specific legislative actions required are:

Authorize the County Executive, or his designee, to accept a grant in the total amount of \$233,000 from, and to execute a contract, and any amendments thereto, with the Dormitory Authority of the State of New York, for the Lake Ontario Resiliency & Economic Development Initiative (REDI) Sutter's Marina Project.

I recommend that Your Honorable Body amend Bond Resolution 334 of 2019 to amend the project title and description of the project from "Renovation and Expansion of Building 4 at Monroe Community College" to "Expand Visual and Performing Arts at both the Brighton and Downtown Campuses and Renovate Building 4."

Building 4 at MCC's Brighton Campus currently houses many visual and performing arts programs used by the college and the local community. Several visual and performing arts programs are anticipated to be moved from the Brighton Campus to the new Downtown Campus. Once these programs are relocated out of Building 4, the building will be renovated to provide new and enlarged facilities to support other visual and performing arts programs and to address the deficiencies and any modifications detailed in the Facilities Condition Assessment Report. The intent of the 2020-2025 Capital Improvement Program (CIP) is that funding for design and construction of the project would apply to both the Brighton and Downtown campuses.

The current Bond Resolution 334 of 2019 limits the project to the "Renovation and Expansion of Building 4 at Monroe Community College." This project's original anticipated scope of work also includes work at the Downtown Campus. Therefore, it is necessary to revise the description of the project authorization in the bond resolution to properly reflect the elements in the 2020-2025 CIP by including the Downtown Campus as well as Building 4 at the Brighton Campus.

This project was approved by the Monroe County Planning Board on March 21, 2019.

The specific legislative action required is to amend Bond Resolution 334 of 2019 to amend the project title and description of the project from "Renovation and Expansion of Building 4 at Monroe Community College" to "Expand Visual and Performing Arts at both the Brighton and Downtown Campuses and Renovate Building 4."

This action is a Type II Action pursuant to 6 NYCRR § 617.5(c) and is not subject to review under the State Environmental Quality Review Act.

Funding for this project, consistent with authorized uses, is included in capital fund 1970, and any capital fund(s) created for the same intended purpose. No additional net County support is required in the current Monroe County budget.

I recommend that Your Honorable Body authorize a contract with Stantec Consulting Services Inc., in the amount of \$143,064.82, for engineering services, for the Aldrich Road Culvert over White Brook Tributary in the Town of Perinton.

The Aldrich Road Culvert is County owned and spans the White Brook Tributary, in the Town of Perinton. The project involves the rehabilitation or replacement of the culvert along with highway approach and channel improvements. The current total project estimate is \$565,000.

Several consultants were considered, with Stantec Consulting Services Inc. rated the most qualified for this project. Stantec Consulting Services Inc. proposes to provide the services in the amount of \$143,064.82.

Honorable Legislators:

I recommend that Your Honorable Body authorize the issuance of refunding bonds in a total amount not to exceed \$40 million, with the proceeds to be used to pay the remaining debt service costs, or portions thereof, associated with a public improvement bond issue.

The outstanding bond to be refunded in whole or in part is: Public Improvement Bonds - 2010

The bond issue is callable June 1, 2020 and conditions in the bond market offer the potential for significant savings to taxpayers if the County refinances all or a portion of the outstanding balance of the bond issue by issuing refunding bonds. This would have the effect of reducing the interest cost of the original bond issue since the refunding bonds would incur a lower interest cost and therefore result in lower future debt service.

While the exact amount of savings cannot be determined until the interest rates for the refunding bonds are set, it is anticipated that the present value savings will be in excess of \$3.4 million, or greater than 10% of the refunded principal, over the remaining life of the bond issue.

The specific legislative action required is to authorize the issuance of refunding bonds in a total amount not to exceed \$40 million. The proceeds will be used to pay the remaining debt service cost, or portions thereof, associated with Public Improvement Bond -2010.

LOCAL LAW NO. __ OF 2020

ENACTING LOCAL LAW ENTITLED "AMERICAN SIGN LANGUAGE INTERPRETERS AT ALL MONROE COUNTY GOVERNMENT PRESS CONFERENCES HELD DURING EMERGENCY SITUATIONS"

BE IT ENACTED BY THE LEGISLATURE OF THE COUNTY OF MONROE, as follows:

Section 1. Legislative Intent. Monroe County is home to one of the largest per-capita populations of individuals who are deaf or hard of hearing. This population is especially vulnerable to the dangers and hardships associated with natural disasters and other public emergencies. According to the National Association for the Deaf, it has been well documented that this population frequently experiences the most difficulty preparing for and recovering from emergencies and disasters.

Among the many difficulties faced by the deaf and hard of hearing during times of emergency is the inability to receive potentially life-saving information from government agencies responsible for emergency management. Research by the National Council on Disability has found that access to emergency services for deaf and hard of hearing individuals is in need of significant improvement. Because local jurisdictions such as Monroe County are primarily responsible for responding to emergencies and natural disasters, it is our responsibility to lead the way in initially making such improvements. Accordingly, this Legislature determines that the County should initiate steps through its Department of Public Safety to ensure adequate emergency communication with individuals who are deaf and hard of hearing through the provision of American Sign Language interpreters at all press conferences held during emergency situations including natural and manmade disasters.

Section 2. Definitions. The following terms used in this local law shall have the meanings indicated:

- 1. "Director" shall mean the Director of Public Safety.
- 2. "Emergency situation" shall mean disaster, rioting, catastrophe, severe weather, flooding, or similar event whether or not a state of emergency has been officially declared, including a "Public Disaster," as defined in Section 21-2 of the Monroe County Administrative Code and a "Disaster," as defined in Section 20(2) of the New York State Executive Law.

- 3. "Press conference" shall mean a meeting, organized by a County official, employee, or other representative of the County with one or more journalists and other representatives of the media, for the purposes of officially distributing information to the media and answering questions.
- 4. "Emergency situation press conference" shall mean a press conference relating to or involving an emergency situation.
- 5. "Qualified and certified American Sign Language Interpreter" shall mean an interpreter fluent in American Sign Language and meeting the requirements set forth in Section 390 of the Judiciary Law.

Section 3. Sign Language Interpreters at Emergency Situation Press Conferences.

- 1. It shall be the responsibility of the Director to ensure that qualified and certified American Sign Language Interpreters are available to provide sign language interpretation services at all emergency situation press conferences. Such sign language interpreters shall be present and shall provide such services at each emergency situation press conference held by any officer, official, employee or agent of the County. To the maximum extent possible, the Director shall ensure that the sign language interpreter shall be so physically positioned that his or her face, body, arms, and hands are visible in the video transmission of the press conference at all times.
- 2. The Director shall establish protocols for securing the services of qualified and certified American Sign Language interpreters at all emergency situation press conferences.

Section 4. Severability. If any clause, sentence, paragraph, subdivision, section, or part of this law or the application thereof to any person, individual, corporation, firm, partnership, entity, or circumstance shall be adjudged by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, section or part of this law, or in its application to the person, individual, corporation, firm, partnership, entity, or circumstance directly involved in the controversy in which such order or judgment shall be rendered.

Section 5. Effective Date. This local law shall take effect in accordance with the provisions of the Municipal Home Rule Law and the Monroe County Charter.
