

**ADDENDUM TO REQUEST FOR PROPOSAL
FOR OPERATION OF FOOD AND BEVERAGE KIOSK
AT THE GREATER ROCHESTER INTERNATIONAL AIRPORT**

2.3 Concession Premises

- A. The offered concession space is an existing 10' by 15' foot kiosk located in the center of the Food Court behind the Security Checkpoint consisting of approximately one hundred fifty (150) square feet. A secure backroom to be used for food refrigeration and storage, which along with the kiosk shall collectively be known as, the premises.

The location of the existing space is shown in Exhibit A as are the locations of the existing concessions.

- B. A second offered concession space is an existing kiosk currently located on the second floor of the main terminal west in the pre-security Observatory Lounge. This kiosk will be re-located in the terminal across from the ticket counters pre-security as shown on Exhibit C attached hereto. The kiosk consists of approximately three hundred twenty (320) square feet. A secure backroom to be used for food refrigeration and storage, which along with the kiosk shall collectively be known as, the premises.


