TITLE: Supervising Nutritionist (*Provisional Appointment)

SALARY: \$40,858 - \$52,451 annually

LOCATION: Monroe County Department of Public Health

JOB SUMMARY:

This is a professional position responsible for program planning and staff supervision of a public education program at the Monroe County Public Health Department for the purpose of promoting good nutrition among socio-economically disadvantaged women, their infants and children. The employee reports directly to and works under the general supervision of an administrative-level staff member. General supervision is exercised over a staff of Nutritionists and clerical personnel. Does related work as required.

MINIMUM QUALIFICATIONS:

Graduation from a regionally accredited or New York State registered college or university with a Bachelor's degree in Nutrition or Dietetics or related field, plus EITHER:

- (A) Four (4) years paid full time or its part time equivalent experience in community health or nutrition in the areas of counseling, education, or field program planning and development; OR,
- (B) Graduation from a regionally accredited or New York State registered college or university with a Master's degree in Dietetics or Nutrition or a related field plus three (3) years of experience as defined in (A); OR,
- (C) Any equivalent combination of training and experience as defined in (A) and (B) above.

NOTE: Possession of current certification as a Registered Dietitian issued by the American Dietetic Association may substitute for one (1) year of the required experience.

SPECIAL REQUIREMENTS:

Depending on position duties, candidates for employment with Monroe County Government will be required to pass a pre-employment drug test and physical. Applicants may be required to undergo a state and national criminal history background investigation, which will include a fingerprint check, to determine suitability for appointment. Failure to meet the standards for the background investigation may result in disqualification.

RESIDENCY REQUIREMENT:

Applicant must be a resident of Monroe County at the time of appointment and for at least four (4) months at the time of examination.
