TITLE: Pure Waters Technician (*Provisional Appointment)

SALARY: \$26,891 - \$34,563 Annually

LOCATION: Monroe County Department of Environmental Services

JOB SUMMARY: This is an entry-level position in the Department of Environmental Services, Division of Pure Waters. Depending on the incumbent's interests and abilities, assignments may be made in any unit within Pure Waters including Administration, Laboratory, Field Operations, Pump Stations, and/or a Wastewater Treatment Plant. Duties performed may involve manual labor, assisting in report preparation, inputting data into a computer, laboratory testing, sampling or other duties related to the unit assigned. The employee reports directly to, and works under the general direction of, a higher-level staff member.

MINIMUM QUALIFICATIONS:

- (A) Graduation from a regionally accredited or New York State recognized college or university with an Associates Degree or sixty (60) college semester credit hours in a natural science, engineering science, civil engineering technology, mechanical engineering technology, chemical technology, instrumentation technology, environmental science or a closely related field; OR
- (B) Three (3) years of paid full-time or its part-time equivalent experience in the operation of wastewater collection, conveyance, or treatment facilities including assistance in gathering of operations-related data; OR
- (C) Any equivalent combination of training and experience as defined by the limits of (A) and (B) above.

SPECIAL REQUIREMENTS:

If you are appointed, you will be required to have a valid Class D license to operate a motor vehicle in New York State. Candidates for employment will be required to pass a pre-employment drug test.

Applicants may be required to undergo a State and national criminal history background investigation, which will include a fingerprint check, to determine suitability for appointment. Failure to meet the standards for the background investigation may result in disqualification.

RESIDENCY REQUIREMENT:

Applicant must be a resident of Monroe County at the time of appointment and for at least four (4) months at the time of examination.
