These fees cover Grantee expenses for obtaining the necessary approvals/resolutions and Customs Concurrence Letters, preparation and processing of the Operations Agreements, and any necessary support required in the approval and activation process, oversight and submission of the Annual Report to the Foreign Trade Zones Board. The fees do not include actual preparation of the Application.
