NOTICE OF HEARING BEFORE MONROE COUNTY LEGISLATURE

PLEASE TAKE NOTICE, that a public hearing will be held by the County Legislature of the County of Monroe on April 12, 2022, at 6:15p.m. in the County Legislative Chambers in the County Office Building, 39 West Main Street, Rochester, New York, for the purpose of hearing public comments on **APPROVING THE SUBMISSION OF A GRANT APPLICATION TO; AND AUTHORIZING THE ACCEPTANCE OF GRANT FUNDING FROM, THE NEW YORK STATE OFFICE OF COMMUNITY RENEWAL FOR THE COMMUNITY DEVELOPMENT BLOCK GRANT – CARES ACT FOR THE PREPARING, PREVENTING, AND RESPONDING TO THE CORONAVIRUS.**" Copies of this proposed resolution are available for examination in the office of the Clerk of the County Legislature.

Approval of this submission by New York State Office of Community Renewal will provide the County with funding in the amount of \$4,645,000 for a small business loan and grant program and to support a program to provide legal representation to those facing eviction.

All parties of interest and citizens will be heard at the Public Hearing. The hearing is being conducted pursuant to Section 570.486, Subpart I of the CFR and in compliance with the requirements of the Housing and Community Development Act of 1974, as amended.

Monroe County will hold a public hearing on April 12, 2022 at 6:15 P.M. at 39 West Main Street, County Office Building, Legislative Chambers Room 410, Rochester, for the purpose of hearing public comments on Monroe County's Community Development needs, and to discuss the possible submission of one Community Development Block Grant (CDBG) CARES Act (CV) application for the 2022 program year. The CDBG-CV program is administered by the New York State Office of Community Renewal (OCR), and will make available to eligible local governments approximately \$4,645,000 housing, and economic development, with the principal purpose of benefitting low/moderate income persons. Monroe County is applying for \$4,645,000 in CDBG-CV funds for the prevention, preparing for, and response to the COVID-19 pandemic, to provide economic development grant/loan to small businesses and support a program for legal representation for those at risk of eviction. The hearing will provide further information about the CDBG-CV program and will allow for citizen participation in the development of any proposed grant applications and/or to provide technical assistance to develop alternate proposals. Comments on the CDBG-CV program or proposed project(s) will be received at this time.

The location of the hearing is accessible to persons with disabilities. If special accommodations are needed for persons with disabilities, those with hearing impairments, or those in need of translation
