The local funding for this project will ultimately be provided by the Monroe County Airport Authority from Airport generated revenues.
Section 4. This resolution shall take effect in accordance with Section C2-7 of the Monroe County Charter.

## Honorable Legislators:

I recommend that Your Honorable Body amend the 2020-2025 Capital Improvement Program and the 2020 Capital Budget to add a project entitled "Runway Guard Lights for Runway 10-28" in the amount of \$700,000; authorize financing for the project in the amount of \$700,000; and authorize a contract with CHA Consulting, Inc., in the amount of \$240,000, for design services, for the Runway Guard Lights for Runway 10-28 project at the Greater Rochester International Airport.

The Federal Aviation Administration required Runway Safety Action Team meets annually to recommend safety improvements on the airfield to minimize runway incursions. At their 2019 meeting, the team recommended the runway guard lights for Runway 10-28. The runway guard lights flash 24 hours a day, seven days a week to enhance pilot awareness of the runway hold lines. The Airport presently has runway guard lights on all connector taxiways to Runway 4-22.

This project will be funded by a Federal Aviation Administration grant of 90%, a New York State Department of Transportation grant of 5%, and a local share of 5%.

The Department of Aviation recommends authorization of a contract with GHA Consulting, Inc., a designated airport consultant per Resolution 455 of 2017, to provide design services for the Runway Guard Lights for Runway 10-28 project in the amount of \$240,000.

This project is scheduled to be considered by the Monroe County Planning Board on February 27, 2020.

## The specific legislative actions required are:

- 1. Amend the 2020-2025 Capital Improvement Program to add a project entitled "Runway Guard Lights for Runway 10-28" at the Greater Rochester International Airport, in the amount of \$700,000.
- 2. Amend the 2020 Capital Budget to add a project entitled "Runway Guard Lights for Runway 10-28" at the Greater Rochester International Airport, in the amount of \$700,000.

- 4. Authorize the County Executive, or his designee, to execute a contract with CHA Consulting, Inc., 16 Main Street West, Suite 830, Rochester, New York 14614, for design services, for the Runway Guard Lights for Runway 10-28 project at the Greater Rochester International Airport, in the amount of \$240,000, and any amendments necessary to complete the project within the total capital fund(s) appropriation.

This action is a Type II Action pursuant to 6 NYCRR § 617.5(c) and is not subject to review under the State Environmental Quality Review Act.

Funding for this project, consistent with authorized uses, will be included in the capital fund to be created and any other capital fund(s) created for the same intended purpose. The local funding for this project will ultimately be provided by the Monroe County Airport Authority from Airport generated revenues. No net County support is required in the current Monroe County budget.
