**AUTHORIZING INTERMUNICIPAL AGREEMENT WITH CITY OF ROCHESTER POLICE  
DEPARTMENT FOR TRAFFIC CONTROL SERVICES AT FRONTIER FIELD**

BE IT RESOLVED BY THE LEGISLATURE OF THE COUNTY OF MONROE, as follows:

Section 1. The County Executive, or his designee, is hereby authorized to execute an intermunicipal agreement, and any amendments thereto, with the City of Rochester Police Department, to provide traffic control services for regular and post-season games at Frontier Field during the 2020 baseball season at a rate of \$79 per hour for each Police Officer, in an amount not to exceed \$94,000, for the period of April 1, 2020 through September 25, 2020.

Section 2. Funding for this agreement is included in the 2020 operating budget of the Department of Finance-Unallocated, general fund 9001, funds center 1209060600, Frontier Field.

Section 3. This resolution shall take effect in accordance with Section C2-7 of the Monroe County Charter.

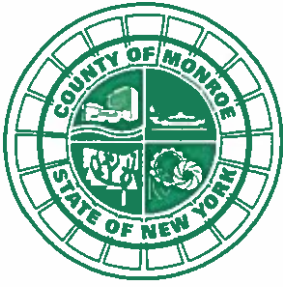

Subject: Authorize an Intermunicipal Agreement with the City of Rochester Police Department for Traffic Control Services at Frontier Field

Honorable Legislators:

I recommend that Your Honorable Body authorize an intermunicipal agreement with the City of Rochester Police Department to provide traffic control services for regular and post-season Red Wings baseball games at Frontier Field during the 2020 season at the rate of \$79 per hour for each Police Officer, in an amount not to exceed \$94,000, for the period of April 1, 2020 through September 25, 2020.

**The specific legislative action required** is to authorize the County Executive, or his designee, to execute an intermunicipal agreement, and any amendments thereto, with the City of Rochester Police Department, to provide traffic control services for regular and post-season games at Frontier Field during the 2020 baseball season at a rate of \$79 per hour for each Police Officer, in an amount not to exceed \$94,000, for the period of April 1, 2020 through September 25, 2020.

This referral is a Type II Action pursuant to 6 NYCRR 617.5(c) and is not subject to review under the State Environmental Review Act.

Funding for this agreement is included in the 2020 operating budget of the Department of Finance-Unallocated, general fund 9001, funds center 1209060600, Frontier Field. No additional net County support is required in the current Monroe County budget.
