## Honorable Legislators:

I recommend that Your Honorable Body accept a grant from Health Research, Inc., in the amount of \$402,370, for the Coronavirus (COVID-19) Program, for the period of March 5, 2020 through March 15, 2021; and authorize the acceptance of up to an additional \$500,000 in restricted New York State Department of Health emergency placeholder funding that may be included in this grant.

The purpose of this grant is to assist local health departments with emergency funding for COVID-19 response activities. Program objectives are: incident management for early crisis response; jurisdictional recovery; information management; countermeasures and mitigation; surge management; and biosurveillance. This is the first year the County will receive this grant. Up to an additional \$500,000 in restricted New York State Department of Health emergency placeholder funding may be included in this grant, which could be made available quickly if deemed necessary.
