**ACCEPTING GRANT FROM UNITED STATES TREASURY FOR CORONAVIRUS AID,  
RELIEF, AND ECONOMIC SECURITY ACT**

BE IT RESOLVED BY THE LEGISLATURE OF THE COUNTY OF MONROE, as follows:

Section 1. The County Executive, or his designee, is hereby authorized to accept a \$129,433,144.90 grant from, and to execute a contract and any amendments thereto with, the United States Treasury, for the Coronavirus Aid, Relief, and Economic Security Act, for payment of expenses needed to combat the Coronavirus pandemic, for the period of March 1, 2020 through December 30, 2020.

Section 2. The 2020 operating budget of the Department of Finance is hereby amended by appropriating the sum of \$129,433,144.90 into general fund 9001, funds center 1209070100, State of Emergency.

Section 3. The County Executive is hereby authorized to appropriate any subsequent years of the grant award in accordance with the grant terms, to reappropriate any unencumbered balances during the grant period according to the grantor requirements, and to make any necessary funding modifications within the grant guidelines to meet contractual commitments.

Section 4. Should funding of this program be modified or terminated for any reason, the County Executive is hereby authorized to terminate or modify the program and, where applicable, to terminate or abolish some or all positions funded under such program. Any termination or abolishment of positions shall be in accordance with New York State Civil Service Law and, when applicable, the terms of any labor agreement affecting such positions.

Section 5. This resolution shall take effect in accordance with Section C2-7 of the Monroe County Charter.

Subject: Acceptance of a Grant from the United States Treasury for the Coronavirus Aid, Relief, and Economic Security Act

Honorable Legislators:

I recommend that Your Honorable Body accept a grant from the United States Treasury, in the amount of \$129,433,144.90, for the Coronavirus Aid, Relief, and Economic Security (CARES) Act, for payment of expenses needed to help combat the Coronavirus pandemic.

The CARES Act included direct aid payments to local governments with populations that exceed 500,000. The grant may be used by Monroe County for any expense which is a necessary expenditure incurred due to the public health emergency, was not accounted for in the 2020 County budget, and was incurred during the period March 1, 2020 through December 30, 2020.

**The specific legislative action required is to:**


1. Authorize the County Executive, or his designee, to accept a \$129,433,144.90 grant from, and to execute a contract and any amendments thereto with, the United States Treasury, for the Coronavirus Aid, Relief, and Economic Security Act, for payment of expenses needed to combat the Coronavirus pandemic, for the period March 1, 2020 through December 30, 2020.
2. Amend the 2020 operating budget of the Department of Finance by appropriating the sum of \$129,433,144.90 into general fund 9001, funds center 1209070100, State of Emergency.
3. Authorize the County Executive to appropriate any subsequent years of the grant award in accordance with the grant terms, to reappropriate any unencumbered balances during the grant period according to the grantor requirements, and to make any necessary funding modifications within the grant guidelines to meet contractual commitments.

4. Should funding of this program be modified or terminated for any reason, the County Executive is hereby authorized to terminate or modify the program and where applicable, to terminate or abolish some or all positions funded under such program. Any termination or abolishment of positions shall be in accordance with New York State Civil Service Law, and when applicable, the terms of any labor agreement affecting such positions.

This action is a Type II Action pursuant to 6 NYCRR § 617.5(c) and is not subject to review under the State Environmental Quality Review Act.

This grant is 100% funded by the United States Treasury. No net County support is required in the Monroe County budget.
