Subject: Acceptance of a Gift from Lightspec, LLC/Lightspec Canada, Inc. of Personal Protective Equipment

Honorable Legislators:

I recommend that Your Honorable Body authorize the acceptance of a gift from Mr. Steve Danzig, President of Lightspec, LLC/Lightspec Canada, Inc. of Personal Protective Equipment ("PPE") at an approximate retail value of \$266,524.

The donated PPE consists of non-surgical masks, sanitizing wipes, and sanitizer to be dispersed free-of-charge to the community as part of Monroe County's COVID-19 response.

**The specific legislative action required** is to authorize the County Executive, or his designee, to accept a gift from Mr. Steve Danzig, President of Lightspec, LLC/Lightspec Canada, Inc. of Personal Protective Equipment at an approximate retail value of \$266,524 to be dispersed free-of-charge to the community as part of Monroe County's COVID-19 response.

This action is a Type II Action pursuant to 6 NYCRR § 617.5(c)(31) ("purchase or sale of furnishings, equipment or supplies, including surplus government property, other than the following: land, radioactive material, pesticides, herbicides, or other hazardous materials") and is not subject to review under the State Environmental Quality Review Act.

This gift will have no impact on the revenues or expenditures of the current Monroe County budget.

I recommend that this matter be referred to the appropriate committee(s) for favorable action by Your Honorable Body.
