Subject: Mortgage Tax Distribution

Honorable Legislators:

I recommend that Your Honorable Body approve the Mortgage Tax Distribution for the period April 1, 2023 through September 30, 2023.

The Monroe County Clerk's Office has reported that, for the period April 1, 2023 through September 30, 2023, Mortgage Tax collections totaled \$8,002,164.52. Pursuant to Section 261 of the New York State Tax Law, Mortgage Tax collections are to be distributed to the City of Rochester and the Towns and Villages of Monroe County, on or before the fifteenth day of December.

**The specific legislative action required is to approve the attached proposed resolution for the distribution of \$8,002,164.52 in Mortgage Tax collections for the period of April 1, 2023 through September 30, 2023, to the City of Rochester and the Towns and Villages of Monroe County, on or before the fifteenth day of December.**

This mortgage tax distribution will have no impact on the revenues or expenditures of the current Monroe County budget.

**MORTGAGE TAX DISTRIBUTION**

WHEREAS, in compliance with Section 261 of the Tax Law, the County Clerk and the Director of Finance have filed with the Clerk of the Legislature and the New York State Tax Commission a joint report, showing the total amount of Mortgage Tax allocated to the various tax districts in Monroe County to be \$8,002,164.52, for the period April 1, 2023 through September 30, 2023

NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE COUNTY OF MONROE, as follows:

Section 1. That the Controller is hereby authorized to draw checks on the Mortgage Tax Fund and to make payment on or before December 15, 2023 as follows: one to the City of Rochester, Treasurer, in the amount of \$1,445,365.76 and one to the Supervisor of each Town and to the Village Treasurer of each Village pursuant to the Distribution Table, as follows:
