Honorable Legislators:

I recommend that Your Honorable Body amend Resolution 278 of 2015 to extend the contract with the New York State Unified Court System, for the Monroe County Sheriff's Office to provide court security services for one (1) year, for the period of April 1, 2016 through March 31, 2017, in the amount of \$10,100,011.

Per Resolution 278 of 2015, Your Honorable Body authorized an extension to the contract with the New York State Unified Court System for the provision of court security services by the Monroe County Sheriff's Office. At this time, the New York State Unified Court System and Monroe County wish to extend the agreement for one (1) additional year. These funds will continue to provide for the salaries, benefits and other expenses for court security personnel.
