Subject: Authorize a Contract with and Accept a Gift from the Rochester Melanoma Action Group to Build a Shade Structure at Webster Park

Honorable Legislators:

I recommend that your Honorable Body authorize a contract with the Rochester Melanoma Action Group to accept a gift in the amount of \$11,000 for the building of a shade structure in Monroe County's Webster Park.

Rochester Melanoma Action Group is an all-volunteer group, founded in 2011, that focuses on raising awareness of the dangers of sun exposure and funding Melanoma research. The structure will provide profection to children and families from the sun and raise awareness of the importance of sun safety, in an effort to prevent Melanoma (Skin Cancer). The shade structure will be built by county parks tradesmen at a nearby playground off Holt Road in Webster Park, a popular area for children and families to play and picnic.

The specific legislative action required is to authorize the County Executive, or her designee, to accept a gift in the amount of \$11,000 from, and to execute a contract, and any amendments thereto, with the Rochester Melanoma Action Group for the building of a shade structure in Monroe County's Webster Park.

Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.

No additional net County support is required in the Monroe County budget.

The Rochester Melanoma Action Group is a not-for-profit corporation, and the records in the Office of the Monroe County Treasury have indicated that it does not owe any delinquent Monroe County Property taxes.
