RESOLUTION NO. ____ OF 2016

AMENDING 2017-2022 CAPITAL IMPROVEMENT PROGRAM TO ADD PROJECT ENTITLED "ENTERPRISE RESOURCE PLANNING/SECURITY"

BE IT RESOLVED BY THE LEGISLATURE OF THE COUNTY OF MONROE, as follows:

Section 1. The 2017-2022 Capital Improvement Program is hereby amended to add a project entitled "Enterprise Resource Planning/Security," in the amount of \$850,000.

Section 2. Funding for this contract, consistent with authorized uses, will be included in the capital fund to be established pursuant to the appropriation transfer requested, and any other capital fund(s) created for the same intended purpose.

Section 3. This resolution shall take effect in accordance with Section C2-7 of the Monroe County Charter.

Subject: Amend the 2017-2022 Capital Improvement Program and the Proposed 2017 Capital Budget to Add a Project Entitled "Enterprise Resource Planning/Security" and Authorize an Appropriation Transfer

Honorable Legislators:

I recommend that Your Honorable Body amend the 2017-2022 Capital Improvement Program and the proposed 2017 Capital Budget to add a project entitled "Enterprise Resource Planning/Security" in the amount of \$850,000; and authorize an appropriation transfer in the amount of \$850,000.

In preparation for the dissolution of Upstate Telecommunications Corporation ("UTC"), the Department of Information Services seeks to create a new capital project for the periodic enhancement and upgrade of the County's Enterprise Resource Planning software (currently SAP) and the annual deployment of cyber security tools. Components of this function were previously accounted for within the annual contractual payment made to UTC, while other components were anticipated to be financed by County bonding. The dissolution of UTC, however, will allow the Department of Information Services to include \$850,000 in the proposed 2017 operating budget for cash capital financing that can be transferred to the capital budget.

The County's Enterprise Resource Planning software and cyber security practices must continually be upgraded, improved, and enhanced due to the constant updating of technology and evolving threat of cyber attack. Creating a capital fund for such replacement, funded by cash capital in the annual operating budget is necessary for proper strategic, operational, and sound financial planning purposes.

This project is scheduled to be considered by the Monroe County Planning Board on December 1, 2016.

The specific legislative actions required are:

1. Amend the 2017-2022 Capital Improvement Program to add a project entitled "Enterprise Resource Planning/Security," in the amount of \$850,000.
2. Amend the proposed 2017 Capital Budget to add a project entitled "Enterprise Resource Planning/Security," in the amount of \$850,000.


3. Authorize the Controller to transfer \$850,000 from the proposed 2017 operating budget of the Department of Information Services, internal services fund 9020, funds center 1902010000, Equipment Lease/Maintenance, to the capital fund to be established for the project "Enterprise Resource Planning/Security."

Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.

Funding for this project, consistent with authorized uses, will be included in the capital fund to be established pursuant to the appropriation transfer requested herein, and any other capital fund(s) created for the same intended purpose. No additional net County support is required in the current Monroe County budget.

I recommend that this matter be referred to the appropriate committee(s) for favorable action by Your Honorable Body.
