RESOLUTION NO. ____ OF 2016

AMENDING 2017 CAPITAL BUDGET TO ADD PROJECT ENTITLED "NETWORK INFRASTRUCTURE" AND AUTHORIZING APPROPRIATION TRANSFER

BE IT RESOLVED BY THE AFFIRMATIVE VOTE OF NOT LESS THAN TWO-THIRDS OF THE TOTAL VOTING STRENGTH OF THE LEGISLATURE OF THE COUNTY OF MONROE, as follows:

Section 1. The 2017 Capital Budget is hereby amended to add a project entitled "Network Infrastructure," in the amount of \$200,000.

Section 2. The Controller is hereby authorized to transfer \$200,000 from the 2017 operating budget of the Department of Information Services, internal services fund 9020, funds center 1902010000, Equipment Lease/Maintenance, to the capital fund to be established for the project "Network Infrastructure."

Section 3. This resolution shall take effect in accordance with Section C2-7 of the Monroe County Charter.

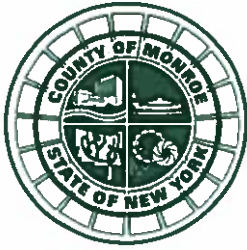

Subject: Amend the 2017-2022 Capital Improvement Program and the Proposed 2017 Capital Budget to Add a Project Entitled "Network Infrastructure" and Authorize an Appropriation Transfer

Honorable Legislators:

I recommend that Your Honorable Body amend the 2017-2022 Capital Improvement Program and the proposed 2017 Capital Budget to add a project entitled "Network Infrastructure" in the amount of \$200,000; and authorize an appropriation transfer for the project in the amount of \$200,000.

In preparation for the dissolution of Upstate Telecommunications Corporation ("UTC"), the Department of Information Services seeks to create a new capital project for the periodic replacement, upgrade, and improvement of various hardware, connection, and transmission components of the County's data network. As the cost of this function was previously accounted for within the annual contractual payment made to UTC, the Department of Information Services will include \$200,000 in the proposed 2017 operating budget for cash capital financing that can be transferred to the capital budget.

The County's data network must continually be upgraded, improved, and components replaced due to the rapid evolution of computer and data technology. Creating a capital fund for such replacement, funded by cash capital in the annual operating budget, is necessary for proper strategic, operational, and sound financial planning purposes.

This project is scheduled to be considered by the Monroe County Planning Board on December 1, 2016.

The specific legislative actions required are:

1. Amend the 2017-2022 Capital Improvement Program to add a project entitled "Network Infrastructure," in the amount of \$200,000.
2. Amend the proposed 2017 Capital Budget to add a project entitled "Network Infrastructure," in the amount of \$200,000.

3. Authorize the Controller to transfer \$200,000 from the proposed 2017 operating budget of the Department of Information Services, internal services fund 9020, funds center 1902010000, Equipment Lease/Maintenance, to the capital fund to be established for the project "Network Infrastructure."

Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.

Funding for this project, consistent with authorized uses, will be included in the capital fund to be established pursuant to the appropriation transfer requested herein, and any other capital fund(s) created for the same intended purpose. No additional net County support is required in the current Monroe County budget.

I recommend that this matter be referred to the appropriate committee(s) for favorable action by Your Honorable Body.
