Honorable Legislators:

I recommend that Your Honorable Body amend Resolution 289 of 2010, as amended by Resolution 437 of 2014 and Resolution 270 of 2015, to extend the license and operating agreement with the Seneca Park Zoo Society for one (1) year, through December 31, 2017, with all other terms to remain the same.

Per Resolution 289 of 2010, Your Honorable Body authorized a license and operating agreement with the Seneca Park Zoo Society. Resolution 437 of 2014 and Resolution 270 of 2015 each extended the license and operating agreement for one (1) additional year, currently through December 31, 2016. At this time, Monroe County and the Seneca Park Zoo Society wish to extend the license and operating agreement for an additional year.
