Honorable Legislators:

This matter is being referred to Your Honorable Body at the request of Sheriff Patrick M. O'Flynn.

I recommend that Your Honorable Body authorize an intermunicipal agreement with Ulster County, in an amount not to exceed \$140 per inmate, per day, for reimbursement to the Monroe County Sheriff's Office for the provision of security services at the Rochester Psychiatric Center Forensic Unit for patient inmates of Ulster County, for the period of January 1, 2018 through December 31, 2018, with the option to renew for three (3) additional one-year terms upon mutual consent of all parties.

Under this agreement, the Monroe County Sheriff's Office will provide security services at the Rochester Psychiatric Center Forensic Unit to Ulster County's inmates who meet the criteria of Section 508 of the New York State Correction Law, conditioned upon available bed space and the recommendations of the examining psychiatrist at the Center.

The specific legislative action required is to authorize the County Executive, or her designee, to execute an intermunicipal agreement, and any amendments thereto, with Ulster County, for reimbursement to the Monroe County Sheriff's Office for the provision of security services at the Rochester Psychiatric Center Forensic Unit for patient inmates of Ulster County, in an amount not to exceed \$140 per inmate, per day, for the period of January 1, 2018 through December 31, 2018, with the option to renew for three (3) additional one-year terms upon mutual consent of all parties.
