I recommend that Your Honorable Body authorize contracts with Testa Construction, Inc., in the amount of \$251,200, for general construction, North Coast Electrical Solutions LLC, in the amount of \$105,300, for electrical construction, Pipitone Enterprises, LLC, in the amount of \$34,800, for mechanical construction, and Lloyd Mechanical Company, LLC, in the amount of \$17,495, for plumbing construction, for the Monroe Community College (MCC) New Science Lab and Support Space Project.

This project involves renovations to approximately 2,100 square feet of existing biology department space on the third floor of MCC Building 7 (Sciences Building) at the Brighton Campus. The project will result in the creation of a new teaching laboratory, an open study room and associated support areas. Work will include general mechanical, electrical and plumbing (M/E/P); heating, ventilation and air conditioning (HVAC) and electrical systems. The project is scheduled to be complete in time for the fall 2018 semester.
