Honorable Legislators:

I recommend that Your Honorable Body enact a Local Law authorizing the sale of surplus property, owned by the Rochester Pure Waters District, consisting of approximately 2.9 acres of improved land on East Ridge Road in the Town of Irondequoit, having an address of 2629 East Ridge Road, to the Town of Irondequoit for the sale price of \$130,000.

This parcel was acquired in 1979 and is improved by a roadway. This sale price of the surplus property was established upon the valuation found in an independent appraisal performed by Bruckner, Tillett, Rossi, Cahill & Associates.

The specific legislative actions required are:

- 1. Schedule and hold a Public hearing on the proposed Local Law.
- 2. Enact a Local Law authorizing the County Executive, or her designee, to execute all necessary documents, deeds and agreements to effectuate the sale of a surplus property, owned by the Rochester Pure Waters District, consisting of approximately 2.9 acres of improved land on East Ridge Road in the Town of Irondequoit, having an address of 2629 East Ridge Road, to the Town of Irondequoit for the sale price of \$130,000.
