Subject: Authorization to Settle a Lawsuit entitled "Katharina Jedrzejek v. County of Monroe, New York"

Honorable Legislators:

I recommend that Your Honorable Body authorize a settlement in the amount of \$50,000 in an action brought against the County of Monroe by Katharina Jedrzejek.

The Jedrzejek lawsuit arises out of an accident occurring on January 5, 2010.


The specific legislative actions required are:

1. Authorize the settlement of the Jedrzejek lawsuit for \$50,000.
2. Authorize the County Executive, or her designee, to execute and deliver any and all documents necessary to effectuate such settlement.

Funding for the payment of the settlement is available in the Risk Management Fund. No additional net County support is required in the current Monroe County budget.

I recommend that this matter be referred to the appropriate committee(s) for favorable action by Your Honorable Body. I request that the Jedrzejek lawsuit referral be considered in Executive Session, pursuant to the Public Officer's Law.
