RESOLUTION NO. ____ OF 2017

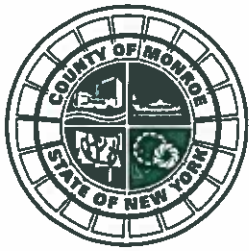


