Subject: Authorize Contracts to Provide Temporary Nursing Staff at Monroe Community Hospital

## Honorable Legislators:

I recommend that Your Honorable Body authorize contracts with Interim Healthcare of Rochester, Medical Solutions, Inc., Maxim Healthcare Services, Inc. (DBA Maxim Staffing Solutions), WorkFit Medical, LLC, Adecco Medical & Science Staffing, Inc., Nursefinders, LLC, Reliant Staffing Systems, Inc. (DBA Career Start), Clinical Staffing Resources Corp. and any other qualified nursing staffing agency, in the total amount not to exceed \$2,400,000 collectively, to provide nursing staff relief on a temporary basis at Monroe Community Hospital (Hospital), for the period of April 1, 2017 through March 31, 2018, with the option to renew for two (2) additional one-year terms in a total amount not to exceed \$2,400,000 collectively per year with a three (3) percent inflation consideration added to each year.

Monroe Community Hospital must maintain adequate staffing for patient care. These contracts will provide for temporary relief services needed to cover absences due to illness, injury on duty, vacations and job vacancies for certified nursing assistants, licensed practical nurses and registered nurses at the Hospital. The necessity of having a number of temporary agencies to provide nursing personnel is crucial in order to assure proper staffing is met at all times.

A Request for Qualifications was issued for these services. The top eight (8) who were chosen are: Interim Healthcare of Rochester, Medical Solutions, Inc., Maxim Staffing Solutions, WorkFit Medical, LLC, Adecco Medical & Science Staffing, Inc., Nursefinders, LLC, Reliant Staffing Systems, Inc. (DBA Career Start) and Clinical Staffing Resources Corp.

The specific legislative action required is to authorize the County Executive, or her designee to execute contracts, and any amendments thereto, with Interim Healthcare of Rochester, 347 East Avenue, Rochester, NY 14604, Medical Solutions, Inc., 135 W. Ridge Road, Rochester, NY 14615, Maxim Healthcare Services, Inc. (DBA Maxim Staffing Solutions), 392 Pearl Street, Suite 400, Buffalo, NY 14202, WorkFit Medical, LLC, 1160 Chili Avenue, Rochester, NY 14624, Adecco Medical & Science Staffing, Inc., 1890 South Winton Road, Suite 180, Rochester, NY 14618, Nursefinders, LLC, 1900 South Clinton Avenue, Rochester, NY 14618, Reliant Staffing Systems, Inc. (DBA Career Start), 252 South Plymouth Avenue, Rochester, NY 14608 and Clinical Staffing Resources Corp., 420 Broadway, 3rd Floor, Brooklyn, NY 11211, and any other qualified nursing staffing agency in a total amount not to exceed \$2,400,000 collectively, for the period of April 1, 2017 through March 31, 2018, with the option to renew for two (2) additional one-year terms in a total amount not to exceed \$2,400,000 collectively per year with a three (3) percent inflation consideration added to each year.

Funding for these contracts is included in the 2017 operating budget of Monroe Community Hospital, fund 9012, funds center 6201010000, Monroe Community Hospital and will be requested in future years' budgets. No additional net County support is required in the current Monroe County Budget.

Environmental assessments were completed for this action and it was determined that there would be no significant effect on the environment.

The records in the Office of the Monroe County Treasury have indicated that neither Interim Healthcare of Rochester, Medical Solutions, Inc., Maxim Healthcare Services, Inc.
