# DOG PARK RULES

Monroe County Dog Park Rules and Regulations - (Monroe County Parks Law § 323-20)

- All dogs in an off-leash area must be licensed.
- All persons bringing a dog to a designated off-leash area must carry and have available for inspection a permit issued by the Parks Director.
- No animal other than dogs are permitted in off-leash areas.
- Any person who takes a dog into a designated off-leash area:
  - must have physical control of the dog by means of a leash when entering and leaving the off-leash area;

- must maintain voice control over the dog and keep the dog in sight at all times while in the off-leash area and shall be responsible for the conduct of such animal and shall be responsible for all injury to person or property caused by the dog;

- shall carry the proper equipment for removing feces from the designated area and dispose of same in a sanitary

manner by placing the feces deposited by such dog in an appropriate receptacle. Dog feces must be removed immediately and deposited in the receptacle;

- must immediately leash and remove from the off-leash area a dog showing aggression toward persons or other dogs.
- Professional dog trainers may not use an off-leash area for the conduct of business.
- No person shall bring more than three dogs to an off-leash area at one time.
- The Parks Director may temporarily ban dogs or a specific dog from any off-leash area where the Director determines that same may be a nuisance or is necessary to maintain peace and order, or necessary to protect the health and safety of the public.
- All dogs entering the off-leash area must wear a tag issued annually by the Parks Director.
- No children under ten (10) years of age are allowed inside the off-leash area. Children over ten (10) and under eighteen (18) must be accompanied by an adult person eighteen (18) years of age or older and be under that adult's supervision.
- A Small Dog area is for dogs weighing twenty-five (25) pounds or less; a Large Dog Area is open to dogs of all weights.
- All dogs brought by one person must remain in the same area (Small Dog Area or Large Dog Area) with that person.
- Gates to the off-leash area must be kept closed and latched at all times, except when entering or exiting.
- Each person bringing a dog into the off-leash area should discourage digging and must immediately fill-in any holes.
- No dog or person is to climb on or over the off-leash area fences.
- The following are NOT PERMITTED within the off-leash area: Dogs in heat; Dogs that are ill or injured; Pinch, spike,

prong, and choke collars; Puppies under six (6) months of age; Alcoholic beverages, smoking, food, or glass; Dog treats and rawhide chews; Bicycles, scooters, skateboards or any other wheeled or motorized devices (except wheelchairs).

- There shall be no soliciting.
- Nonobservance of these rules and regulations constitutes a violation of the Monroe County Park Law. Under Parks Law, violators are subject to penalties for the offense. Penalties range from civil penalties of \$25 to \$100, fines from \$50 to \$750 and/or imprisonment up to 30 days.

## Monroe County Dog Park Rules and Regulations County of Monroe, State of New York

Monroe County Code provisions regarding Dog Parks or off-lease areas:

§323-20. Dogs, Cats, and other household pets.

A. No person shall bring into, permit, have or keep in a park any dog, cat or other household pet or any other animal which may be injurious or destructive to birds, fish, animals or other wildlife, plant life or other natural features within a park or may be dangerous, injurious or offensive to other users of a park; except that dogs and cats shall be permitted within a park if controlled by leash. Horses may be permitted in a park only as set forth in § 323-13 above.

B. Notwithstanding the above, dogs, cats, other household pets and horses are prohibited in all swimming areas and beaches; and dogs and horses are not permitted to be on golf courses or in picnic areas.

C. Exceptions.[Added 9-9-2003 by L.L. No. 11-2003, approved 9-25-2003 Editor's Note: This local law also provided for the renumbering of former Subsections C and D as D and E, respectively.]

(1) Designated off-leash areas. Nothing in this chapter is intended to prohibit a dog from running at large in such off-leash areas as the Parks Director may designate upon such terms as the Director deems advisable and to discontinue such use at any time, provided that no off-leash areas may be designated by the Director until all necessary improvements to construct said areas have been completed using private funds only.

(2) Licenses and permits. All dogs in an off-leash area must be licensed as required by this chapter and all applicable laws or rules. All persons bringing a dog to a designated off-leash area must carry and have available for inspection a permit issued by the Parks Director which shall be produced upon request. The application for an off-leash permit shall be provided by the Parks Department and shall be filed by the applicant with a copy of a valid dog license, a current rabies vaccination certificate issued by a licensed veterinarian if vaccination information listed on the dog's license is missing or the vaccination has expired, proof of county residency and such other proof or information as may be required by the Parks Director, together with payment of the applicable fee. The Parks Director may deny an application as he deems advisable. If an application is granted, such permit shall identify the name and address of the dog owner and the name, sex, breed, color and markings of the dog. Once issued, the permit is not transferable to another dog and shall expire one year from the date of its issuance.

(3) Dogs only. No animal other than dogs are permitted in off-leash areas. Any person who takes a dog into a designated off-leash area must have physical control of the dog by means of a leash when entering and leaving the off-leash area, and must maintain voice control over the dog and keep the dog in sight at all times while in the off-leash area. Each person bringing a dog into an off-leash area shall be responsible for the conduct of such animal and shall be responsible for all injury to person or property

caused by the dog. Dogs showing aggression toward persons or other dogs must be immediately leashed and removed from the off-leash area. Each person bringing a dog into the off-leash areas shall carry the proper equipment for removing feces from the designated area and dispose of same in a sanitary manner by placing the feces deposited by such dog in an appropriate receptacle. Professional dog trainers may not use an off-leash area for the conduct of business, and no person shall bring more than three dogs to an off-leash area at one time.

(4) Rules and regulations. The Parks Director may adopt such rules and regulations as he deems advisable for the safe use and operation of the off-leash areas. The Parks Director may temporarily ban dogs or a specific dog from any off-leash area where the Director determines that same may be a nuisance or is necessary to maintain peace and order, or necessary to protect the health and safety of the public. If a dog is repeatedly permitted or allowed to commit acts in violation of this chapter, the Parks Director may revoke the permit issued to the dog upon written notice to the owner either personally delivered or by regular United States mail.

D. Any person who has custody of a dog, which dog has caused its feces to be deposited upon any County park property, shall immediately remove such feces and shall dispose of it in a sanitary manner.[Added 4-9-2002 by L.L. No. 2-2002, approved 5-6-2002 Editor's Note: This local law also provided for the renumbering of former Subsection C as D.]

E. Nonobservance of this section shall constitute a violation.



# DOG PARKS MONROE COUNTY DOG PARK FAQ

### How do I register my dog to use the dog parks?

All owners must register their dogs with the Monroe County Department of Parks. Dogs can be registered during normal business hours: M – F 8:30am – 4:30pm at 171 Reservoir Avenue, Rochester, NY 14620. You will need a current copy of your dog(s) license with current address, a copy of current Rabies Certificate, completed permit, and a signed Acknowledgement, Agreement, and Release form. Permit and Acknowledgement, Agreement, and Release forms are available only where you register. There is a \$24 per dog fee that can be paid via cash or check. Credit card payments can only be taken at the Parks Department. Credit card payments will be \$25 per dog which includes service fees. Staff will also be available at the park for registration periodically. Call 753-PARK or go to monroecounty.gov for information on upcoming on-site registration dates and times. When registering your dog at the park, in addition to copies of your forms, please bring a check or money order made payable to "Monroe County Parks Department" for the exact amount (\$24.00 per dog). Cash and credit cards cannot be accepted at on-site registrations.

### Does my registration and permit expire?

Dog Park registration tags and permits expire December 31<sup>st</sup>. You will need to register your dog(s) each year to receive your new registration tag and permit.

### Why does my dog need to be registered?

By requiring dogs to need a registration tag and permit, we are able to ensure that all dogs are licensed and have been vaccinated for rabies. Additionally, the money collected from the registration fee goes directly to the maintenance, improvements, and construction of dog parks in Monroe County.

### What vaccines does my dog need?

The only vaccine required by New York State Law is the Rabies Vaccine. However, you may wish to discuss the following with your veterinarian before bringing your dog to a dog park: DHPP (Distemper, Hepatitis, Parainfluenza, Parvo) Vaccine; Leptospirosis Vaccine; Kennel Cough (Bordetella) Vaccine; Flea and Tick prevention; and Heartworm prevention.

### How many dogs can I register?

You may register all dogs licensed to you at your current address. The registration fee must be paid for each dog.

### Where does the registration money go?

All registration money will be deposited into the Monroe County Dog Park Trust Fund. This trust fund is used to build and maintain dog parks in Monroe County.

### Can I transfer my dog's registration tag?

No.

### What if I lose my tag?

Replacement tags are available at the Monroe County Parks Department at: 171 Reservoir Avenue, Rochester, NY 14620 during normal business hours. M – F 8:30am – 4:30pm. The fee to replace a tag is \$5. You must bring a copy of your current dog park permit.

### What are the hours of the dog parks?

The Dog Parks are open 7am til DUSK. There are no lights at the dog parks. The dog parks may close without notice for maintenance and/or repairs.

### How do I enter/exit the parks?

Dog parks are neutral ground for most dogs and to keep it this way, never bring your dog into the offleash area while on a leash. The double gated system allows you to enter a safe area at which time you can unleash your dog prior to entering the off-leash area. Once in the park, move away from the gate so that other dogs aren't intimidated at the entrance. When you are done in the off-leash area, bring your dog into the double gated area before re-leashing your dog. Always be sure to secure the gate behind you and check to make sure all gates are secure before bringing your dog into the double gated area to leash or unleash.

### When is the dog fountain open?

The water fountains will be closed from late fall to early spring to prevent the water lines from freezing. Please plan on bringing your own water during this time period.

### Why can't my large dog play in the small dog area?

This is strictly a safety issue. While some large dogs may be slow and gentle, toy breeds in particular can easily be harmed. The dog park needs to be safe for dogs of all sizes.

### Why is there a stone surface?

A stone surface (crushed limestone stone dust) was chosen based on research conducted by the Monroe County Department of Parks and other dog parks around the country. A stone surface provides both the safest and most sanitary surface option. Other surface options researched include grass and mulch. A grass surface would not hold-up to the extra wear and tear caused by the dogs in a confined area. The grass would soon be worn down and the dirt would alternate between mud and dust. Wood chips and mulch were also considered and ruled out, based primarily on sanitary concerns. If you have concerns about the stone surface, please discuss this matter with your veterinarian.

### Why can't I bring children under 10 years old into the dog parks?

The dog park is for dogs and owners. Small children take attention away from your dog, and children aren't always a good mix with fast moving large dogs or little scrappy dogs. It is important for owners to concentrate on their dog(s) and make the dog parks as safe as possible for everyone.

### Why can't I bring food or dog treats into the dog parks?

Food is one of the most common aggressive triggers with dogs. While there may be no intention of dropping a piece of doughnut or sandwich, crumbs can easily lead to acts of aggression.

### Why can't I leave my dog's prong, pinch, spiked, or choke collar on?

These collars are very easy for other dogs to get tangled in while playing. For the dog's safety it is important to take these collars off before entering the dog park.

### Why can't I bring my puppy?

Puppies under six (6) months of age are not permitted in the dog park for two primary reasons. The first reason is that their play may offend older or more aggressive dogs. The second reason is that they aren't old enough to have their full series of puppy vaccinations. If you are looking to socialize your puppy in a safe setting please look for puppy classes or puppy daycare.

### How can I support the dog parks?

### What if my dog(s) uses the park without a permit and registration tag?

Owners who allow their dogs to enter the dog park without having the proper registration tag and permit are in violation of the Monroe County Parks Law and subject to potential fines and/or imprisonment.

### What do I do if I see an unregistered dog in the park?

As the parks are self-patrolled, it is everyone's responsibility to keep our parks safe for registered users. Please ask the owner if the dog has a permit. The registration tag could have fallen off or maybe the owner forgot the right collar. Use this opportunity to be an ambassador for the dog parks. If the tag has broken, let the owner know where they can get a new one. If the dog isn't registered, let the owner know how easy it is to register their dog and how the registration fee helps us all.

### What if I see someone is not picking-up after their dog?

The dog parks are self-patrolled. Waste receptacles and "poop bags" are available and conveniently located within the off-leashed area. Usually owners will pick-up after their dogs. It is possible the owner was not paying attention as their dog relieved itself. You can politely point out to the owner that they may have missed their dog eliminating and what general area the offending substance is in. Unfortunately, some owners may still not pick up after their dog. In order to keep the park clean, safe, and sanitary there may be the need for you to pick up another dog's feces. Please know from all the dog park users how thankful we are for all efforts to keep our dog parks clean and safe.

### What if I only live in Monroe County part of the year?

According to New York State Law any dog residing in NY for more than 30 days must be licensed in the city, town, or village they are residing. Please see www.agmkt.state.ny.us/AI/Doglic.html or call your local license office for more information.

### How do I prevent a dog fight?

The best prevention is to never let your dog leave your sight. If you notice a dog becoming aggressive, ask the owner to remove the dog from the park to cool down or go home for the day. If the owner is not receptive, remove your dog promptly from the park. If your dog becomes aggressive or begins playing too rough, take your dog out of the park to cool down. As always, if a situation becomes dangerous, call 911.

### What do I do if there is a dog fight?

Remain calm. Loud yelling, screaming, and/or quick movements can unintentionally increase arousal. **Never get in between two dogs fighting or you can risk injury to yourself.** Many experts suggest diverting the dogs with a loud noise such as an air horn or a blast of water from a sports bottle. There will be many scuffles as dogs will be dogs. Dog fights are rare in dog parks, but the potential is there. Please talk with your veterinarian if you have concerns about breaking-up a dog fight involving your dog. If your dog is involved in a dog fight, exchange information with the other owner. Be sure to include your name, phone numbers, and vaccination records. If your dog is not involved in the fight, remove your dog from the off-leash area. As a courtesy, you should remain nearby until the situation is under control and make sure everyone (dogs and people) are all okay. **If any of the dogs involved in the incident are clearly aggressive or dangerous, call 911.**
