Monroe County has not had the opportunity to test these corrections thoroughly. Accuracy is dependent upon equipment and procedures. Monroe County recommends testing the accuracy of all RTCM products at each project site. Testing should also include connections to local coordinate systems and datum.

Data Reliability:

Monroe County RTCM is dependent upon a real time data stream through the Monroe County IT network. If the network connection to this site is down, RTK processing will not be available until the problem is resolved. Monroe County will keep the public aware of any issues pertaining to base station availability through their GIS website.
