Legislative Update (Legislators Yudelson, Delehanty and Milne):

Not much new. Continue to hear positive comments from residents on moving forward composting, Pittsford food scraps program. Legislature has passed everything CAP-related before it to move forward with the program.

All 500 buckets in Pittsford Food Scraps Pilot reserved &/or picked up by residents.

 - Suggest adding Executive Summary will be pulled into the actual Plan
- Will send BAU forecast next

2. Draft Plan Outline & Preliminary Action Plan

- Public facing draft plan? Simplified from the goal workbook
 - Sneak peek ad campaign (CE video?)

3. Public Outreach Updates

- Survey responses: 589 to date
 - o Pat and Madison got greater participation through recent outreach events
 - Age distribution: 28% 25-34, 25% 35-44, 7% <25
 - o Overwhelmingly white 85%, 4% Black, 3% Latino
 - o 49% woman, 48%, man, 2% nonbinary, 5% other
 - More outreach on Western side of County this past weekend (Genesee Country Village & Museum in Mumford & Housing workshop at MCC Brighton Campus)
 - o Looking to close survey in next week or two (will keep it open, but will start tabulation)
- Putting together a stakeholder outreach guide, work plan
 - Kate Walker reviewed initial list, suggested if email has been primary method, try cold calling ask if meetings are happening we can attend/speak to their group? Kate offered to assist with calls to groups that have not weighed in and should be at the table
 - o Some groups seeing survey for first time -- it takes too long
 - o ARPA: had submission portal for grant funding
 - o Groups want to know where the funding is
 - o Kate suggested one last ditch effort to increase diversity of respondents
 - Find out from community how meetings should be scheduled
 - o How implementation is going to be rolled out?
 - Breakout working groups subject matter experts advising the County
 - o Message should be that this is the start of the process, living document, not too late to participate
 - Akilah Banister attended NYS Senate Climate Justice Roundtable suggests co-hosting an event with local elected officials or prominent community members or groups to convene stakeholders. Rather than

trying to bring all stakeholders together, reaching out to leaders within community that haven't weighed in and ask them to convene a meeting for us to present, reacting to draft CAP Phase II

- Matt O'Connor has reached out to Pittsford Town & Village, Rotary Club, School District, & Chamber of Commerce. Suggests reaching out to Diocese of Rochester
- Kate Walker suggests big splash announcing next phase of outreach draft plan and compilation of priorities gathered in outreach thus far for public comment and stakeholder engagement; Matt O'Connor suggested having another County Executive announcement video to generate excitement; Suggested PechaKucha presentation – simple storytelling, image based
