# JOB SUMMARY:

This position, located at the Public Defender's Office in the Family Court Bureau, is responsible for assisting and guiding clients through the court and other institutional processes. As the employee actively participates with the attorney and staff to develop case management plans, the employee also provides encouragement to clients to engage in services to avoid State intervention.

- (C) An equivalent combination of education and experience as defined by the limits of (A) and (B) above.

\*\*Volunteer experience must be documented by the participating agency and signed by the appointing authority. Employment dates, average number of hours worked per week, and job duties must be included. Documentation must be included with your application.

This position is subject to a background check for criminal convictions. Convictions will be considered but will not automatically disqualify the candidate.
