Notice of Monroe County's Amendment to the Consolidated Plan and 2020-21 Annual Action Plan for Community Development Block Grant (CDBG) Program funding.

The amendment to the Consolidated Plan and 2020-21 Annual Action Plan is being completed to change funding from CARES Act to CDBG.

Monroe County will be utilizing \$100,000 of its Revolving Loan funds to CDBG eligible projects for the 2020-21 program year.
