Introduction

The Monroe County Assigned Counsel Program marked its thirty-first year of operation in all courts within Monroe County. It was also the twentieth year of operation for the Conflict Defender Office.

The attorneys in the Conflict Defender's Office represent indigent clients in Monroe County Family Court, Rochester City Court and appeals before the Appellate Division, Fourth Department. At the end of 2022, the Monroe County Conflict Defender's Office was made up of thirty-one staff members, nineteen attorneys and twelve support staff. The CDO staff grew by seven staff members during the course of the year.

The Office's nineteen attorneys include the Conflict Defender, seven Family Court attorneys, eight attorneys handling misdemeanor criminal cases in Rochester City Court and three appellate attorneys. In 2022, the Conflict Defender's Office provided quality legal representation in **1,976** criminal cases, **1,528** Family Court cases, and **30** new appellate cases. The Office's support staff consists of five full-time clerks, four paralegals, two investigators and a social worker who all provided support to the attorneys and clients of the Conflict Defender's Office.

There was little staff turn-over in 2022. All of the attorneys that CDO had at the beginning of the year were still with us at the end of the year. In fact, we added two attorney positions, one appellate attorney and one criminal court attorney. We had two clerks leave the office in 2022; one of these vacancies was filled by the end of the year. And, in 2022, we created a number of positions that were brand new to the CDO. These positions include four paralegal positions, two investigator positions and a social worker. Previously, investigator services were used on a contract bases with outside vendors.

The clerks processed approximately **3,534** cases for the Conflict Defender's Office, approximately **3,300** assignments for the Monroe County Assigned Counsel Program and more than **3,250** vouchers for assigned attorneys and other vendors in 2022. The investigators worked with our criminal court attorneys to, among other duties, speak to witnesses, locate evidence and serve subpoenas. Our paralegal staffs' duties included interviews with clients for a determination as to whether they are eligible for legal representation, working with attorneys to download and review discovery, assist with preparation of motions and correspondence. The social worker position began late in the year to move the CDO toward providing Family Court clients with multidisciplinary representation.

As noted in the 2021 Annual Report, these staff positions were added to the Conflict Defender's Office due to a change in how Monroe County is providing services to Rochester City Court clients. Prior to 2021, the Monroe County Public Defender's Office provided the primary representation of clients in Rochester City Court while the Conflict Defender's Office would only represent clients when the Public Defender's Office had a conflict of interest. Starting in 2021, the Conflict Defender's Office began taking a larger percentage of the new cases coming into Rochester City Court. At the end of 2021, the Public Defender's Office and Conflict Defender's Office were each handling approximately 50% of City Court cases. In 2022, the transition was completed and the Conflict Defender's Office is now the primary provider of legal services on misdemeanor cases in Rochester City Court. This increased responsibility and caseload required more staff, including on-staff investigators and paralegals.

A number of staff positions continue to be filled pursuant to grants from the New York State Office of Indigent Legal Services (ILS); these include clerk staff positions, criminal court attorney positions and Family Court attorney positions. In 2022, Monroe County accepted a grant from ILS regarding Family Court Article 10 (allegations of child neglect) cases. This grant allowed for the hiring of the brand new social worker position as well as a new Family Court attorney position. This new attorney position was still vacant at the end of 2022.

The Monroe County Assigned Counsel Program is governed by the joint Monroe County/Monroe County Bar Association Plan for Conflict Assignments adopted in 2003. The Assigned Counsel Program currently has attorneys on eight (8) panels. Attorneys on the assigned counsel panels are attorneys in private practice willing to represent indigent clients. An attorney's membership on each panel depends on the complexity of the case and the training, experience and expertise of the attorney. The current panels that make up the Assigned Counsel Program are the Homicide/Predatory Sexual Offense Panel, the ABC Felony Panel, the DE Felony Panel, the misdemeanor criminal panel, the Raise the Age Panel, the Probation/Parole Violation Panel, the Family Court Panel and the Appellate Panel. Panel attorneys accept assignments in all courts in Monroe County: all town and village courts, all felony cases, Family Court cases, all statutorily assigned cases in Surrogate and Superior Court as well as all cases where both the Conflict Defender Office and Public Defender's Office has a conflict of interest. In 2022, **130** private attorneys accepted approximately **3,300** assignments.

It is remarkable that **130** attorneys accepted assignments in 2022. The attorneys of the Monroe County Assigned Counsel Program are willing to represent clients at the State statutory rates, set in County Law § 722-b, of \$60/hour for misdemeanor cases and

\$75/hour for felonies, Family Court and appellate matters. These rates became effective on January 1, 2004 and have not been increased since that date. These rates are well below the rates attorneys are paid in retained cases and less than half the rate that assigned attorneys are paid in federal court pursuant to the Criminal Justice Act. It is unconscionable that the State of New York has not raised rates paid to attorneys representing indigent clients in **twenty years**. The State of New York has abdicated its responsibility to provide effective representation under the Sixth Amendment of the United States Constitution. Despite the disturbing inaction of the State of New York, **130** assigned counsel panel attorneys, dedicated to the fight for justice for indigent clients accepted assignments in approximately **3,300** cases in 2022.

It should be noted that the unconscionably low rates have taken their toll on our assigned panels. The number of attorneys who accepted an assignment in 2022 was **130**, down from the **151** who accepted assignments in 2021.

The remainder of this report outlines, with statistical information, the Program's success in meeting the goals of the Plan which are articulated here:

"The objectives of this conflict assignments plan are to provide quality representation to eligible indigent defendants or other litigants in those cases where the Public Defender has a conflict of interest; to provide a coordinated and centralized assignment system for conflict cases arising in the courts specified in Article IV herein; to provide a more equitable distribution of conflict assignments among lawyers; to attract more lawyers willing to handle conflict assignments; to maintain uniform and proper billing practices; to ensure cost accountability of services, and to provide increased efficiency for the courts by making qualified attorneys more readily available to handle conflict cases." *Monroe County Bar Association Sponsored Plan for Conflict Assignments*, ARTICLE II. Plan Objectives

"To Provide Quality Representation"

In 2022, the total number of case referrals (see page 9) continued was at 6,899. This number was up from the Covid years of 2020 and 2021 (two year average of 6,164), but

still below the pre-pandemic era as from 2017-2019, the total number of cases was steady at approximately 8,500 each year.

Indicative of the pandemic's effect on the number of cases being heard is the number of appellate cases. In 2019 there were over 100 appeal assignments. With the court system shut down for a good portion of 2020 and the lack of trials, the number of appeals has plummeted to 32 assignments in 2021. The number of appeal assignments for ACP and CDO combined was 46 in 2022, somewhat higher than 2021 but well below the high of 2019.

All Assigned Counsel panel attorneys have qualified for their respective panels under the enhanced requirements for panel membership that were implemented in 2014 by then-Conflict Defender Charles Noce, Esq. These panel requirements remain in effect in an ongoing effort to continue to maintain and enhance the quality of representation that indigent clients in Monroe County receive.

With respect to the Conflict Defender Office, the attorneys handling appeals and misdemeanor cases in Rochester City Court were able to maintain a high level of representation for their clients, as did the staff attorneys assigned to Monroe County Family Court. Increased staff including paralegals and on-staff investigators have increased the quality of representation of the CDO's criminal court staff. In Family Court, the addition of a staff social worker has contributed to an increase in the quality of representation as CDO is moving toward providing multidisciplinary representation for clients in Article 10 cases.

As the Continuing Legal Education (CLE) requirements of all staff attorneys of the Conflict Defender Office and panel attorneys for the Assigned Counsel Program overlap with the Mandatory Continuing Legal Education requirements of the State of New York, compliance is 100%.

However, it is a goal of the Conflict Defender Office, in conjunction with the appropriate committees of the Monroe County Bar Association, to create more opportunities for training of attorneys.

"To Provide a Coordinated and Centralized Assignment System for Conflict Cases"

The Assigned Counsel Program is fully computerized, and has been through a number of electronic transformations. The initial computer program (2003-2010) entered all cases reported in it to a centralized database that tracked the representation from assignment through payment of the voucher for all cases; both Assigned Counsel and Conflict Defender cases. At the end of calendar year 2011, a new database was purchased for use by the office, and the underlying support system needed for the use of the prior ACP Database was discontinued. This system was in operation from approximately 2011-until August 2016. In August 2016, a new electronic voucher system and overall conflict case assignment database became operational. This current system is essentially paper-less with vouchers being sent to the courts for review electronically. This has resulted in a savings on time and effort, as well as an improvement on efficiency.

Assignments referred by the courts continue to be assigned from a rotating list of qualified attorneys who meet the requirements to be on the varying panels. The program, when used by the Courts, is very successful in ensuring continuity of counsel where a client has additional matters pending in Family Court or is re-arrested on new charges, even when the arrests span differing jurisdictions. Additionally, the program continues to track conflict of interest information so that panel attorneys are not unnecessarily assigned when the Conflict Defender Office could ethically continue.

"To Provide a More Equitable Distribution of Conflict Assignments Among Lawyers"

The Assigned Counsel Program continually strives to improve its system of assignment of conflict cases. The Program constantly attempts to implement new and better systems to distribute assignments more equitably among the participating attorneys.

In criminal cases, the current system is highly effective when fully utilized by the Courts of Monroe County. Less than 16% of criminal court assignments came from the bench, the vast majority were through the staff of the Assigned Counsel Program. In Family Court, on the other hand, the equitable distribution of cases remains an issue in cases not represented by the Conflict Defender staff as 50% of assignments to panel attorneys in Family Court are still made directly from the bench. It remains a goal of the

Conflict Defender Office to address the inequities in Family Court assignments. The fact that a few attorneys receive the bulk of the assignments places an undue burden on those attorneys and can impact directly on the quality of representation. A number of attorneys who have receive a high percentage of assignments in Family Court have complained of burnout and have limited or stopped taking assignments.

"To Attract More Lawyers Willing to Handle Conflict Assignments"

Included in this report (see page 8) is a list of new panel members added during the 2022 calendar year.

These attorneys were added to the panels under the requirements for panel membership that were implemented in 2014 by then-Conflict Defender Charles Noce, Esq. These panel requirements were created and remain in effect in an ongoing effort to continue to enhance the quality of representation that indigent clients in Monroe County receive.

The Conflict Defender's Office, with the assistance of the Monroe County Bar Association, has taken steps to recruit qualified attorneys to the assigned counsel panels.

The majority of new attorneys on the panels were added to the Appellate Panel. The last few years have taken a toll on our Appellate Panel with a number of attorneys leaving the panel. A concerted recruitment effort was undertaken to add new attorneys to the Appellate Panel.

"To Maintain Uniform and Proper Billing Practices and to Ensure Cost Accountability of Services"

As was the case in previous years, the Conflict Defender reviews each voucher to ensure compliance with the voucher regulations and notifies each attorney of any noncompliance to educate the attorney on proper procedures. The review and notification help maintain proper and uniform billing practices among the participating attorneys.

Having received a Grant from the New York State Office of Indigent Legal Services to fund the purchase of an electronic vouchering system, the system became operational

in August 2016. The use of the electronic voucher system has significantly increased the efficiency and accuracy of reviewing vouchers. This current system is essentially paperless with vouchers being sent to the courts for review electronically. This has resulted in a savings on time and effort, as well as an improvement on efficiency.

"To Provide Increased Efficiency for the Courts"

The Courts that fully utilize the services of the Assigned Counsel Program report a positive impact on the efficiency in obtaining assigned counsel in conflict cases. These Courts report a significant decrease in the burden on the court staff in finding attorneys willing to accept assignments and a prompt response from the Assigned Counsel Program in obtaining assigned counsel.

The electronic voucher system has increased the efficiency in voucher processing. Panel attorneys can access the system from any computer or smart phone with a login username and password. This system requires timely filing of vouchers by assigned counsel. The system allows for ease of review by the Conflict Defender. Furthermore, as the vouchers can be transmitted between the Conflict Defender Office and the Courts electronically instead of through the mail, it cuts down on total processing time. Additionally, the system allows for County payment with minimal paperwork.

The efficiency of the Courts has clearly been facilitated by the dedicated attorneys serving on the assigned counsel panels, and the staff attorneys in the Office of the Conflict Defender, while ensuring high quality representation in Family Court, all of the criminal and appellate courts in 2022.

2022 Assignments

The following charts show the assignments each attorney received in 2022. The number of assignments is higher than the number of cases referred because in some cases more than one attorney receives an assignment for a case. Also, an attorney might be assigned in 2022 to a case originally referred in a previous year. This occurs most often after a court relieves one attorney and either the court or the Assigned Counsel Program assigns a new attorney.

Several factors should be considered in looking at these tables. First, approved panel members receive more assignments than non-approved panel members do. Some of the attorneys with a low number of assignments are non-approved panel members. Most often, such an attorney is court assigned. Secondly, those attorneys gaining membership on a panel for the first time during 2022 will have fewer assignments in that panel because they were not on the panel for an entire year. Thirdly, a number of attorneys decline a significant number of assignments, requested removal from the Program for periods of time or resigned from the Program during 2022. While the report includes non-approved attorneys, new panel members, attorneys declining appointments, and attorneys temporarily removed from panels at their own request, concentrating on those members who participated for the full year as approved members of a particular panel gives a truer picture of the equitable distribution of assignments.

Of particular significance in this report is the fact that in the criminal courts, where the Assigned Counsel Program assigns a large percentage of cases, there is a more even distribution of assignments. This is attributable to the fact that, by comparison, Family Court has a much lower percentage of cases assigned by the Assigned Counsel Program: most assignments are directed by the court. Attaining more equitable distribution of cases is difficult, if not impossible. The Administrator and Advisory Committee must work

diligently to provide a workable solution to the inequities of the Family Court assignments. Looking at the last column of the tables, it takes significantly fewer attorneys for the Family Court assignments to reach a high percentage than it does for the criminal court assignments. This is less of a concern since the Conflict Defender Office represents the bulk of the conflict cases in Family Court. Nonetheless, it is an issue that should be addressed for those cases where the Conflict Defender Office cannot represent the client in Family Court.

The table below shows the number of assignments for each Judge making at least one assignment during 2022. The statistics, between this chart and the attorney assignments, clearly show that Rochester City Court, which assigns the greatest number of cases in the County, is very high in percentage of cases assigned through the Assigned Counsel Program. These facts directly correlate to the fact that the distribution of cases among the attorneys is greatest for criminal cases. Conversely, the statistics show that Family Court has a much lower percentage of cases assigned through the Assigned Counsel Program when removing those cases assigned to the Conflict Defender Office. There has been some progress in Family Court toward the increased use of the Assigned Counsel Program.
