Introduction

This was a momentous year in public defense in Monroe County. Three major changes took place during this year. First, the Assigned Counsel Program and Conflict Defender's Office became separate entities. Second, the rate of pay for assigned attorneys increased with the passage of New York State's 2023-2024 budget. Third, the Assigned Counsel Program hired an attorney dedicated to enhancing quality representation provided by assigned counsel panel attorneys.

The Monroe County Assigned Counsel Program marked its thirty-second year of operation in all courts within Monroe County. It was also the twenty-first year of operation for the Conflict Defender's Office. Since the inception of the Conflict Defender's Office more than twenty years ago, the Conflict Defender's Office and Assigned Counsel Program have been a joint office under the same leadership, the Conflict Defender. At the beginning of 2022, Mark D. Funk, Esq. held the position of Conflict Defender. On July 10, 2023, Sarah S. Holt, Esq. was named Monroe County Conflict Defender, while Mark D. Funk, Esq. assumed the title of Assigned Counsel Administrator. Ms. Holt's appointment as Conflict Defender marked the official separation of the two offices into separate entities.

With the offices becoming separate entities, new staff positions needed to be created and filled. When the offices were combined, a number of support staff members performed tasks associated with both parts of the office. As this was no longer possible, new staff were required to be hired. A great deal of planning and coordination was required to evaluate the staffing needs to both the Conflict Defender's Office and Assigned Counsel Program and evaluate the current staff to determine which staff members should be in which office. Support staff members (clerks, paralegals and other administrative staff), with their input, were assigned to one office or the other. Where gaps in service would be created in one office due to the assignment of a staff member to the other office a new positions was created to fill those gaps.

It was determined that Mark D. Funk, Esq. would leave the title of Conflict Defender and become the Assigned Counsel Administrator. Thus, the position of Conflict Defender would need to be filled. After an extensive search process which included the Monroe County Bar Association, the County Executive and the County Legislature, Sarah S. Holt, Esq. was named the Conflict Defender.

All attorney position except for the Assigned Counsel Administrator position and a new position of Resource Attorney would remain with the Conflict Defender's Office.

The positions of Assigned Counsel Administrator and Resource Attorney would be part of the new Assigned Counsel Program.

As of July 10, 2023 when the offices officially split into separate entities, the Assigned Counsel Program staff was comprised of seven staff members: Assigned Counsel Administrator, Resource Attorney, Project Manager, Clerk 1, Clerk 2, Clerk 3 and Special Urban Investigative Assistant (paralegal). All Assigned Counsel Program staff members are paid through New York State grants, not County funds.

The Monroe County Assigned Counsel Program is governed by the joint Monroe County/Monroe County Bar Association Plan for Conflict Assignments adopted in 2003. The Assigned Counsel Program currently has attorneys on eight (8) panels. The current panels that make up the Assigned Counsel Program are the Homicide/Predatory Sexual Offense Panel, the ABC Felony Panel, the DE Felony Panel, the misdemeanor criminal panel, the Raise the Age (Youth Part) Panel, the Probation/Parole Violation Panel, the Family Court Panel and the Appellate Panel. Attorneys on the assigned counsel panels are attorneys in private practice willing to represent indigent clients. An attorney's membership on each panel depends on the complexity of the case and the training, experience and expertise of the attorney. Panel attorneys accept assignments in all courts in Monroe County: all town and village courts, all felony cases, Family Court cases, all statutorily assigned cases in Surrogate and Superior Court as well as all cases where both the Conflict Defender Office and Public Defender's Office has a conflict of interest. In 2023, **149** private attorneys accepted approximately **3,175** assignments.

There was a marked increase in the number of attorneys who accepted assignments this year as opposed to 2022 (149 this year and 130 last year). As part of the New York State budget that was passed in 2023, the assigned counsel rates, set by state statute, was raised for the first time since January 1, 2004. The statutory amendment set the new rate at \$158/hour for all matters. Previously, the rates set in County Law § 722-b were \$60/hour for misdemeanor cases and \$75/hour for felonies, Family Court and appellate matters. The new rates, became effective on April 1, 2023. Also of note, is that New York State has agreed to reimburse Monroe County for 50% of the increased fee.

The increase in rates did not create an influx of trial attorneys willing to join the criminal and Family Court panels, however. The increase in the number of attorneys who accepted assignments in 2023 was mostly due a number of new attorneys on the Appellate panel.

The Assigned Counsel Program did see an influx of attorneys on the Appellate panel. This was not due to the increase in assigned counsel rates however. There has

become a scarcity of attorneys in Monroe County who were willing and able to accept appellate assignments. The Assigned Counsel Program was required therefore to widen its pool of appellate attorneys. In the past, the Assigned Counsel Program attempted whenever feasible to assign appeals to attorneys who live or work in Monroe County. Over the last few years, due to natural attrition (deaths, retirements, new employment) we have lost a number of appellate attorneys including most of the appellate practitioners who work or reside in Monroe County. The Assigned Counsel Program's Appellate Panel is a joint panel with the Appellate Division, Fourth Department, meaning attorneys assigned to appeals of Monroe County cases must be approved by both the Assigned Counsel Program and the Fourth Department, and complete the Fourth Department's specialized training program. The Fourth Department keeps a list of attorneys who have completed the training and are willing to accept assignments. The attorneys on the Fourth Department's list are from all parts of New York State. The Court shared their list with the Assigned Counsel Program and we began actively soliciting attorneys from around New York State to accept assignments of cases on appeal to the Appellate Division, Fourth Department.

The remainder of this report outlines, with statistical information, the Program's success in meeting the goals of the Plan which are articulated here:

"The objectives of this conflict assignments plan are to provide quality representation to eligible indigent defendants or other litigants in those cases where the Public Defender has a conflict of interest; to provide a coordinated and centralized assignment system for conflict cases arising in the courts specified in Article IV herein; to provide a more equitable distribution of conflict assignments among lawyers; to attract more lawyers willing to handle conflict assignments; to maintain uniform and proper billing practices; to ensure cost accountability of services, and to provide increased efficiency for the courts by making qualified attorneys more readily available to handle conflict cases." *Monroe County Bar Association Sponsored Plan for Conflict Assignments*,
ARTICLE II. Plan Objectives

"To Provide Quality Representation"

In 2023, the total number of case referrals (see page 9-10) was at 6,969 (combined numbers for the Conflict Defender's Office and Assigned Counsel Program. This number was similar to 2022 (6,900) and up from the Covid years of 2020 and 2021 (two year average of 6,164), but still below the pre-pandemic era as from 2017-2019, the total number of cases was steady at approximately 8,500 each year.

Looking at the Assigned Counsel Program exclusively, the number of assignments in 2023 was also quite similar to 2022 in total and in each category. In 2022, the yearly total of assignments was 3,300, while in 2023 the total was 3,402. There was a notable decrease in Homicide case assignments from 48 in 2022 to 23 in 2023.

All Assigned Counsel panel attorneys have qualified for their respective panels under the enhanced requirements for panel membership that were implemented in 2014 by then-Conflict Defender Charles Noce, Esq. These panel requirements remain in effect in an ongoing effort to continue to maintain and enhance the quality of representation that indigent clients in Monroe County receive.

As the year 2023 began, we hired D. Scott Young, Esq. as the Assigned Counsel Program's first Resource Attorney. This was a new position created with New York State grant funds. Mr. Young has more than thirty years of criminal defense experience and has handled notable cases including earning an acquittal in the Boys & Girls Club murder case. As this was a brand-new position, there was not a template as to how this position should operate. In consultation with the Assigned Counsel Administrator, panel attorneys, judges and others, Mr. Young created this position with the goal of improving the quality of representation that our assigned counsel panel attorneys provide to their clients. Mr. Young will observe attorneys in court and provide feedback to the attorneys. He is available to answer questions and assist attorneys with legal research. He is assembling a data base of experts and other resources that are available to our panel attorneys.

As the Continuing Legal Education (CLE) requirements of all staff attorneys of the Conflict Defender Office and panel attorneys for the Assigned Counsel Program overlap with the Mandatory Continuing Legal Education requirements of the State of New York, compliance is 100%.

However, it is a goal of the Assigned Counsel Program, in conjunction with the appropriate committees of the Monroe County Bar Association, to create more opportunities for training of attorneys.

"To Provide a Coordinated and Centralized Assignment System for Conflict Cases"

The Assigned Counsel Program is fully computerized, and has been through a number of electronic transformations. The initial computer program (2003-2010) entered all cases reported in it to a centralized database that tracked the representation from assignment through payment of the voucher for all cases; both Assigned Counsel and Conflict Defender cases. At the end of calendar year 2011, a new database was purchased for use by the office, and the underlying support system needed for the use of the prior ACP Database was discontinued. This system was in operation from approximately 2011-until August 2016. In August 2016, a new electronic voucher system and overall conflict case assignment database became operational. This current system is essentially paper-less with vouchers being sent to the courts for review electronically. This has resulted in a savings on time and effort, as well as an improvement on efficiency.

Assignments referred by the courts continue to be assigned from a rotating list of qualified attorneys who meet the requirements to be on the varying panels. The program, when used by the Courts, is very successful in ensuring continuity of counsel where a client has additional matters pending in Family Court or is re-arrested on new charges, even when the arrests span differing jurisdictions. Additionally, the program continues to track conflict of interest information so that panel attorneys are not unnecessarily assigned when the Public Defender's Office or Conflict Defender Office could ethically continue.

"To Provide a More Equitable Distribution of Conflict Assignments Among Lawyers"

The Assigned Counsel Program continually strives to improve its system of assignment of conflict cases. The Program constantly attempts to implement new and better systems to distribute assignments more equitably among the participating attorneys.

In criminal cases, the current system is highly effective when fully utilized by the Courts of Monroe County. Only 16% of criminal court assignments came from the bench, the vast majority were through the staff of the Assigned Counsel Program. This percentage remained unchanged from 2022. In Family Court, on the other hand, the equitable distribution of cases remains an issue, as 46% of assignments to panel attorneys in Family Court are still made directly from the bench. This was a slight decrease from

approximately 50% in 2022. It remains a goal of the Assigned Counsel Program to address the inequities in Family Court assignments. The fact that a few attorneys receive the bulk of the assignments places an undue burden on those attorneys and can impact directly on the quality of representation. A number of attorneys who have received a high percentage of assignments in Family Court have complained of burnout and have limited or stopped taking assignments.

"To Attract More Lawyers Willing to Handle Conflict Assignments"

Included in this report (see page 8) is a list of new panel members added during the 2023 calendar year.

These attorneys were added to the panels under the requirements for panel membership that were implemented in 2014 by then-Conflict Defender Charles Noce, Esq. These panel requirements were created and remain in effect in an ongoing effort to continue to enhance the quality of representation that indigent clients in Monroe County receive.

As explained above, the majority of new attorneys on the panels were added to the Appellate Panel. A concerted recruitment effort was undertaken to add new attorneys to the Appellate Panel.

"To Maintain Uniform and Proper Billing Practices and to Ensure Cost Accountability of Services"

As was the case in previous years, the Assigned Counsel Administrator reviews each voucher to ensure compliance with the voucher regulations and notifies each attorney of any noncompliance to educate the attorney on proper procedures. The review and notification help maintain proper and uniform billing practices among the participating attorneys.

Further, in October 2023, the Assigned Counsel Program held its first annual meeting, mandatory for all panel attorneys. A number of topics were discussed in the meeting. But, a primary focus was on billing expectations.

Having received a Grant from the New York State Office of Indigent Legal Services to fund the purchase of an electronic vouchering system, the system became operational

in August 2016. The use of the electronic voucher system has significantly increased the efficiency and accuracy of reviewing vouchers. This current system is essentially paperless with vouchers being sent to the courts for review electronically. This has resulted in a savings on time and effort, as well as an improvement on efficiency.

"To Provide Increased Efficiency for the Courts"

The Courts that fully utilize the services of the Assigned Counsel Program report a positive impact on the efficiency in obtaining assigned counsel in conflict cases. These Courts report a significant decrease in the burden on the court staff in finding attorneys willing to accept assignments and a prompt response from the Assigned Counsel Program in obtaining assigned counsel.

The electronic voucher system has increased the efficiency in voucher processing. Panel attorneys can access the system from any computer or smart phone with a login username and password. This system requires timely filing of vouchers by assigned counsel. The system allows for ease of review by the Assigned Counsel Administrator. Furthermore, as the vouchers can be transmitted between the Assigned Counsel Program Office and the Courts electronically instead of through the mail, it cuts down on total processing time. Additionally, the system allows for County payment with minimal paperwork.

The efficiency of the Courts has clearly been facilitated by the dedicated attorneys serving on the assigned counsel panels, and the staff attorneys in the Office of the Assigned Counsel Program, while ensuring high quality representation in Family Court, all of the criminal and appellate courts in 2023.

2023 Assignments

The following charts show the assignments each attorney received in 2023. The number of assignments is higher than the number of cases referred because in some cases more than one attorney receives an assignment for a case. Also, an attorney might be assigned in 2023 to a case originally referred in a previous year. This occurs most often after a court relieves one attorney and either the court or the Assigned Counsel Program assigns a new attorney.

Several factors should be considered in looking at these tables. First, approved panel members receive more assignments than non-approved panel members do. Some of the attorneys with a low number of assignments are non-approved panel members. Most often, such an attorney is court (bench) assigned. Secondly, those attorneys gaining membership on a panel for the first time during 2023 will have fewer assignments in that panel because they were not on the panel for an entire year. Thirdly, a number of attorneys decline a significant number of assignments, requested removal from the Program for periods of time or resigned from the Program during 2023. While the report includes non-approved attorneys, new panel members, attorneys declining appointments, and attorneys temporarily removed from panels at their own request, concentrating on those members who participated for the full year as approved members of a particular panel gives a truer picture of the equitable distribution of assignments.

Of particular significance in this report is the fact that in the criminal courts, where the Assigned Counsel Program assigns a large percentage of cases, there is a more even distribution of assignments. This is attributable to the fact that, by comparison, Family Court has a much lower percentage of cases assigned by the Assigned Counsel Program: most assignments are directed by the court. Attaining more equitable distribution of cases is difficult, if not impossible. The Administrator and Advisory Committee must work diligently to provide a workable solution to the inequities of the Family Court assignments. Looking at the last column of the tables, it takes significantly fewer attorneys for the Family Court assignments to reach a high percentage than it does for the criminal court assignments. This is less of a concern since the Conflict Defender Office represents the bulk of the conflict

cases in Family Court. Nonetheless, it is an issue that should be addressed for those cases where the Conflict Defender Office cannot represent the client in Family Court.

The table below shows the number of assignments for each Judge making at least one assignment during 2022. The statistics, between this chart and the attorney assignments, clearly show that Rochester City Court, which assigns the greatest number of cases in the County, is very high in percentage of cases assigned through the Assigned Counsel Program. These facts directly correlate to the fact that the distribution of cases among the attorneys is greatest for criminal cases. Conversely, the statistics show that Family Court has a much lower percentage of cases assigned through the Assigned Counsel Program when removing those cases assigned to the Conflict Defender Office. There has been some progress in Family Court toward the increased use of the Assigned Counsel Program.
