Introduction

The Monroe County Assigned Counsel Program is governed by the joint Monroe County/Monroe County Bar Association Plan for Conflict Assignments adopted in 2003. The “Bar Plan” is in the process of being revised, but as of the end of 2024 it was still in effect as the new plan had not received all of the required State, County and Monroe County Bar Association approvals.

In 2024, the Monroe County Assigned Counsel Program marked its thirty-third year of operation in all courts within Monroe County. From 2003 to 2023, the Assigned Counsel Program was combined with the Conflict Defender’s Office. The joint office was under the same leadership, the Conflict Defender, who fulfilled the roles of both Conflict Defender and Assigned Counsel Administrator. From October 31, 2016 until July 10, 2023, Mark D. Funk, Esq. held the position of Conflict Defender. On July 10, 2023, Sarah S. Holt, Esq. was named Monroe County Conflict Defender; Mark D. Funk, Esq. assumed the title of Assigned Counsel Administrator. Ms. Holt’s appointment as Conflict Defender marked the official separation of the two offices into separate entities.

As of July 10, 2023 when the offices officially split into separate entities, the Assigned Counsel Program staff was comprised of seven staff members: Assigned Counsel Administrator, Resource Attorney, Project Manager, Clerk 1, Clerk 2, Clerk 3 and Special Urban Investigative Assistant (paralegal). There has been no staff turn-over since then. All of our seven positions remain filled and occupied by the same individuals who held the position upon the split of the offices in July 2023. All Assigned Counsel Program staff members are paid through New York State grants, not County funds.

As of July 10, 2023, with Mr. Funk no longer wearing both the Conflict Defender and Assigned Counsel Administrator hats, he could focus exclusively on improving the Assigned Counsel Program and the quality of representation that the Program’s assigned counsel panel attorneys provide to their clients. 2024 marked the first full year of the Assigned Counsel Administrator acting solely in that role without the added responsibilities of overseeing the Conflict Defender’s Office.

The transformation of the Assigned Counsel Program began in 2023 with such basic things such as a brand-new Assigned Counsel Program logo. The transformation is also reflected in the fact that at the end of March 2024 the Program moved into new office space on the Eighth Floor of the City Place building. The new space is more conducive to assisting panel attorneys. The office space has meeting rooms where panel attorneys can meet with their clients. The space also has workspaces available for

panel attorneys, particularly those with offices that are not downtown, to do work between court appearances.

The Assigned Counsel Program has been able to utilize New York State grant funds to expand the services that we provide to our panel attorneys. Most important of these new initiatives has been the hiring of D. Scott Young, Esq. at the beginning of 2023, in the position of Resource Attorney. Mr. Young has more than thirty years of criminal defense experience and has handled notable cases including earning an acquittal in the Boys & Girls Club murder case. As this was a brand-new position, there was not a template as to how this position should operate. In consultation with the Assigned Counsel Administrator, panel attorneys, judges and others, Mr. Young created this position with the goal of improving the quality of representation that our assigned counsel panel attorneys provide to their clients. Among the activities that Mr. Young engages in to improve quality representation are the following: Mr. Young observes attorneys in court and provide feedback to the attorneys. He is available to answer questions and assist attorneys with legal research. He is assembling a data base of experts and other resources that are available to our panel attorneys. In 2024, Mr. Young began writing a monthly topical newsletter as well as a newsletter highlighting recent appellate cases of interest.

With the hiring of Mr. Young, we added a feature to the Program where attorneys can meet with the Resource Attorney and Assigned Counsel Administrator to conference (or “pod”) cases. This has typically been a discussion with an attorney in preparation for trial. However, case conferences have been held in cases to discuss how to handle plea negotiations, suppression issues, advice on dealing with difficult clients or issues of a sensitive nature. Anecdotally, we estimate that these case conferences have been quite successful with a number of quality outcomes in cases including a number of jury trial acquittals.

In 2024, the Assigned Counsel Program began offering panel attorneys free Westlaw, a legal research program. And, as some resources are still not available online, we have begun acquiring books and other resources essential to practicing criminal defense attorneys and Family Court practitioners.

The Assigned Counsel Program has continued its “Second Chair Program” where two attorneys are assigned to a defendant charged with an A-level felony (thus facing a potential life sentence) or in a case where a death is involved. This has been a very successful program. Lead Counsel is always a member of our Homicide/Predatory Sexual Offense Panel, made up of our most experienced attorneys. In high-profile or complex cases, we can assign two experienced attorneys to the case. On other cases, we can appoint a less experienced attorney as Second Chair to work with the Lead Counsel, who is a more experienced attorney. This allows less experienced attorneys to gain

valuable experience. The Second Chair attorney's voucher is paid with New York State grant funds.

The Assigned Counsel Program has been emphasizing with our panel attorneys that they should use experts and other support services. In 2024, our panel attorneys utilized the services of a number of specialized experts including mental health experts, computer and technology forensic experts, ballistics experts, sentencing advocates and DNA experts. More education of our panel attorneys is necessary to get them to use experts more frequently.

The use of private investigators has increased. We have paralegal and social work support available to our panel attorneys. This has not become as prevalent as the use of investigators. Like experts, more education is necessary for the panel to understand that these services are available to them. We have particularly tried to emphasize the use of interpreting services including a service called Propio, where a live interpreter can be accessed over a table, phone or computer.

The Assigned Counsel Program currently has attorneys on eight (8) panels. The current panels that make up the Assigned Counsel Program are the Homicide/Predatory Sexual Offense Panel, the ABC Felony Panel, the DE Felony Panel, the misdemeanor criminal panel, the Raise the Age (Youth Part) Panel, the Probation/Parole Violation Panel, the Family Court Panel and the Appellate Panel. Attorneys on the assigned counsel panels are attorneys in private practice willing to represent indigent clients. An attorney's membership on each panel depends on the complexity of the case and the training, experience and expertise of the attorney. Panel attorneys accept assignments in all courts in Monroe County: all town and village courts, all felony cases, Family Court cases, all statutorily assigned cases in Surrogate and Superior Court as well as all cases where both the Conflict Defender Office and Public Defender's Office has a conflict of interest. In 2024, **159** private attorneys accepted approximately **3,983** assignments.

There was a increase in the number of attorneys who accepted assignments this year; we had 159 attorneys accept assignments in 2024. We had 149 in 2023 and 130 in 2022. The trend is moving upward and hopefully will continue. The increase in the number of attorneys accepting assignments has gone up due to two reasons. First, the assigned counsel rates, the rate that we pay attorneys, increased effective April 1, 2023 to \$158/hour for all matters.

Second, the Assigned Counsel Program has made a concerted effort to recruit more attorneys to the Appellate Panel. The Appellate Panel is created through a joint effort with the Appellate Division, Fourth Department. To be on the Appellate Panel, an attorney must be approved by both the Assigned Counsel Program and the Fourth Department, and complete the Fourth Department's specialized training program. The Fourth Department keeps a list of attorneys who have completed the training and are

willing to accept assignments. The attorneys on the Fourth Department's list are from all parts of New York State. The Court shared their list with the Assigned Counsel Program and we began actively soliciting attorneys from around New York State to accept assignments of cases on appeal to the Appellate Division, Fourth Department.

The number of assignments in criminal matters was quite similar to 2023, with each category only showing a slight increase from the year before. For example, misdemeanor assignments went from 1,005 in 202 to 1,028 in 2024. The most notable area was Family Court where case assignments went from 1,005 in 2023 to 1,360 in 2024.

The overall cost of paying assigned counsel panel attorneys went up this year. This was expected as 2024 was the first full year of the new State rate that went into effect partway through 2023. Also, the average voucher went up. Again, this was to be expected due to the increased rate. Further, due to more cases having electronic evidence such as videos and body camera footage, attorneys are required to spend more time preparing for their cases.

The remainder of this report outlines, with statistical information, the Program's success in meeting the goals of the Plan which are articulated here:

"The objectives of this conflict assignments plan are to provide quality representation to eligible indigent defendants or other litigants in those cases where the Public Defender has a conflict of interest; to provide a coordinated and centralized assignment system for conflict cases arising in the courts specified in Article IV herein; to provide a more equitable distribution of conflict assignments among lawyers; to attract more lawyers willing to handle conflict assignments; to maintain uniform and proper billing practices; to ensure cost accountability of services, and to provide increased efficiency for the courts by making qualified attorneys more readily available to handle conflict cases." *Monroe County Bar Association Sponsored Plan for Conflict Assignments*, ARTICLE II. Plan Objectives

"To Provide Quality Representation"

All Assigned Counsel panel attorneys have qualified for their respective panels under the enhanced requirements for panel membership that were implemented in 2014 by then-Conflict Defender Charles Noce, Esq. These panel requirements remain in effect in an ongoing effort to continue to maintain and enhance the quality of representation that indigent clients in Monroe County receive.

As noted in detail above, the Assigned Counsel Program has implemented a number of new programs and initiatives in the last two years designed to improve the quality of representation that our panel attorneys provide to their clients.

As the Continuing Legal Education (CLE) requirements of all staff attorneys of the Conflict Defender Office and panel attorneys for the Assigned Counsel Program overlap with the Mandatory Continuing Legal Education requirements of the State of New York, compliance is 100%.

However, it is a goal of the Assigned Counsel Program, in conjunction with the appropriate committees of the Monroe County Bar Association, to create more opportunities for training of attorneys.

"To Provide a Coordinated and Centralized Assignment System for Conflict Cases"

The Assigned Counsel Program is fully computerized, and has been through a number of electronic transformations. The initial computer program (2003-2010) entered all cases reported in it to a centralized database that tracked the representation from assignment through payment of the voucher for all cases; both Assigned Counsel and Conflict Defender cases. At the end of calendar year 2011, a new database was purchased for use by the office, and the underlying support system needed for the use of the prior ACP Database was discontinued. This system was in operation from approximately 2011-until August 2016. In August 2016, a new electronic voucher system and overall conflict case assignment database became operational. This current system is essentially paper-less with vouchers being sent to the courts for review electronically. This has resulted in a savings on time and effort, as well as an improvement on efficiency.

Assignments referred by the courts continue to be assigned from a rotating list of qualified attorneys who meet the requirements to be on the varying panels. The program, when used by the Courts, is very successful in ensuring continuity of counsel where a client has additional matters pending in Family Court or is re-arrested on new charges, even when the arrests span differing jurisdictions. Additionally, the program continues to track conflict of interest information so that panel attorneys are not unnecessarily

assigned when the Public Defender's Office or Conflict Defender Office could ethically continue.

"To Provide a More Equitable Distribution of Conflict Assignments Among Lawyers"

The Assigned Counsel Program continually strives to improve its system of assignment of conflict cases. The Program constantly attempts to implement new and better systems to distribute assignments more equitably among the participating attorneys.

In criminal cases, the current system is highly effective when fully utilized by the Courts of Monroe County. There was a significant jump in the amount of cases being assigned by the Court from the bench. Over the last two years, about 16% of criminal court assignments came from the bench. In 2024, that amount jumped to 31%.

Historically, in Family Court, the majority of cases have been bench assigned. The percentage of cases being assigned from the bench is trending downward. In 2022, approximately 50% of cases were assigned from the bench. In 2023, it was about 46%. This trend has continued in 2024 with 43% of cases being bench assigned.

It remains a goal of the Assigned Counsel Program to address the inequities in assignments. The fact that a few attorneys receive the bulk of the assignments places an undue burden on those attorneys and can impact directly on the quality of representation. A number of attorneys who have receive a high percentage of assignments in Family Court have complained of burnout and have limited or stopped taking assignments.

"To Attract More Lawyers Willing to Handle Conflict Assignments"

Included in this report (see page 10) is a list of new panel members added during the 2024 calendar year.

These attorneys were added to the panels under the requirements for panel membership that were implemented in 2014 by then-Conflict Defender Charles Noce, Esq. These panel requirements were created and remain in effect in an ongoing effort to continue to enhance the quality of representation that indigent clients in Monroe County receive.

A number of new attorneys were added to the Appellate Panel and the Family Court Panel.

"To Maintain Uniform and Proper Billing Practices and to Ensure Cost Accountability of Services"

As was the case in previous years, the Assigned Counsel Administrator reviews each voucher to ensure compliance with the voucher regulations and notifies each attorney of any noncompliance to educate the attorney on proper procedures. The review and notification help maintain proper and uniform billing practices among the participating attorneys.

Having received a Grant from the New York State Office of Indigent Legal Services to fund the purchase of an electronic vouchering system, the system became operational in August 2016. The use of the electronic voucher system has significantly increased the efficiency and accuracy of reviewing vouchers. This current system is essentially paperless with vouchers being sent to the courts for review electronically. This has resulted in a savings on time and effort, as well as an improvement on efficiency.

"To Provide Increased Efficiency for the Courts"

The Courts that fully utilize the services of the Assigned Counsel Program report a positive impact on the efficiency in obtaining assigned counsel in conflict cases. These Courts report a significant decrease in the burden on the court staff in finding attorneys willing to accept assignments and a prompt response from the Assigned Counsel Program in obtaining assigned counsel.

The electronic voucher system has increased the efficiency in voucher processing. Panel attorneys can access the system from any computer or smart phone with a login username and password. This system requires timely filing of vouchers by assigned counsel. The system allows for ease of review by the Assigned Counsel Administrator. Furthermore, as the vouchers can be transmitted between the Assigned Counsel Program Office and the Courts electronically instead of through the mail, it cuts down on total processing time. Additionally, the system allows for County payment with minimal paperwork.

The efficiency of the Courts has clearly been facilitated by the dedicated attorneys serving on the assigned counsel panels, and the staff attorneys in the Office of the Assigned Counsel Program, while ensuring high quality representation in Family Court, all of the criminal and appellate courts in 2024.

The following charts show the assignments each attorney received in 2024. The number of assignments is higher than the number of cases referred because in some cases more than one attorney receives an assignment for a case. Also, an attorney might be assigned in 2024 to a case originally referred in a previous year. This occurs most often after a court relieves one attorney and either the court or the Assigned Counsel Program assigns a new attorney.

Several factors should be considered in looking at these tables. First, approved panel members receive more assignments than non-approved panel members do. Some of the attorneys with a low number of assignments are non-approved panel members. Most often, such an attorney is court assigned. Secondly, those attorneys gaining membership on a panel for the first time during 2024 will have fewer assignments in that panel because they were not on the panel for an entire year. Thirdly, a number of attorneys decline a significant number of assignments, requested removal from the Program for periods of time or resigned from the Program during 2024. While the report includes non-approved attorneys, new panel members, attorneys declining appointments, and attorneys temporarily removed from panels at their own request, concentrating on those members who participated for the full year as approved members of a particular panel gives a truer picture of the equitable distribution of assignments.

The 2024 numbers are for the Assigned Counsel Program only. Prior years reflect the number of cases for Assigned Counsel and the Conflict Defenders Office as the two offices were combined until July 10, 2023.

Of particular significance in this report is the fact that in the criminal courts, where the Assigned Counsel Program assigns a large percentage of cases, there is a more even distribution of assignments. This is attributable to the fact that, by comparison, Family

Court has a much lower percentage of cases assigned by the Assigned Counsel Program: most assignments are directed by the court. Attaining more equitable distribution of cases is difficult, if not impossible. The Administrator and Advisory Committee must work diligently to provide a workable solution to the inequities of the Family Court assignments. Looking at the last column of the tables, it takes significantly fewer attorneys for the Family Court assignments to reach a high percentage than it does for the criminal court assignments. This is less of a concern since the Conflict Defender Office represents the bulk of the conflict cases in Family Court. Nonetheless, it is an issue that should be addressed for those cases where the Conflict Defender Office cannot represent the client in Family Court.

The statistics, between this chart and the attorney assignments, clearly show that Rochester City Court, which assigns the greatest number of cases in the County, is very high in percentage of cases assigned through the Assigned Counsel Program. These facts directly correlate to the fact that the distribution of cases among the attorneys is greatest for criminal cases. There has been some progress in Family Court toward the increased use of the Assigned Counsel Program.
