Help Voters In Our Community

By Federal Law, polling sites across New York State are required to post sample ballots and all other informational materials in Spanish when five (5) percent of the residents in an Election District are Spanish speaking.

Those election districts will be assigned a
Spanish speaking Interpreter whose
responsibility is to assist non-English
speaking voters by translating voting
information given by the Poll Workers. The
Interpreter may also assist non-English and
limited-English speaking voters in voting
booths and is trained to work
with and assist the Poll Worker team on
Election Day.

Interpreters are paid \$12.00 an hour.

Paychecks are mailed four (4) weeks after the date you worked an election. You must have reliable transportation. We do not pay for mileage.

Once you have been assigned to a polling site, it is your responsibility to be present at the site. It is your responsibility to call immediately (585) 753-1530 if you cannot work on Election Day. You must call so we have enough time to find a substitute interpreter to work for you. Applicant will receive by MAIL a notice with an assignment 2 weeks before Election Day.
