

Away temporarily?

Make sure you change only your mailing address, and not your residence address when filling out forwarding paperwork with the DMV or Post Office. That will make it less likely the Board of Elections will be incorrectly notified you have moved.

FAST FACT

In most cases, people have a choice to vote from any one of their legal residences, including students when they go to college, even if it is outside of New York State. However, it is illegal to vote more than once in any election so register accordingly.

Need to cancel a registration?

Inform the Board of Elections if you move out of the County or if a family member passes away so we can send you a voter removal request form to be signed and returned to us. We require an official notification to remove someone from the voter rolls.

NY State Dept. of Health provides notifications of death to the Board of Elections, but not always in time for the next election, and if someone passes away in another state, we will not be notified.

FAST FACT

Want to vote in the Presidential Primary next year?

In New York State, we have "closed primaries" meaning you can only vote in a primary election if you are a member of that political party (i.e. only Democrats can vote in a Democratic primary, only Republicans can vote in a Republican primary, etc.).

FAST FACT

Registering to a political party does NOT affect whom you choose to vote for in the November General Election, you can still vote for anyone you want, even if they are a different political party than you.

Need an Absentee Ballot?

You can request an **Absentee Ballot** for one of the following reasons:

- absence from the county on Election Day
- temporary illness or physical disability
- permanent illness or physical disability
- duties related to primary care of one or more individuals who are ill or physically disabled
- resident or patient of a Veterans Health Administration Hospital
- detention in jail/prison, awaiting trial, awaiting action by a grand jury, or in prison for a conviction of a crime or offense which was not a felony

Due to a recent change in the law, voters who request an absentee ballot will not be allowed to vote in person on a voting machine. They may vote by affidavit ballot.

All verified absentee ballots received before Election Day will be counted along with Election Day and Early Voting tallies. The results will be posted after the polls close on Election Day.
