Primary Election 2025 Info

- In New York State, you must be enrolled in a party to be eligible to vote a **Primary Election**. The Primary this year is on **Tuesday, June 24, 2025**.
- Your enrolled party must have a primary race in your district (meaning more candidates running for the same office than seats available).
- **Early Voting** for the Primary Election takes place from **June 14 – June 22**. During Early Voting, voters can vote in person at ANY Polling Location across Monroe County (see full list of locations on the back).
- New Voter Registrations must be received by June 14, and address changes for currently registered voters must be received by June 9.
- Primary races can be very close and are generally lower turnout due to eligibility – more than ever, **YOUR VOTE MATTERS!**

Introducing New Voting Machines!



The Monroe County Board of Elections has purchased new voting technology from Election Systems & Software (ES&S). For the 2025 Primary Election, Monroe County voters will be using the state-of-the-art ExpressVote XL machines, which are designed to enhance voter accessibility, security, and efficiency.

The ExpressVote XL machines feature:

- ✓ **Voter-Verifiable Paper Records:** Each voter will see their printed ballot with the summary of their selections. This ensures accuracy and transparency. The printed ballots allow the Board of Elections to conduct post-election audits and recounts.
- ✓ **Enhanced Accessibility:** The machines accommodate all voters through touch screens, as well as optional audio interfaces and compatibility with assistive devices for independent voting.
- ✓ **Advanced Security Measures:** Rigorous security protocols protect against potential threats, ensuring election integrity.

The Board is hosting public demonstrations and training sessions leading up to the 2025 elections. We invite the public to attend these sessions and encourage continued voter participation and engagement.


Primary Election 2025 Early Voting Sites

Polling Hours: Sat, Sun, Mon, Wed, & Fri: 9am – 5pm; Tues & Thurs: 12 noon – 8pm

To qualify to be an Election Inspector, you must:

- ✓ Be a registered voter
- ✓ Have a working email and phone number
- ✓ Have reliable transportation to your assigned poll site
- ✓ Attend a paid Training session
- ✓ Pledge to assist all voters and uphold election law

Please note: a voter may not vote on a voting machine for any election in which they have properly requested an Absentee or Early Vote by Mail ballot. However, a voter may vote by Affidavit Ballot if they wish to vote in person at a polling site.
