## **Your Absentee Ballot is on the Way!**

### **Today was the Deadline for Applications**

ROCHESTER, New York – Today is the last day to submit an Absentee Application for the June 23, 2020 Elections. The Board has received an unprecedented volume of applications over the last 6 weeks. We have processed close to 60,000 applications and mailed out over 100,000 ballots.

This has created a large volume of mail for our post offices to deliver. If you have not received your ballot within 7 days of submitting your application, we want to encourage all voters to consider visiting at an early voting polling site.

The Board is asking each voter to be safe, wear a mask and practice social distancing while at all polling sites. Voters are also encouraged to use hand sanitizer when entering and exiting polling sites. Each voter will check in separately for the Presidential Primary, State/ Local Primary and Special Election- 27<sup>th</sup> Congressional District.

If you are not able to visit an early voting site and you have not received your absentee ballot, please go to an Election Day polling site to cast your ballot. A postcard was mailed to every eligible voter to identify their new location for Tuesday, June 23<sup>rd</sup>, the hours will be 6 am- 9 pm. If you did not receive the polling site postcard, please call our office at 585-753-1550 to confirm your new location. We want every voter to know you have options to ensure you are able to cast your vote.
