Our Mission:

The Office of the County Clerk provides access to vital government services and records to the residents of Monroe County. The Clerk's Office must follow all federal, state, and county laws, providing accurate and timely processing of transactions. We are also responsible for providing records to the public while adapting to new technology and the needs of the community by enhancing accessibility. The County Clerk's Office is also responsible for the preservation and integrity of our database systems. Our team is comprised of the Downtown Operations Division, located in the County Office Building, and the Auto License Bureau with four branches strategically located throughout the County.





Our Impact: Supporting Taxpayers

The Monroe County Clerk's Office is one of the only revenue generating entities in County Government that does not rely on the Property Tax Levy to fund our operations. Every year, we return our surplus revenue to the County's General Fund, an effort to help mitigate the burden on local taxpayers.

Annually, the Monroe County Clerk's Office generates between \$10 to \$11 million in revenue. *In 2020 despite the COVID-19 shutdowns, our office still returned \$1.9 million in revenues to the General Fund.*

Our ability to generate these revenues continues to be threatened by an outdated DMV revenue-sharing agreement and other stagnant State fees. Across New York State, county governments run the majority of DMVs, receiving only 12.75% of all the revenues generated on behalf of the State. For the sake of taxpayer equity we call on Governor Hochul and the State Legislature to renegotiate this 23-year old formula, allowing DMV revenues to grow with expenses.


Serving our Community - Who We Are

Auto License Bureau (Department of Motor Vehicles-DMV)

The Auto License Bureau has four branch offices: Henrietta, Greece, Irondequoit, and Downtown Rochester. Each office provides public counter service for license transactions, vehicle registrations, and other motor vehicle transactions primarily serving residents and commercial automobile dealer work throughout Monroe County.

Downtown Operations (Downtown Filing Office)

The Downtown Operations Division is responsible for the administration, recording, filing, and storing of official documents. This division's responsibilities include intake, indexing, preservation, and retrieval of official documents as required by law. Items processed, recorded, and filed by this section include mortgages, deeds, civil, criminal, and divorce actions. The County Clerk additionally acts as an agent for the state and federal government for issuance of passports, pistol permits, and conservation licenses. The County Clerk also administers the Oath of Allegiance at naturalization ceremonies for new citizens.




Our Impact: Committing to Diversity, Equity, and Inclusion

The Monroe County Clerk's Office continues to demonstrate our commitment to Diversity, Equity, and Inclusion with our investments to expand access to the services we provide in an equitable fashion while reviewing our own hiring practices.

As the first County entity to implement a Language Access Plan, the Monroe County Clerk's Office continues to lead the way with an expansion of ASL video interpreting services available at all four DMV locations and the Downtown Filing Office. In our lobbying efforts, the Monroe County Clerk's Office also continues to work to eliminate language barriers for residents, asking New York State DMV to provide more testing materials in additional languages, including Dari and Ukrainian.

The Monroe County Clerk's Office also leads as one of the County's most diverse teams, from the Administrative team on down. The County's DEI State of Diversity Report stated that "The County Clerk's Office has been a leader at Monroe County in the implementation of diverse and equitable hiring practices. The department has committed to creating an environment where people of marginalized backgrounds have access to development and opportunity. The department has implemented the first Language Access Plan at Monroe County and continues to educate staff on tools and resources for success. The County Clerk's Office also intentionally hires people with diverse abilities."

US Passport Outreach


After a brief pause due to the COVID-19 pandemic, the Monroe County Clerk's Office redeployed our mobile U.S. Passport services to help connect students and families with the application and renewal process. We were proud to work with R.I.T., Nazareth College, local school districts, and municipalities on many events in 2022. We are excited to expand these opportunities with new partnerships with the University of Rochester and SUNY Brockport in 2023!





Promoting Responsible Gun Ownership

Through a new partnership with the Monroe County Sheriff's Office and the UR Medicine Kessler Trauma Center, the Monroe County Clerk's Office began a new campaign to help empower new and existing pistol permit holders with information about responsible gun ownership and safety tips. With every new application and new firearm added to a permit, the County Clerk's Office has distributed thousands of flyers important statistics and tips, along with FAQ and contacts of local resources. In addition, the Monroe County Clerk's Office has distributed over 800 gun locks at our pistol permit counter.

Relocation of Henrietta DMV

For the first time in decades, one of the three main Monroe County DMVs was relocated to the Frontier Commons Plaza on Jefferson Road. This new and updated space was designed to provide a more welcoming, friendly environment for residents seeking out DMV services. In addition, an expanded lobby has allowed for the investment of additional permit testing stations.

Throughout 2022, all Monroe County DMVs continued to make the most of their close to 500,000 annual transactions by partnering with Monroe County STOP-DWI, New York Donate Life, and Monroe County's first ever PRIDE Committee to help share important information with every person who visited any one of our four locations.

Our Impact: A New Mission for Mobile DMVs

In 2020 the COVID-19 pandemic forced Monroe County's Mobile DMV units to be suspended, allowing for a thorough review of operations and opportunities.

After significant updates and improvements to technology, safety, and processes, the Monroe County Clerk's Office is excited to announce the re-deployment of Mobile DMVs to new locations and under a new mission: to bring DMV services to the underserved residents in Monroe County.

Redeploying Mobile DMVs

Mobile DMVs will continue to build strong relationships with local towns and villages to provide access to services in those municipalities outside of a 20-minute drive of one of our four local branches. We are excited to announce in 2023 our Mobile DMV unit will begin regular hours at the Village of Brockport and the Town of Ogden.

Jail ID Program

In November 2022, the Monroe County Clerk's Office and Monroe County Sheriff's Office were able to restart the successful Jail ID Program, an effort to help those currently incarcerated receive a state-issued ID before their release into the community. Access to a state-issued ID is a gateway to many services, and this program hopes to help those in reentry have the tools they need to succeed. **This program will continue in 2023.**

Project Homeless Connect

For individuals experiencing homelessness, the lack of a state-issued ID can become a significant barrier to accessing vital services. Working with members of the local nonprofit Project Homeless Connect, the **Monroe County Mobile DMVs will begin to hold regular hours at the Rundell Library in Downtown Rochester in 2023** to help issue Non-Driver IDs (NDID) and help set individuals on a path to obtain other documents needed to get a NDID.

Future Opportunities

The Monroe County Clerk's Office has made it a core mission to help every Monroe County resident access a state-issued ID, and use our office to help build bridges to fill the gaps when individuals fail to meet State and Federal regulations. This often will mean obtaining other government documents or forms of identification. Deputy County Clerk Tad Mack has been tasked with spearheading the County Clerk's Office's efforts, seeking out new opportunities and partnerships. Our Impact: Opportunities for 2023

The State of the County Clerk's Records

As the official registrar of deeds, mortgages, assignments of mortgages, satisfactions of mortgages, judgments, and liens; the Clerk of the Supreme and County Courts responsible for maintaining the court files for civil and criminal matters; Chief Notary of Monroe County; and administrator of the pistol permit process - the Monroe County Clerk's Office is the custodian of millions of official documents and records on behalf of all Monroe County residents.

Many of our records are currently stored and utilized in their original, physical format. Assistant Deputy County Clerk Jackie Consol has been tasked with overseeing the efforts to modernize the management, storage, and public access of our vast archive. Since 2020 the Monroe County Clerk's Office has been awarded \$219,990 in grants from the Local Government Records Management Improvement Fund Grant from the New York State Archives in pursuit of digitizing many of these records.





Veterans Discount Card & Outreach

In partnership with the Monroe County Office of Veteran Services and other local agencies, the Monroe County Clerk's Office will be redesigning and renewing the Veterans Discount Card, with hopes of increasing business participation and access to the program.

DBA/Small Business Outreach

The first step many take when starting a business is to file a DBA (Doing Business As) form with the Monroe County Clerk's Office. In 2023, through a new partnership with the Rochester Chamber of Commerce, Small Business Development Center, and the City of Rochester, the Clerk's Office plans to launch a new initiative to make the most of these opportunities, connecting entrepreneurs and small business owners with additional tools to help ensure the success of their dream and ambition.

Our Impact: 2023 Legislative Priorities & Advocacy

New York State Association of County Clerk's (NYSACC) Legislative Agenda

<u>Support Increasing the County Share of DMV Retention Revenues</u>

Fifty-one counties (including Monroe) act as the agent of the State in the operation of local DMV offices. These offices provide a majority of DMV services to residents, including all testing and commercial transactions to local car dealers. However, from **an agreement negotiated 23 years ago, Counties only retain 12.7% of the revenues** for all transactions processed within our offices, and 3.75% of all online transactions of County residents after the State has retained \$9,000,000 in revenue.

In the past 23 years, the cost of operations has grown significantly for Counties. This situation is not sustainable. In order for Monroe County to continue to provide DMV services on behalf of the State, there must be an increase in the revenue retention formula.

The Monroe County Clerk's Office echoes the NYSACC legislative priority for:

- an increase to 15% in the county share of Department of Motor Vehicle revenue retention (inoffice and internet revenue with no threshold imposed).
- to amend NY Tax Law 1132 (2)(g)(2), which has not been increased in over 50 years, to increase compensation to county clerks for collecting sales tax on motor vehicles.

Supporting Pistol Permit Recertification Continuity

Recertification was a process established under the SAFE Act where active permit holders are required to self-certify with the New York State Police (NYSP) that the information on their permits remained true. Currently, the new laws have established several different recertification processes for a singular permit:

- a Carry Concealed Pistol Permit is required to be recertified with NYSP every 3 years.
- a Possess on Premise or Possess During Employment Pistol Permit is required to be recertified with NYSP every 5 years.
- a Semi-Automatic Rifle Permit is required to be recertified by the local licensing officer (the issuing County Court Judge) every 5 years.

Semi-Automatic Rifle Permits are newly established permits that went into effect on September 4th 2022, that can be issued either as a stand-alone permit or as an endorsement onto a valid Carry Concealed, Possess on Premise, or Possess During Employment Pistol Permit. The current system will result in a single pistol permit potentially two different recertification schedules and two different agencies to report to.

The Monroe County Clerk's Office and NYSACC urge the State Legislature to streamline the pistol permit recertification process, at a minimum, to realign to a single reporting agency, the New York State Police. This will allow for greater compliance and better understanding for all current pistol permit holders and eliminate an unnecessary and undue burden on both pistol permit holders and local governments.

Our Impact: 2023 Legislative Priorities & Advocacy Cont'd

New York State Association of County Clerk's (NYSACC) Legislative Agenda

<u>Support Legislation Amending Article 81 of Mental Hygiene Law to Prevent the Disclosure of Personal Identifying Information</u>

The Monroe County Clerk's Office and NYSACC support legislation to impose greater safeguards on personal information. Article 81 of the Mental Hygiene Law, which also governs the proceedings under former Articles 77 and 78 of the same law, is available for public inspection. Unlike most court records, the files in these cases are replete with personal information.

NYSACC supports and encourages legislation amending §81.14 of the Mental Hygiene Law to limit disclosure of court records to the parties and their counsel, which would include the duly appointed guardians, the court evaluators, and court examiners. Such a restriction would be like that imposed in the case of matrimonial actions and will not impair the "interest of the public" or "the orderly and sound administration of justice."

Monroe County Clerk Legislative Priorities

Reducing Barriers to Accessing State-Issued IDs

One of the lessons we learned from the COVID-19 pandemic was the number of residents in our community who do not have any current form of state-issued ID, whether that be a Non-Drivers ID, Learners' Permit, or Driver's License. The Monroe County Clerk's Office remains in conversation with Project Homeless Connnect, the Monroe County Department of Human Services, the Probation Department, and many other local agencies and community groups to help us better identify and understand the current needs.

Currently, the point system required to issue a state-issued ID can become cumbersome for individuals struggling with poverty or lack of access to original documents. The Monroe County Clerk's Office encourages New York State DMV and the State Legislature to consider developing additional pathways for residents to obtain a state-issued ID, including but not limited to the expansion of the MV45b "Statement of Identity" currently available only for applicants who can be considered a disenfranchised, homeless youth. Finding additional opportunities to help residents meet the standards of the State's point system is essential to help all New Yorkers gain access to a state-issued ID.

Breaking Down Language Barriers to DMV Testing

In order to take a permit test for a passenger, motorcycle, or commercial learner's permit, the applicant must take the exam on a State-issued workstation. Currently, Monroe County DMVs can only provide these exams in 16 languages, including Arabic, Bengali, Bosnian and Nepali. The Monroe County Clerk's Office encourages New York State DMV and the State Legislature to take action to ensure more testing materials are provided in additional languages, specifically Ukrainian and Dari. Both these languages are common amongst a recent influx of refugees and immigrants from both Ukraine and Afghanistan whom are settling in many parts of New York State, including Monroe County.

Thank you for taking the time to review our first Annual Report to the Community. The accomplishments and vision of the Monroe County Clerk's Office would be nowhere without our amazing staff! To all 144 team members of the Monroe County Clerk's Office, we thank you for your continued dedication to service and purpose on behalf of a grateful community.
