County Clerk Online Records Subscriptions & Free Fraud Alerts

Start Wednesday, April 1st

March 30, 2026 (Rochester, NY) – Monroe County Clerk Jamie Romeo announced that the Office’s Online Records System, currently housed in the IQS Solutions Records Management System, will begin its subscription plan and policy on Wednesday, April 1st. Additionally, these system updates will provide for residents to sign-up for free Fraud Alerts from the same system.

“With the rise of AI technology and the unknown potential risk this can pose for data harvesting, implementing this subscription policy will not only provide an added layer of security for the documents and information our office is responsible for; but also provide a modest revenue source that will allow us to continue to invest in our operations.” Monroe County Clerk Jamie Romeo stated.

As County Registrar and Clerk of County and Supreme Courts, the Monroe County Clerk’s Office is responsible for the custody and maintenance of millions of public records. While the indexes of those records (standard information including party names, property address, etc.) will remain available for public search and review for free, the digital version of original documents will only be visible through the subscription service.

The Monroe County Clerk’s Office is also proud to follow the leadership of many Finger Lakes counties with the implementation of a free Fraud Alert service for their Online Records System. This will allow users who sign up to register specific names and/or properties to search for, and be notified when any recordings or filings are accepted by the Clerk’s Office under those names and/or properties. While the system does not outright prevent fraud, it will provide users with real-time notifications of these filings that, should a nefarious one be accepted, action can be taken swiftly.

“It is a difficult balance of maintaining transparency of public records with appropriate guardrails and protections for our residents. These new tools with our partners at Info Quick Solutions Inc., will provide both the Monroe County Clerk’s Office and our residents with the right set of tools in this endeavor.”
