I have met with members of our office, law enforcement partners, community leaders, and residents across Monroe County to better understand the needs, expectations, and challenges facing our justice system. Those conversations have been difficult and invaluable, and have reaffirmed the importance of collaboration, transparency, and trust.

In a short period of time, we have begun the important work of strengthening our office by reviewing operations, reinforcing professional standards, and ensuring our approach to justice is thoughtful, fair, and effective. I am encouraged by the dedication and professionalism of the men and women who serve this community every day, and by our shared commitment to doing this work the right way.

As we look ahead to 2026, our priorities are clear. We will continue investing in comprehensive training, concentrate on thoughtfully restructuring the office to better serve the public, and focus on expanding meaningful community outreach. Most importantly, we remain firmly committed to public safety and justice, holding individuals accountable under the law while ensuring fairness, integrity, and respect for all.

Notable Court Appearances & Indictments

An indictment was unsealed charging 38-year-old **Aneka Connor** with Manslaughter in the 2nd Degree, Reckless Endangerment in the 2nd Degree and Endangering the Welfare of a Child in relation to the death of her son, Ca'hry Glbson. Aneka Connor's next court date is January 5, 2026. This case is being prosecuted by Assistant District Attorney *Aaron Rath*, of the Special Investigations Bureau.

27-year-old **Demingo Hinton-Diggs** pled guilty to the indictment, which included Operator Leave Scene of Incident Resulting in Death. The defendant admitted to driving the vehicle that hit Moresee Chatman, and driving away on August 15, 2025. Moresee Chatman died from his injuries. This case was investigated by the Rochester Police Department and prosecuted by Assistant District Attorney *Karen Chung*, of the Vehicular Crimes Bureau. Demingo Hinton-Diggs will be sentenced by Monroe County Court Judge Douglas Randall on February 24, 2026.

Marcus Tookes was indicted on Assault in the 3rd Degree and Petit Larceny in relation to events occurring on December 4, 2025. He was previously indicted on Assault in the 2nd Degree for an Assault against a Rochester Police Officer on the same day. This case is being prosecuted by Assistant District Attorney Ellie Laloudakis, of the Major Felony Bureau.

Aaliyah Lewis was indicted on Assault in the 2nd Degree in relation to an assault with a dangerous instrument on December 11, 2025. This case is being prosecuted by Assistant District Attorney Stephen Ryck, of the Major Felony Bureau.

Eber Fuentes was indicted on two counts of Aggravated Driving While Intoxicated With a Child Passenger, Driving While Intoxicated; BAC .08 or more, and Driving While Intoxicated. This case is being prosecuted by Assistant District Attorney Drew Kroft, of the Vehicular Crimes Bureau.

James Barkley was indicted on Criminal Possession of a Weapon in the 2nd Degree. This case is being prosecuted by Assistant District Attorney Jennifer Kennedy, Deputy Chief of the Special Investigations Bureau.

First Jury Trial of 2026

January 5, 2026
The People vs. **Timothy Patterson**

The Defendant is charged with Murder in the 2nd Degree, and two counts of Criminal Possession of a Weapon in the 2nd Degree in front of Monroe County Court Judge Caroline Morrison.

This case is being prosecuted by Assistant District Attorney *Emily Chisholm*, of the Non-Fatal Shooting Taskforce, and Assistant District Attorney *Karen Chung*, of the Vehicular Crimes Bureau.
