### From Monroe County District Attorney Brian Green

This week, our office secured significant results that reflect our continued commitment to public safety and justice in Monroe County.



This week, a Monroe County jury found Jamie Busch guilty of Murder in the 2<sup>nd</sup> Degree and two counts of Tampering with Physical Evidence for the homicide of her sister, Penny Busch in Honeoye Falls. I want to commend Assistant District Attorney [Jessica Wagner](#) of the Special Victims Unit for her exceptional prosecution, as well as the Monroe County Sheriff's Office for their thorough and determined investigation. Jamie Busch will be sentenced on April 23, 2026, by Justice Stephen Miller.

A jury also convicted Tyshon McCullough of Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree and Criminal Possession of a Weapon in the 3<sup>rd</sup> Degree. The conviction stems from the execution of a Monroe County Sheriff's Office search warrant at 75 Sherman Street in connection with a fraudulent check scheme investigation. McCullough was found in possession of a loaded 9mm handgun and an extended magazine. The case was prosecuted by Assistant District Attorney [Ryan Mulcahy](#), of the Special Investigations Bureau.



Additionally, Daveon Cooper pled guilty to Assault in the 1<sup>st</sup> Degree and Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree in connection with a non-fatal shooting on North Goodman Street in the City of Rochester on June 8, 2025. This case was prosecuted by Assistant District Attorney [Anthony Freeman](#) of the Non-Fatal Shooting Task Force.

These outcomes reflect the tireless work of our prosecutors and law enforcement partners. We will continue working every day to ensure accountability, support victims, and strengthen the safety of our community.

## Notable Court Appearances

37-year-old **Richard Leo** was indicted on Murder in the 2<sup>nd</sup> Degree in relation to the homicide of Daniel Fiero on January 31, 2026. This case is being prosecuted by Assistant District Attorney [Patrick Gallagher](#), Chief of Domestic Violence Bureau and Assistant District Attorney [Kaitlin Hastings](#), of the General Felony Bureau.

26-year-old **Lavone Brown I** was indicted on two counts of Rape in the 1<sup>st</sup> Degree, Unlawful Imprisonment in the 1<sup>st</sup> Degree, and two counts of Assault in the 3<sup>rd</sup> Degree. This case is being prosecuted by Assistant District Attorney [Rachael Landauer](#), of the Special Victims Unit.

17-year-old **Izayah Jones** was indicted on Attempted Murder in the 2<sup>nd</sup> Degree and Assault in the 1<sup>st</sup> Degree. This case is being prosecuted by Assistant District Attorney [Philip Alvaro](#), of the Youth Part/Major Felony Bureau.

36-year-old **Michael Burgio** was indicted on Assault in the 2<sup>nd</sup> Degree. This case is being prosecuted by Assistant District Attorney [Merrick Sadler](#), Chief of the Vehicular Crimes Bureau.

57-year-old **Bobby Simmons, Jr.** was indicted on Burglary in the 2<sup>nd</sup> Degree. This case is being prosecuted by Assistant District Attorney [Camille Ingino](#), of the Major Felony Bureau.

## Ongoing & Upcoming Trials

### The People vs. **Jermaine Williams**

This defendant is charged with two counts of Murder in the 1<sup>st</sup> Degree and two counts of Murder in the 2<sup>nd</sup> Degree, in front of Monroe County Court Judge Michael Dollinger.

This case is being prosecuted by Assistant District Attorney [Adam VanHeyst](#), Deputy Chief of the Major Felony Bureau, and Assistant District Attorney [Emily Chisholm](#), of the Non-Fatal Shooting Taskforce.

### The People vs. **Edwin Narvaez**

The defendant is charged with Sexual Abuse in the 1<sup>st</sup> Degree and two counts of Rape in the 2<sup>nd</sup> Degree in front of Monroe County Court Judge Caroline Morrison.

This case is being prosecuted by Assistant District Attorney [Courtney Kleiman](#), of the Special Victims Unit.

### The People vs. **Stanley Glover, Jr.**

The defendant is charged with two counts of Criminal Possession of a Forged Instrument in the 2<sup>nd</sup> Degree, Falsifying Business Records in the 1<sup>st</sup> Degree, two counts of Offering a False Instrument for Filing in the 1<sup>st</sup> Degree, Identity Theft in the 1<sup>st</sup> Degree, and Attempted Grand Larceny in the 4<sup>th</sup> Degree in front of New York State Supreme Court Justice Thomas Moran.

This case is being prosecuted by Assistant District Attorney [Amy Crosier](#), of the Public Integrity/Economic Crimes Bureaus.
