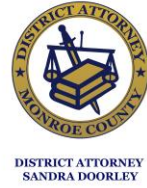

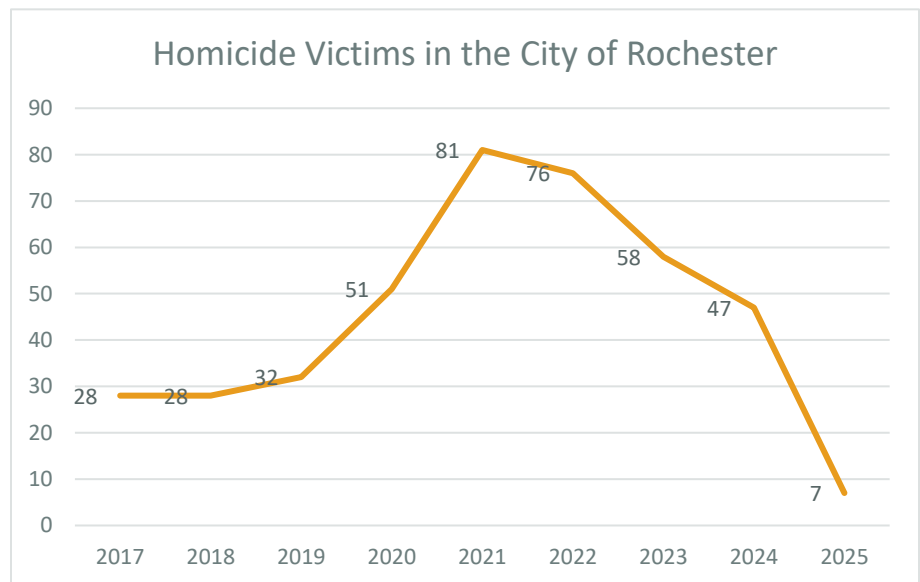


Welcome to the weekly newsletter from Monroe County District Attorney Sandra Doorley.

Homicides

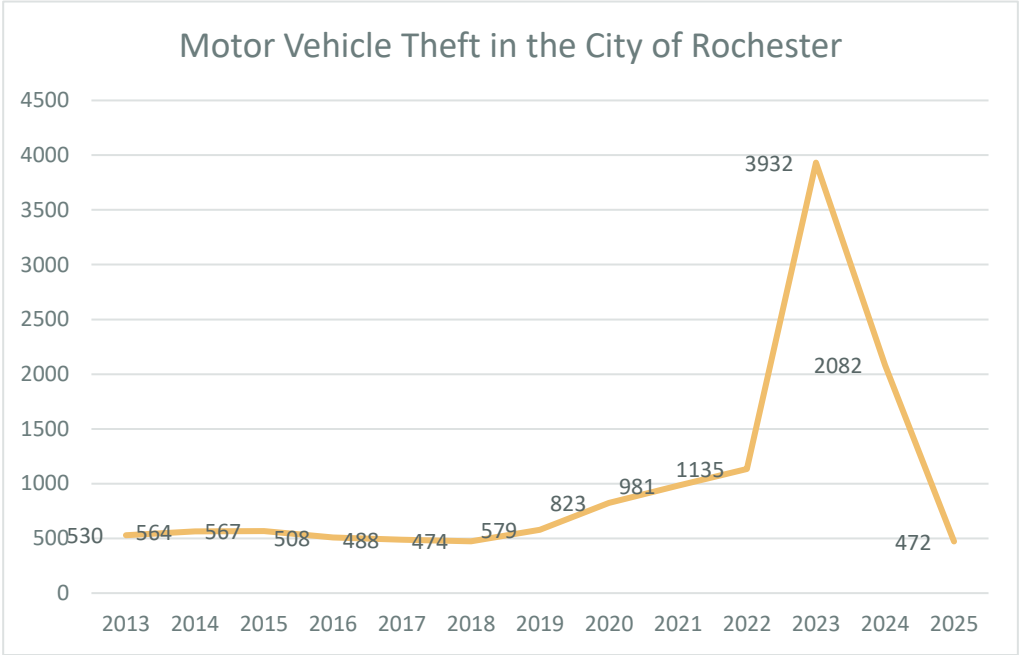

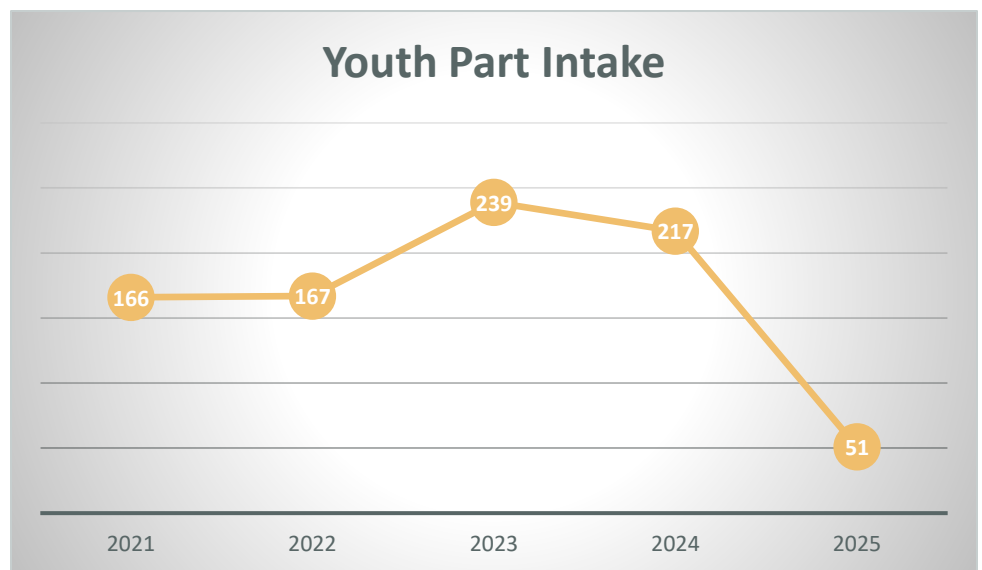

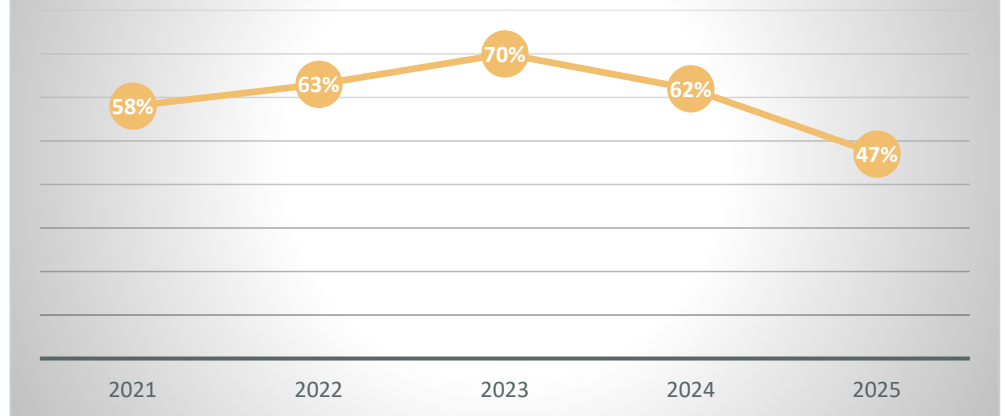
Listed above is the percentage of Criminal Possession of a Weapon in the 2nd Degree arrests where non-monetary bail is being set at arraignments. I also noted the percentage of cases where cash bail was set at \$5,000 or less. Criminal Possession of a Weapon in the 2nd Degree is a class C violent felony.

Youth Part Cases

There has been a lot of interest in youth part and juvenile prosecution. Listed below are the numbers we are seeing into Youth Criminal Part, and how many of those cases stay, or are transferred to Family Court, which is outside of our office.

Update on the Investigation into Irondequoit Town Supervisor Andrae Evans

Monroe County District Attorney Sandra Doorley filed a petition against Irondequoit Town Supervisor Andrae Evans for a judgment under Public Officers Law §36. This petition was filed with the State of New York Appellate Division Fourth Department for a judgment removing Andrae Evans as the Supervisor of the Town of Irondequoit.

Following a referral from the Irondequoit Town Board and the Irondequoit Police Department, the Monroe County District Attorney's Office reviewed the current findings and conducted an outside investigation to determine if any criminal charges or penalties are appropriate. Upon review, it was determined that the petition for a judgment under Public Officers Law §36 is the most appropriate action at this time. This statute provides that this petition may be filed by the District Attorney.

The Monroe County District Attorney's Office anticipates a scheduling order from the Fourth Department in the coming weeks.

Highlights from the MCDA's Office

On Monday, jury selection will begin for the **People vs. Bradford Clark, Jr.** This case is being prosecuted by Assistant District Attorney Ryan Lamon, of the Major Felony Bureau.

The defendant is charged with Murder in the 2nd Degree and two counts of Criminal Possession of the Weapon in the 2nd Degree in front of Acting Monroe County Court Judge Patterson.

On Monday, a bench trial will begin for the **People vs. Rodolfo Reyes.** This case is being prosecuted by Assistant District Attorney Nico Gonzalez, of the Special Investigations Bureau.

The defendant is charged with Criminal Possession of the Weapon in the 2nd Degree and Criminal Possession of a Weapon in the 3rd Degree in front of New York State Supreme Court Justice Schiano.

On Monday, jury selection will begin for the **People vs. Cordae Terry** This case is being prosecuted by Assistant District Attorney Jonathan Jirik, of the Major Felony Bureau.

The defendant is charged with Robbery in the 1st Degree in front of Monroe County Court Judge Ansaldi.

On Tuesday, jury selection will begin for the **People vs. Eliezar Ortiz.** This case is being prosecuted by Assistant District Attorney Emily Chisholm and Assistant District Attorney Aliyah Fowler, of the Non-Fatal Shooting Taskforce.

The defendant is charged with three counts of Attempted Murder in the 2nd Degree, two counts of Assault in the 1st Degree, and two counts of Criminal Possession of a Weapon in the 2nd Degree in front of Monroe County Court Judge Dollinger.

New York State Supreme Court Justice Miller sentenced 33-year-old **Johnkiomi Ruiz** to 30 years in the New York State Department of Corrections plus 5 years of post-release supervision. He was previously convicted by a jury of Assault in the 1st Degree and two counts of Criminal Possession of a Weapon in the 2nd Degree for shooting a man on June 20, 2023. On June 20, 2023, Rochester Police Officers responded to a report of a person shot on Lake Avenue near Ravine Avenue in the City of Rochester. Upon arrival, a 24-year-old man was found with a gunshot wound in the back. He was immediately transported to Strong Memorial Hospital, where he needed life-saving surgery. After a thorough investigation by the Non-Fatal Shooting Taskforce, it was determined that Johnkiomi Ruiz targeted the victim and shot him in the back as the victim attempted to run away. The case was prosecuted by Assistant District Attorney Adam VanHeyst, Deputy Chief of the Major Felony Bureau.

Jullian Beechler was indicted on Grand Larceny in the 4th Degree in relation to stealing property from a Domino's on January 12, 2024 and January 15, 2024. This case is being prosecuted by Assistant District Attorney Joseph Flores, of the General Felony Bureau.

Mitchell Griffin was indicted on two counts of Burglary in the 3rd Degree and two counts of Petit Larceny in relation to burglaries at two different Wegmans on January 20, 2024 and February 14, 2025. This case is being prosecuted by Assistant District Attorney Joseph Flores, of the General Felony Bureau.

Ladarius Collins was indicted on Aggravated Unlicensed Operation of a Motor Vehicle in the 1st Degree in relation to a vehicular incident on August 14, 2024. This case is being prosecuted by Assistant District Attorney Diane Orosz-Roy, of the Vehicular Crimes Bureau.

Tracy Lee Skye was indicted on two counts of Burglary in the 3rd Degree and two counts of Petit Larceny in relation to burglaries at a Wegmans and a Walmart on November 19, 2024 and March 9, 2025. This case is being prosecuted by Assistant District Attorney Joseph Flores, of the General Felony Bureau.

Jahquez Mitchell was indicted on four counts of Criminal Sale of a Controlled Substance in the 3rd Degree and four counts of Criminal Possession of a Controlled Substance in the 3rd Degree in relation to the sale and possession of illegal narcotics on November 14, 2024 and December 12, 2024. This case is being prosecuted by Assistant District Attorney Aaron Rath, of the Special Investigations Bureau.

Romualdo Sing-Lazaro was indicted on two counts of Criminal Possession of a Controlled Substance in the 3rd Degree in relation to the illegal possession of narcotics on February 14, 2025. This case is being prosecuted by Assistant District Attorney Nico Gonzales, of the Special Investigations Bureau.

Phillip Oliver was indicted on Criminal Contempt in the 1st Degree in relation to the violation of an order of protection on January 1, 2025. This case is being prosecuted by Assistant District Attorney Courtney Kleiman, of the Special Victims Unit.

Francisco Alberto Perez-Ozuna was indicted on Criminal Possession of Stolen Property in the 3rd Degree and Unauthorized Use of a Vehicle in the 3rd Degree in relation to possession of a stolen vehicle on September 3, 2024. This case is being prosecuted by Assistant District Attorney Terance Calcagno, of the General Felony Bureau.

Amadi Rivers and **Winston Wilson** were indicted on Criminal Possession of a Weapon in the 2nd Degree and Criminal Possession of a Weapon in the 3rd Degree in relation to the illegal possession of a firearm on March 29, 2025. This case is being prosecuted by Assistant District Attorney Jennifer Kennedy, Deputy Chief of the Special Investigations Bureau.

Sharquis Bennet was indicted on Criminal Possession of a Weapon in the 2nd Degree in relation to the possession of an illegal firearm on April 25, 2022. This case is being prosecuted by Assistant District Attorney Jonathan Jirik, of the Major Felony Bureau.

Brima Jalloh was indicted on Burglary in the 2nd Degree in relation to a home burglary on October 14, 2024. This case was indicted by Assistant District Attorney Ellie Laloudakis, of the Major Felony Bureau.

Michael Paniccia was indicted on Attempted Robbery in the 1st Degree, two counts of Attempted Robbery in the 2nd Degree, and Assault in the 2nd Degree in relation to the attempted armed robbery of an individual on March 28, 2025. This case is being prosecuted by Assistant District Attorney Ellie Laloudakis, of the Major Felony Bureau.
