## Highlights from the MCDA's Office

On Friday, April 26, 2024, 34-year-old **Jacob Seffens** was convicted by a Monroe County jury of Assault in the 1<sup>st</sup> Degree for the assault of his 18-year-old niece. On June 14, 2023, Rochester Police Officers arrived to a home on Chili Avenue in the City of Rochester. The victim was beaten and unresponsive. She was immediately taken to Strong Memorial Hospital where she was placed in a medically induced coma due to a traumatic brain injury with severe and life threatening swelling to her brain. Thankfully, due to the expert treatment by the medical professionals at Strong Hospital the victim was able to recover from these injuries and is physically doing better and on her way to a full recovery. After a detailed investigation by the Rochester Police Department, it was determined that Jacob Seffens, the uncle to the victim, was responsible for this brutal assault. Jacob Seffens was in a sexual relationship with his niece. When the victim attempted to end the relationship with the defendant, Jacob Seffens beat her with a baseball bat, almost killing her. After being indicted by a Monroe County Grand Jury for this assault, he was arrested by the Rochester Police Department. This case was prosecuted by Assistant District Attorney Patrick Gallagher, Chief of the Domestic Violence Bureau.

**Jermaine Shelton, Jr.** was convicted by a jury of two counts of Robbery in the 2<sup>nd</sup> Degree. On October 16, 2022, in the South Wedge of the City of Rochester, Jermaine Shelton, Jr., along with co-defendants, forcibly stole property from an individual while one of the co-defendants displayed a weapon. This case was investigated by the Rochester Police Department and prosecuted by Assistant District Attorney Michael Harrigan, Chief of the Major Felony Bureau. Jermaine Shelton, Jr. will be sentenced on May 28, 2024, in front of New York State Supreme Court Justice Sinclair.

**Dionedre Wyatt** was convicted by a jury of Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree. The defendant was found to be in possession of an illegal firearm on September 15, 2023. This case was investigated by the Rochester Police Department and was prosecuted by Assistant District Attorney Stephen Ryck, of the Special Investigations Bureau. Dionedre Wyatt will be sentenced on May 29, 2024, in front of Monroe County Court Judge Dollinger.

**Heather Derooy** was indicted on Criminal Possession of a Forged Instrument in the 2<sup>nd</sup> Degree and Identity Theft in the 1<sup>st</sup> Degree in relation to events occurring on May 12, 2023. This case is being prosecuted by Assistant District Attorney Ryan Lamon, of the Public Integrity/Economic Crimes Bureau.

**Trevon Collier and Jamotti Fulton** were indicted on Robbery in the 2<sup>nd</sup> Degree in relation to a robbery of an individual on March 26, 2024. This case is being prosecuted by Assistant District Attorney Ellie Laloudakis, of the Youth Part/Major Felony Bureau.

**Cyler Quinn** was indicted two counts of Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree in relation to a shooting and the illegal possession of a firearm on March 23, 2024. This case is being prosecuted by Assistant District Attorney Timothy Boucher, of the Special Investigations Bureau.

**Tarquan Monroe** was indicted on Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree in relation to the illegal possession of a firearm on March 26, 2024. This case is being prosecuted by Assistant District Attorney Anthony Freeman, of the Non-Fatal Shooting Taskforce.

**Aniya Carter** was indicted on two counts of Burglary in the 1<sup>st</sup> Degree, Robbery in the 1<sup>st</sup> Degree, two counts of Robbery in the 2<sup>nd</sup> Degree, and Assault in the 2<sup>nd</sup> Degree in relation to the armed robbery and assault of an individual on March 24, 2024. This case is being prosecuted by Assistant District Attorney Emily Chisholm, of the Major Felony Bureau.

**Serdar Ozmen** was indicted on Kidnapping in the 1<sup>st</sup> Degree as a Sexually Motivated Felony, two counts of Criminal Sexual Act in the 1<sup>st</sup> Degree, and two counts of Criminal Sexual Act in the 2<sup>nd</sup> Degree in relation to the kidnapping of a child from her Brighton home on March 25, 2024. This case is being prosecuted by Assistant District Attorney Sara Vanstrydonck, Chief of the Special Victims Unit and Assistant District Attorney Patrick Gallagher, Chief of the Domestic Violence Bureau.

**Tyrone Brown, Jr. and Tyshawn Brown** were indicted on Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree in relation to the illegal possession of a firearm on March 29, 2024. This case is being prosecuted by Assistant District Attorney Timothy Boucher, of the Special Investigations Bureau.

**Dsean Kelly, Jr.** was indicted on Robbery in the 1<sup>st</sup> Degree, Robbery in the 2<sup>nd</sup> Degree, two counts of Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree, Grand Larceny in the 3<sup>rd</sup> Degree, and Criminal Possession of Stolen Property in the 4<sup>th</sup> Degree in relation to an armed robbery on March 31, 2024. This case is being prosecuted by Assistant District Attorney Emily Chisholm, of the Major Felony Bureau.

**Jiyair Wimbush** was indicted on two counts of Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree and Assault in the 2<sup>nd</sup> Degree in relation to an assault with an illegal firearm on February 14, 2024. This case is being prosecuted by Assistant District Attorney Anthony Freeman, of the Non-Fatal Shooting Taskforce.

**Kevin Scarborough** was indicted on two counts of Driving While Intoxicated in relation to an attempted a vehicular incident on November 12, 2023. This case is being prosecuted by Assistant District Attorney Drew Kroft, of the Vehicular Crimes Bureau.

**Samahj Williams** was indicted on Attempted Robbery in the 1<sup>st</sup> Degree and Criminal Mischief in the 2<sup>nd</sup> Degree in relation to an attempted armed robbery on April 2, 2024. This case is being prosecuted by Assistant District Attorney Aliyah Fowler, of the Major Felony Bureau.

**Tejay Gibson** was indicted on two counts of Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree and Menacing in the 2<sup>nd</sup> Degree in relation to a domestic incident on December 13, 2023. This case is being prosecuted by Assistant District Attorney Aaron Rath, of the Special Victims Unit.

**Tasha Durand** was indicted on Burglary in the 3<sup>rd</sup> Degree in relation to a burglary at a Wegmans on February 12, 2024. This case is being prosecuted by Assistant District Attorney Caroline Rodriguez, of the General Felony Bureau.

**Kim Carpenter-Fayko** was indicted on Grand Larceny in the 4<sup>th</sup> Degree in relation to a theft from a JCPenney on December 23, 2023. This case is being prosecuted by Assistant District Attorney Caroline Rodriguez, of the General Felony Bureau.
