# Homicide Update

### Highlights from the MCDA's Office

47-year-old **Marcus Buckman** was convicted by a jury of Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree. On September 14, 2023, the Rochester Police Department arrested Marcus Buckman for the possession of an illegal semi-automatic handgun. This case was investigated by the Rochester Police Department and prosecuted by Assistant District Attorney Timothy Boucher, of the Special Investigations Bureau. Marcus Buckman is a quadruple predicate felony offender and faces 5-15 years in the New York State Department of Corrections. He will be sentenced on June 26, 2024, in front of New York State Supreme Court Justice Renzi.

28-year-old **Bryasia Love** pled guilty to Manslaughter in the 1<sup>st</sup> Degree and Assault in the 2<sup>nd</sup> Degree for the physical abuse that resulted in the death of her one-year-old son, A'Mias Love, and the assault of her two-year-old daughter. On January 19, 2023, Rochester Police Officers were called to Wilson Commencement Park Apartments in the City of Rochester for reports of an unresponsive child. Upon arrival, one-year-old A'Mias Love was rushed to Strong Memorial Hospital, where the child died from his injuries days later. After an investigation conducted by the Rochester Police Department, Monroe County Child Protective Services, and the Bivona Child Advocacy Center, it was determined that Bryasia Love was responsible for the physical abuse and waited to seek medical treatment for her son. She was also deemed responsible for the abuse against her two-year-old daughter. The case was prosecuted by Assistant District Attorney Sara VanStrydonck, Chief of the Special Victims Unit, and Special Assistant District Attorney Hillary Langdon, also of the Special Victims Unit. Bryasia Love will be sentenced on August 23, 2024, in front of Monroe County Court Judge Julie Hahn. She faces a determinant sentence between 22-28 years in the New York State Department of Corrections.

New York State Supreme Court Justice Judith Sinclair sentenced 37-year-old Randy Burney to 25 years to Life in the New York State Department of Corrections. Randy Burney was previously convicted by a jury of Murder in the 2<sup>nd</sup> Degree, two counts of Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree, and Assault in the 2<sup>nd</sup> Degree for the murder of Kimanhi Hinds and the shooting of a security guard. On May 29, 2023, at approximately 2:00AM, Rochester Police Officers were called to the Flour City Station bar on East Avenue in the City of Rochester. Upon arrival, 41-year-old Kimanhi Hinds was found shot to death. A security guard for the establishment was also hit by the same bullet. The guard was transferred to Rochester General Hospital, where he recovered from the gunshot. After a thorough investigation by the Rochester Police Department, it was determined that Randy Burney was the assailant. The defendant approached Kimanhi Hinds and shot the victim. Randy Burney was also responsible for the gunshot that struck the security guard before fleeing the scene. The case was prosecuted by Special Assistant District Attorney Jessica Wagner, of the Special Victims Unit.

New York State Supreme Court Justice Moran sentenced 31-year-old **Saquan Felton** to 15 years in the New York State Department of Corrections plus 5 years of post-release supervision for his role in the homicide of Jameik Daquan Foster on August 21, 2022. Saquan Felton previously pled guilty to Manslaughter in the 1<sup>st</sup> Degree. Jameik Foster was shot in the upper body and located on the ground by emergency responders on State Street in the City of Rochester. He was transported to Strong Memorial Hospital, where he was pronounced dead. This case was investigated by the Rochester Police Department and prosecuted by Assistant District Attorney Jennifer Kennedy, Deputy Chief of the Special Investigations Bureau and Assistant District Attorney Merrick Sadler, of the Non-Fatal Shooting Taskforce.

An indictment was unsealed in front of New York State Supreme Court Justice Argento charging **Timothy Tabron** with Manslaughter in the 2<sup>nd</sup> Degree and Operator Leave Scene of Incident Resulting in Death for the vehicular homicide of Alivia Curl on November 26, 2022. This case is being prosecuted by Assistant District Attorney Drew Kroft, of the Vehicular Crimes Bureau.

An indictment was unsealed in front of New York State Supreme Court Justice Sinclair charging **Robert Petit** with eleven counts of Sexual Abuse in the 1<sup>st</sup> Degree and six counts of Endangering the Welfare of a Child in relation to the sexual abuse of three children between February 27, 2023 and March 2, 2023. This case is being prosecuted by Assistant District Attorney Hillary Langdon, of the Special Victims Unit.

Joel Davila-Ramos was indicted on Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree, six counts of Criminal Possession of a Controlled Substance in the 3<sup>rd</sup> degree, and two counts of Criminal Possession of a Controlled Substance in the 5<sup>th</sup> Degree in relation to the possession of an illegal firearm and illegal narcotics on January 30, 2024 and March 21, 2024. This case is being prosecuted by Assistant District Attorney Michael Caranante, of the Special Investigations Bureau.

**David Lampman** was indicted on Attempted Murder in the 2<sup>nd</sup> Degree and Assault in the 2<sup>nd</sup> Degree in relation to a stabbing on April 19, 2024. This case is being prosecuted by Assistant District Attorney Sara VanStrydonck, Chief of the Special Victims Unit and Assistant District Attorney Kaylee Rizzari, also of the Special Investigations Bureau.

**Harry Harris** was indicted on Criminal Mischief in the 3<sup>rd</sup> Degree in relation to intentionally damaging property on April 3, 2024. This case is being prosecuted by Assistant District Attorney James Nguyen, of the Special Victims Unit.

**Asia Kwanai Wimbush** was indicted on Driving While Intoxicated in relation to a vehicular incident on February 2, 2024. This case is being prosecuted by Assistant District Attorney Diane Orosz-Roy, of the Vehicular Crimes Bureau.

**Ronald Scott** was indicted on Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree and Criminal Possession of a Weapon in the 3<sup>rd</sup> Degree in relation to the possession of an illegal firearm on May 1, 2024. This case is being prosecuted by Assistant District Attorney Bridget Morgan, of the Special Investigations Bureau.

**Richard Goliwitzer, Jr.** was indicted on Criminal Possession of a Weapon in the 3<sup>rd</sup> Degree in relation to the possession of an illegal firearm silencer on March 17, 2024. This case is being prosecuted by Assistant District Attorney Caroline Rodriguez, of the General Felony Bureau.

**Malaki Hollins** was indicted on Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree and Criminal Possession of a Weapon in the 3<sup>rd</sup> Degree in relation to the possession of an illegal firearm on May 9, 2024. This case is being prosecuted by Assistant District Attorney Tony DiPerna, of the Special Investigations Bureau.

**Luis Crespo** was indicted on two counts of Assault in the 2<sup>nd</sup> Degree, three counts of Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree, and two counts of Criminal possession of a Weapon in the 3<sup>rd</sup> Degree in relation to a shooting on April 26, 2024 and the illegal possession of a firearm on May 2, 2024. This case is being prosecuted by Assistant District Attorney Adam VanHeyst, of the Non-Fatal Shooting Taskforce.

**Alicia Sackett** was indicted on three counts of Grand Larceny in the 4<sup>th</sup> Degree, Burglary in the 3<sup>rd</sup> Degree, two counts of Petit Larceny, two counts of Forgery in the 2<sup>nd</sup> Degree, and Criminal Impersonation in the 2<sup>nd</sup> Degree in relation to thefts and other criminal activity in the Towns of Sweden, Irondequoit, Greece, and Webster between November 2022 and January 2024. This case is being prosecuted by Assistant District Attorney Armando Benitez, of the General Felony Bureau.

**Christopher DeJonge** and **Darius Smith** were indicted on Grand Larceny in the 2<sup>nd</sup> Degree, Burglary in the 3<sup>rd</sup> Degree, and Criminal Possession of Stolen Property in the 3<sup>rd</sup> Degree in relation to a theft from a business during June 2023 and July 2023. This case is being prosecuted by Assistant District Attorney Ryan Lamon, of the Public Integrity/Economic Crimes Bureau.

**Matthew Chisolm** was indicted on Robbery in the 1<sup>st</sup> Degree in relation to an armed robbery on February 5, 2024. This case is being prosecuted by Assistant District Attorney Matthew Hogestyn, of the Major Felony Bureau.

**George Stanton, II** was indicted on two counts of Burglary in the 3<sup>rd</sup> Degree in relation to burglaries at two separate Home Depots. This case is being prosecuted by Assistant District Attorney Armando Benitez, of the General Felony Bureau.
