#### National Police Week

Sunday marks National Police Week across the country. A recognition that started in 1962 as a way to pay respect to our dedicated Law Enforcement Officers who have lost their lives in the line of duty. In Monroe County, we are too familiar with the risk that law enforcement officers face every single day. Recognizing them has become more important than ever as they too often face violent attacks while keeping us safe.

I will never stop talking about two of my heroes:

Rochester Police Officer Daryl Pierson, EOW: Wednesday, September 3, 2014 Rochester Police Officer Anthony Mazurkiewicz, EOW: Thursday, July 21, 2022

On September 3, 2014, Officer Pierson was doing his job. He was pursuing parolee Thomas Johnson III, who turned around and shot and killed Officer Pierson. We remember Officer Pierson for his service to the Rochester Police Department, but we also remember Daryl for who he was, a father, a husband, a man of faith.



Daryl left behind a wife, children, parents, and many friends and family members who loved and respected him.



On July 21, 2022, Officer Mazurkiewicz and his partner, Rochester Police Officer Sino Seng, were doing their job and were shot at by Kelvin Vickers. Both were shot, and Officer Mazurkiewicz was killed. Maz was known to be an incredible police officer, an exceptional mentor, and a role model to every officer who knew him.

Most importantly, Officer Mazurkiewicz was a devoted husband, father, and grandfather. His family adored him, and he is dearly missed.

These men are my heroes, which is why I fought so hard to find them justice in the courtroom. I pray that this community never witnesses another murder of a police officer.

### Highlights from the MCDA's Office

**The People vs. Robert Petit** will continue into next week. This case is being prosecuted by Assistant District Attorney Jessica Wagner, of the Special Victims Unit. The defendant is charged with eleven counts of Sexual Abuse in the 1<sup>st</sup> Degree and six counts of Endangering the Welfare of a Child in front of New York State Supreme Court Justice Sinclair.

Monroe County Court Judge Dollinger Sentenced 46-year-old Herbert Montgomery to 25 years in the New York State Department of Corrections. He was previously convicted by a jury of Murder in the 2<sup>nd</sup> Degree for killing Christopher Austin. On July 26, 2024, at approximately 9:30 p.m., Rochester Police Officers responded to a gas station store on North Street in the City of Rochester following reports of a disturbance inside the store. Upon their arrival, officers located 38-year-old Christopher Austin deceased from a stab wound in his neck. Following a detailed investigation by the Rochester Police Department, it was determined that Christopher Austin was inside the store when Herbert Montgomery initiated a verbal and physical altercation. This confrontation immediately escalated with the defendant stabbing Christopher Austin, in the neck, ultimately leading to his death. After the incident, Montgomery fled the scene in his vehicle. Rochester Police Officers located Herbert Montgomery within twelve hours and arrested him for the murder. At the time of the murder, the defendant was a twice-convicted felony offender and was also on federal probation. The case was prosecuted by Assistant District Attorney Patrick Gallagher, Chief of the Domestic Violence Bureau.

41-year-old **Serdar Ozmen** was sentenced by New York State Supreme Court Justice Renzi to 25 years to Life in the New York State Department of Corrections. He previously pled guilty to the indictment, which included Kidnapping in the 1st Degree as a Sexually Motivated Felony, two counts of Criminal Sexual Act in the 1st Degree, and two counts of Criminal Sexual Act in the 2<sup>nd</sup> Degree, for the kidnapping and sexual assault of a 14-year-old child. On March 25, 2024, an amber alert was issued for a 14-year-old girl who was missing from her home. Together, the Brighton Police Department, the New York State Police, and the New York City Police Department worked in tandem to locate the child less than 24 hours from her kidnapping. After a swift, high-priority investigation, it was determined that the 14-year-old victim met 41-year-old Serdar Ozmen online through social media. The defendant convinced the victim to leave her house in the middle of the night, when he restrained her in his vehicle and abducted her. Serdar Ozmen drove her from Monroe County to New York City. New York Police Officers located the 14-year-old victim in an apartment in the Bronx. During the abduction, she was sexually assaulted. She was quickly reunited with her family due to the quick work of the Brighton Police Department, the New York State Police, and the New York City Police Department. This case was prosecuted by Assistant District Attorney Sara VanStrydonck, Chief of the Special Victims Unit, and Assistant District Attorney Patrick Gallagher, Chief of the Domestic Violence Bureau.

New York State Supreme Court Justice Argento sentenced 32-year-old Shaquille Turner to 25 years in the New York State Department of Corrections plus 5 years of post-release supervision. He was previously convicted by a Monroe County jury of Assault in the 1st Degree, two counts of Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree, and two counts of Criminal Possession of a Controlled Substance in the 3<sup>rd</sup> Degree for shooting a woman on Lake Avenue on July 26, 2023. On July 26, 2023, Rochester Police Officers with the Non-Fatal Shooting Taskforce responded to Lake Avenue near Lake View Park for a report of gunshots from a motor vehicle. Rochester Police Officers also responded to Rochester General Hospital for a report of a woman shot. Investigators quickly determined that the 48-year-old victim was injured in the Lake Avenue shooting. She was shot in her face and her arm before being transported to the hospital, where she recovered from her serious injuries. After a thorough investigation conducted by the Non-Fatal Shooting Taskforce, which consists of Rochester Police Officers, Assistant District Attorneys and Investigators from the Monroe County District Attorney's Office, it was determined that Shaquille Turner was responsible for the shooting. This was a targeted assault, as the defendant and victim were known to each other. On August 10, 2023, United States Marshals arrested Shaquille Turner, who was in possession of illegal narcotics at the time of the arrest. The case was prosecuted by former Assistant District Attorney Rachel Clark, of the Non-Fatal Shooting Taskforce.

New York State Supreme Court Justice Moran sentenced 39-year-old Anthony Hall to 2 years in the New York State Department of Corrections plus two years of post-release supervision. This sentence comes after Hall pled guilty to an indictment charging him with Assault in the 2<sup>nd</sup> Degree for the assault of a Rochester Police Department Officer. On January 2, 2025, Rochester Police Officers were called to a home on East Main Street for a reported domestic incident. Anthony Hall refused to comply when officers ordered him to leave, requiring them to detain him. While attempting to take Hall into custody, an altercation ensued which resulted in a Rochester Police Officer suffering a broken thumb. Anthony Hall was also concurrently sentenced to 1 ½ to 3 years in the New York State Department of Corrections after he pled guilty to one count of Grand Larceny in the 4th Degree, in which he admitted to stealing an excess of \$1,000 which belonged to the Coalition of North East Associations, Inc. These cases were prosecuted by Assistant District Attorney Adam VanHeyst, Deputy Chief of the Major Felony Bureau and Caroline Rodriguez, of the Public Integrity/Economic Crimes Bureau.

17-year-old **Isa Reed** pled guilty to an indictment charging him with Attempted Murder in the 2<sup>nd</sup> Degree, Assault in the 1<sup>st</sup> Degree, and two counts of Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree. These charges stemmed from a non-fatal shooting incident that occurred on January 21, 2024 in the area of Magnolia Street and Manila Street in the City of Rochester. At approximately 6:15 p.m. that night, Rochester Police Officers responded to a call on Manila Street regarding a male who had reportedly been shot. Upon arrival, officers located a 36-year-old City of Rochester resident, who was suffering from a gunshot wound to his lower leg. The victim was shot at twelve times from behind, using two separate 9mm semiautomatic pistols. One of those twelve shots pierced his femoral artery. The victim was quickly transported to Strong Memorial Hospital, where he remained hospitalized for over 10 days. During his treatment, he underwent extensive medical procedures, including revascularization surgery, which involved transplanting a functioning vein from his right leg to repair damage in his left leg. Isa Reed will be sentenced on June 27, 2025, in front of New York State Supreme Court Justice Richard Healy. The case was prosecuted by Special Assistant District Attorney Anthony Freeman, of the Non-Fatal Shooting Task Force.

27-year-old **Terry Cordae** was convicted by a jury of Robbery in the 1<sup>st</sup> Degree. On August 21, 2024, the victim was contacted by Terry Cordae under a false identity on Facebook Marketplace, regarding the sale of the victim's vehicle. A meeting was arranged to inspect the car and take it to a mechanic. Upon the victim's arrival, Cordae brandished a firearm, threatening the victim's life. Ten days later, the stolen vehicle was discovered just 30 feet from the defendant's location. A subsequent search connected the defendant to the robbery. This case was investigated by the Rochester Police Department and prosecuted by Assistant District Attorney Jonathan Jirik, of the Major Felony Bureau. Terry Cordae will be sentenced on May 29, 2025, in front of Monroe County Court Judge Ansaldi.

27-year-old Eliezar Ortiz was convicted by a jury of three counts of Attempted Murder in the 2<sup>nd</sup> Degree, two counts of Assault in the 1<sup>st</sup> Degree and two counts of Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree for the shooting of Ricardo and Elaine Lewis on May 1, 2024. Following an investigation by the Greece and Rochester Police Departments, it was found that the victim's son had a verbal dispute during gym class over a basketball game, which escalated into a physical altercation after school at a bus stop. Later that day, in retaliation, the other student returned to the victim's home with two others, including Eliezar Ortiz, and fired multiple shots into the second floor. Ricardo and Elaine Lewis were hit when shots struck near the upstairs bathroom. Both were rushed to Strong Memorial Hospital and underwent extensive surgeries. While both survived the brutal attack, tragically, their unborn child did not survive the injuries sustained by Elaine in the shooting. The case was prosecuted by Special Assistant District Attorney Emily Chisholm and Special Assistant District Attorney Aliyah Fowler both of the Non-Fatal Shooting Taskforce. Eliezar Ortiz will be sentenced on June 4, 2025, in front of Monroe County Court Judge Dollinger.

**Adrian Lewis** was indicted on two counts of Driving While Intoxicated, Aggravated Unlicensed Operation of a Motor Vehicle in the 1<sup>st</sup> Degree, and Resisting Arrest in relation to a vehicular incident on March 3, 2025. This case is being prosecuted by Assistant District Attorney Diane Orosz-Roy, of the Vehicular Crimes Bureau.

**Clayton Proctor** was indicted on two counts of Criminal Contempt in the 1<sup>st</sup> Degree and Criminal Obstruction of Breathing in relation to a domestic incident on December 18, 2024. This case is being prosecuted by Assistant District Attorney Kenisha Flowers, of the Special Victims Unit.

**Emmanuel Morales-Ramirez** was indicted on Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree, Criminal Possession of a Weapon in the 3<sup>rd</sup> Degree, Driving While Intoxicated, and Driving While Intoxicated; BAC .08 or more in relation to the illegal possession of a weapon on April 13, 2024 and a vehicular incident on January 31, 2024. This case is being prosecuted by Assistant District Attorney Diane Orosz-Roy, of the Vehicular Crimes Bureau.

**Mickaela Timmons** was indicted on Aggravated Driving While Intoxicated With a Child Passenger, Driving While Intoxicated, Reckless Driving, and Endangering the Welfare of a Child in relation to a vehicular incident on February 9, 2025. This case is being prosecuted by Assistant District Attorney Diane Orosz-Roy, of the Vehicular Crimes Bureau.

**Joseph Marlin** was indicted on Criminal Possession of a Controlled Substance in the 3<sup>rd</sup> Degree in relation to the illegal possession of narcotics on March 11, 2025. This case is being prosecuted by Assistant District Attorney Jennifer Kennedy, Deputy Chief of the Special Investigations Bureau.

**Mikal McFadden** was indicted on two counts of Criminal Possession of a Controlled Substance in the 3<sup>rd</sup> Degree, Criminal Possession of a Controlled Substance in the 4<sup>th</sup> Degree, and Criminally Using Drug Paraphernalia in the 2<sup>nd</sup> Degree in relation to the illegal possession of narcotics on January 29, 2025. This case is being prosecuted by Assistant District Attorney Jennifer Kennedy, Deputy Chief of the Special Investigations Bureau.

**Todd Romig** was indicted on Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree in relation to the illegal possession of a weapon on April 10, 2025. This case is being prosecuted by Assistant District Attorney Jennifer Kennedy, Deputy Chief of the Special Investigations Bureau.

**Gary Maddox** was indicted on two counts of Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree in relation to a shooting on March 31, 2025. This case is being prosecuted by Assistant District Attorney Jonathan Jirik, of the Major Felony Bureau.

**Miguel Raspaldo** was indicted on Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree and Driving While Intoxicated in relation to the illegal possession of a weapon on January 11, 2025. This case is being prosecuted by Assistant District Attorney Bridget Morgan, of the Special Investigations Bureau.

Randloff Scott was indicted on five counts of Attempted Aggravated Murder, Attempted Murder in the 2<sup>nd</sup> Degree, and Criminal Possession of a Weapon in the 3<sup>rd</sup> Degree in relation to an incident involving the defendant firing at members of the Rochester Police Department on or about and between April 15, 2025 and April 16, 2025. This case is being prosecuted by First Assistant District Attorney Perry Duckles and Assistant District Attorney Adam VanHeyst, Deputy Chief of the Major Felony Bureau.

**Ricardo Torres** was indicted on Criminal Contempt in the 1<sup>st</sup> Degree and Stalking in the 4<sup>th</sup> Degree in relation to a domestic incident on September 20, 2024. This case is being prosecuted by Assistant District Attorney Armando Benitez, of the Special Victims Unit.

Marriana Rivera was indicted on Aggravated Driving While Intoxicated: Per Se, Driving While Intoxicated; BAC .08 or more, and Driving While Intoxicated in relation to a vehicular incident on August 24, 2024. This case is being prosecuted by Assistant District Attorney Diane Orosz-Roy, of the Vehicular Crimes Bureau.

**Lavon Hartzog** was indicted on Burglary in the 1<sup>st</sup> Degree, two counts of Burglary in the 2<sup>nd</sup> Degree, Aggravated Criminal Contempt, Criminal Contempt in the 1<sup>st</sup> Degree, Criminal Contempt in the 2<sup>nd</sup> Degree, Assault in the 3<sup>rd</sup> Degree, Petit Larceny, and three counts of Criminal Mischief in the 4<sup>th</sup> Degree in relation to the repeated burglary of a home and multiple domestic incidents on and about and between March 5, 2025 and March 27, 2025. This case is being prosecuted by Assistant District Attorney Jessica Wagner, of the Special Victims Unit.

**David Truesdale, Jr.** was indicted on Robbery in the 3<sup>rd</sup> Degree in relation to a robbery at a 7-Eleven on February 22, 2025. This case is being prosecuted by Assistant District Attorney William Jenkins, of the General Felony Bureau.

**Rondell Johnson** was indicted on Strangulation in the 2<sup>nd</sup> Degree, Attempted Sexual Abuse in 1<sup>st</sup> Degree, two counts of Menacing in the 2<sup>nd</sup> Degree, Assault in the 3<sup>rd</sup> Degree, and two counts of Endangering the Welfare of a Child, in relation to a domestic assault on March 27, 2025. This case is being prosecuted by Assistant District Attorney Armando Benitez, of the Special Victims Unit.

**Lakwan Hannah** was indicted on two counts of Murder in the 1<sup>st</sup> Degree, two counts of Attempted Murder in the 2<sup>nd</sup> Degree, Assault in the 1<sup>st</sup> Degree, and two counts of Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree in relation to the homicides of Jared Perry and Marquis Chambers and the attempted homicide of two other individuals on May 4 2024. This case is being prosecuted by Assistant District Attorney Patrick Gallagher, Chief of the Domestic Violence Bureau and Assistant District Attorney Mikael Pelkey, of the Special Victims Unit.

**Anthony Jenkins** was indicted on Robbery in the 1<sup>st</sup> Degree, two counts of Robbery in 2<sup>nd</sup> Degree, Kidnapping in the 2<sup>nd</sup> Degree, and Assault in the 2<sup>nd</sup> Degree in relation to an armed robbery and an assault on January 31, 2025. This case is being prosecuted by Assistant District Attorney Christopher Folk, of the Major Felony Bureau.

**Ja'Quez Harris** and **Jayden Foster** were indicted on Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree and Criminal Possession of a Weapon in the 3<sup>rd</sup> Degree in relation to the illegal possession of a weapon on February 21, 2025. This case is being prosecuted by Assistant District Attorney Michael Caranante, of the Special Investigations Bureau.

**John Savage** and **Michael O'Shea** were indicted on Robbery in the 1<sup>st</sup> Degree, Robbery in the 2<sup>nd</sup> Degree, Grand Larceny in the 2<sup>nd</sup> Degree, two counts of Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree and Criminal Possession of a Weapon in the 3<sup>rd</sup> Degree in relation to an armed robbery at M&T Bank on April 7, 2025. This case is being prosecuted by Assistant District Attorney Ryan Lamon, of the Major Felony Bureau.

**Paris Booker** was indicted on two counts of Burglary in the 2<sup>nd</sup> Degree, two counts of Criminal Possession of Stolen Property in the 5<sup>th</sup> Degree, Burglary in the 3<sup>rd</sup> Degree, two counts of Criminal Possession of a Weapon in the 3<sup>rd</sup> Degree, and Criminal Possession of Stolen Property in the 4<sup>th</sup> Degree in relation to the burglary of multiple homes and illegal possession of a weapon from March 16, 2025 through April 9, 2025. This case is being prosecuted by Assistant District Attorney Ellie Laloudakis, of the Major Felony Bureau.

**Jerome Pulley** was indicted on two of counts of Criminal Possession of a Weapon in the 2<sup>nd</sup> Degree and Menacing in the 2<sup>nd</sup> Degree in relation to the illegal possession of a weapon on April 11, 2025.
