Monroe County Grand Jury Indicts Five

Rochester, NY- A Monroe County Grand Jury has indicted two individuals on separate charges this week.

Nicholas Oneal Bevans, 32, was indicted on one count of Manslaughter in the First Degree for his involvement in the shooting death of Jeremy Dukes, 28, on or about December 21, 2014 at 405 Driving Park Avenue. Bevans was arrested the same day of the crime with the cooperation of the Rochester Police Department and the New York State Police. Bevans will be arraigned in Supreme or County Court the coming days. Bevans will be prosecuted by Second Assistant District Attorney Timothy Prosperi.

Charles Tan, 19, was indicted on one count of Murder in the Second Degree for the shooting death of his father, Laing Tan, in their home on Coachside Lane in the Town of Pittsford on or about and between February 5th and February 9th, 2015. Tan will be prosecuted by Assistant District Attorney William Gargan, Chief of the Domestic Violence Bureau. Tan is currently being held in the Monroe County Jail. His arraignment in Superior Court will occur next week, but has not yet been scheduled.

Keo Cody-Vincent Dotson, 23, was indicted on two (2) counts of Attempted Aggravated Murder of a Police Officer, three (3) counts of Attempted Aggravated Assault of a Police Officer, one (1) count of Assault on a Peace Officer, Police Officer, Fireman or EMT, one (1) count of Assault in the Second Degree, and one (1) count of Criminal Possession of a Weapon in the Third Degree for attacking three Rochester City Police Officers with a machete during an altercation on Illinois Street on December 23, 2014. Officer pursued Dotson into a home on that street, when he emerged with the machete and wounded two officers before being subdued and taken into custody. ADA David Dys of the Monroe County District Attorney's Office Major Felony Bureau will prosecute the case.

William Donnell Taylor, 54, was indicted on one count of Murder in the Second Degree for his involvement in the beating death of John Burnell, 34, on or about January 31, 2015. The case will be prosecuted by ADA Christine Callanan of the Monroe County District Attorney's Office Major Felony Bureau

Nikey Hall, 25, was indicted on one count of Assault in the First Degree and two counts of Assault in the Second Degree for an incident occurring on January 15, 2015 that resulted in serious injuries to his daughter, Ny-Kira Hall. Nikey Hall is currently out of custody after posting \$25,000 bond. He will be prosecuted by Assistant District Attorney Meredith Vacca. His arraignment in Superior Court has not yet been scheduled.
