## Tyshon Myles, Genesis Colon and Alvin Hancock all Sentenced to Life Sentences for the Death of Moran Wilson

Rochester, NY- On Monday, December 3, 2018, State Supreme Court Justice Judith Sinclair Sentenced Tyshon Myles to 52 years to life, Genesis Colon to 41 and 1/3 years to life and Alvin Hancock to two consecutive life sentences of 25 years to life, bringing it to 50 years to life, all sentences to be served in the New York State Department of Corrections.

On June 26, 2018, a Monroe County Jury convicted 23-year-old Genesis Colon and 30-year-old Alvin Hancock of 2 counts of Murder in the 2<sup>nd</sup> Degree for the death of Moran Wilson. They were also convicted of Kidnapping in the 1<sup>st</sup> Degree, Burglary in the 1<sup>st</sup> Degree, Robbery in the 1<sup>st</sup> Degree and Robbery in the 2<sup>nd</sup> Degree. Colon was convicted of Tampering with Physical Evidence and Criminal Possession of Marihuana in the 2<sup>nd</sup> Degree.

On Thursday, November 1, 2018, a separate Jury Trial resulted in the conviction of 26-year-old Tyshon Myles of one count of Murder in the 2<sup>nd</sup> Degree for the death of Moran Wilson. He was also convicted of Kidnapping in the 1<sup>st</sup> Degree, Burglary in the 1<sup>st</sup> Degree, Robbery in the 1<sup>st</sup> Degree, Robbery in the 2<sup>nd</sup> Degree and Tampering with Physical Evidence.

On May 12, 2017, Colon, Hancock and Myles caused the death of Moran Wilson during the course of a kidnapping. After a missing person's report, the Rochester Police Department discovered Wilson's remains buried in the backyard of 52 Dayton Street in the City of Rochester. Medical evidence presented at the trial showed that Wilson was brutally beaten and suffocated ultimately leading to his death.

The case was prosecuted by Assistant District Attorney David Dys, Chief of the Non-Violent Felony Bureau and Senior Assistant District Attorney Rachel Clark of the Major Felony Bureau.

"Today is the end of a very long line in a tragic and violent case," said Assistant District Attorney David Dys. "After years in the criminal justice system, the Monroe County District Attorney's Office hopes that justice and closure have been brought to Moran Wilson's suffering family. Thank you to the Court for imposing life sentences for all defendants, reflecting the cruelty and violence of this unthinkable crime."

"Nobody deserves the treatment that thee three violent offenders imposed on Moran Wilson in May 2017," said District Attorney Sandra Doorley. "These sentences are appropriate and important in deterring these types of brutal crimes in our community. I want to thank the Rochester Police Department, who worked vigorously with the Monroe County District Attorney's Office for nearly two years to bring these individuals to justice."
